FUND OBJECTIVE AND PHILOSOPHY

The investment objective of the Baymont Global Equity Fund is to achieve long-term capital growth by investing across global equity markets. The investment philosophy is to invest in dominant, high-quality businesses which have a history of developing both growth and real economic value. The fund has adhered to its policy objective.

FUND MANAGER COMMENTARY

Investors enjoyed a strong recovery in both equity and bond markets in the last quarter of 2023. Pleasing inflation figures pointed to the possible end of rising interest rates, boosting returns as the market started to look through higher interest rates and inflation. The "most anticipated recession in history" did not materialise. For now, at least. The ascendance of Artificial Intelligence during the year providing the stimulus for the market. The magnificent seven, Alphabet, Amazon, Apple, Meta, Microsoft, Nvidia and Tesla, continues to account for most of the market returns in 2023.

Inflation is expected to decline globally into 2024, but it will be varied and uneven. We anticipate that global police rates in general will remain higher for longer and probably settle above pre-pandemic levels. Higher interest rates will impact on global growth, slowing during the year. Geopolitics is elevated and remains a concern. Cash and bond yields are more attractive and will be competing for a place in portfolios that were previously equity heavy. Equity valuations are creeping up.

In line with market performance, Amazon, Apple and Microsoft contributed meaningfully to the performance of the fund. The key detractors to the performance of the fund included Alibaba and Yum China Holdings as the recovery of the Chinese economy remains subdued and Exxon due a significantly lower oil price. There were no major changes to the holdings in the fund for the past quarter.

The fund returns for 2024 are pleasing. A year ago, we strategically expanded our research and investment reach, to include 60 - 80 investments. This focus on diversification has paid dividends, with impressive outcomes in both volatility and performance. Since these changes have been implemented, we now consistently rank above the benchmark and the peer group. We are confident that this level of performance against the 'all country world index' benchmark can be sustained over the long term.

We will stay focused on attractively priced companies with a robust competitive advantage, strong balance sheets and low sensitivity to economic cyclicality. We remain patient investors and assess the opportunities as they present themselves.



Growth of \$100 000 investment net of all fees and expenses




RISK PROFILE





GLOSSARY

Net Asset Value (NAV): means net asset value, which is the total market value of all assets in a portfolio including any income accruals and less and deductible expenses such as audit fees, brokerage and service fees.

Annualised Performance show longer term performance rescaled to a one-year period. Annualised performance is the average return per one year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest Return: The highest and lowest rolling twelve-month performance of the portfolio since inception.

Total Expense Ratio (TER): reflects the percentage of the average Net Asset Value (NAV) of the portfolio that was incurred as charges, levies and fees related to the management of the portfolio. A higher TER does not necessarily imply a poor return, nor does a low TER imply a good return. The current TER cannot be regarded as an indication of future TER's.


Transaction Costs (TC): is the percentage of the value of the Fund incurred as costs relating to the buying and selling of the Fund's underlying assets. Transaction costs are a necessary cost in administering the Fund and impacts Fund returns.

Total Investment Charge (TIC) should not be considered in isolation as returns may be impacted by many other factors over time including market returns, the type of Fund, investment decisions of the investment manager.

Total Investment Charges (TIC%) = TER (%) + TC (%): The Total Investment Charges (TIC), the TER + the TC, is the percentage of the net

asset value of the class of the Financial Product incurred as costs relating to the investment of the Financial Product. It should be noted that a TIC is the sum of two calculated ratios (TER+TC).

FUND RISK

Derivative Risk: Derivative positions are financial instruments that derive their value from an underlying asset. Derivatives are exposed to implicit leverage which could result in magnified gains and/or losses on the portfolio.

Volatility Risk: Volatility refers to uncertainty and risk related to size of change of an instrument or portfolio. It is a statistical measure of the dispersion of returns for a given security or market index. Volatility is proportional to the directional exposure of a portfolio and is measured by Value at Risk (VaR) which is a statistical technique used to measure and quantify the level of volatility.

Concentration and Sector Risk: A large proportion of total assets invested in specific assets, sectors or regions. Concentrated positions or concentrated sectors in a portfolio will materially impact the returns of the portfolio more so than diversified portfolios.

Equity Risk: Applies to investment in shares or derivatives based on shares. The market price of shares varies depending on supply and demand of the shares. Equity risk is the risk of loss due to the drop in the market price of shares. Equity risk can either be systematic risk which is risk to the entire market based on political and economic indicators or unsystematic risk which is company specific and includes risk relating to company profits, future prospects and general consensus on the company or sector.
