#### MINIMUM DISCLOSURE DOCUMENT

#### INVESTMENT AND RETURN OBJECTIVE

The Fund aims to return STeFi Call + 3% per annum through a full interest rate cycle by offering investors an enhanced income yield without undue risk on capital by maintaining constrained credit risk exposure.

#### **INVESTMENT PROCESS**

The Fund invests in a diversified portfolio consisting primarily of South African vanilla debt, mezzanine and structured instruments across the term structure and credit rating bands. Portfolio risk is managed at both single issuer and portfolio level. The former is done through an inhouse dynamic probability of default (PD) based rating model and the latter is through measuring the Expected Loss (EL), Loss Given Default (LGD) and credit VaR (Value at Risk). The Fund's modified duration will typically be below two years. Credit asset selection is underpinned by minimising default risk and credit spread duration.

#### WHO SHOULD INVEST


Investors seeking performance in excess of what is available in the money market or a typical income fund. The Fund is not Regulation 28 compliant.


#### **RISK INDICATOR DEFINITION**

This portfolio typically has longer dated and complex credit exposures, resulting in some capital volatility and liquidity constraints to investors over the shorter term. 

#### **FUND COMMENTARY**

February was a softer month for local fixed income markets as the ALBI lost 58bp. Yields ended the month higher, predominantly driven by global macro developments where we continue to observe robust growth of the US economy. US market participants have thus reduced their expectations for rate reductions from five cuts previously to three cuts currently. In South Africa, market expectations have adjusted accordingly with the first rate cut priced for Q3 2024.

The Debt Capital Market saw increased activity in February with R10.1bn of term issuance, relative to the R2bn seen in January 2024. The banking sector accounted for the majority of issuance with Absa Bank Ltd and Nedbank Ltd raising R3.3bn and R2.6bn in senior issuance respectively. Other notable issuance includes Growthpoint Properties raising R1bn, Equites Property Fund raising R750m, and Netcare Ltd issuing R600m. Total term issuance for the year is thus reported at R12.1bn.

Regarding our view on credit markets, our theme is determined by a combination of the output of our Credit Cycle Indicator (CCI), our consideration of individual counterparty default probabilities and finally the yields offered on these opportunities. Our CCI suggests continued heightened risk levels inherent in the South African Credit market, and the Fund positioning talks to holding assets with what we believe to have defensive characteristics, while opportunistically taking on additional risk as and when this is deemed appropriate.

The Fund reported a net return of 47bp for the month, while the benchmark performance was measured at 86bp. The Fund's gross yield is at 12.04%, modified duration is at 1.65, and its weighted term to maturity at 4.5 years.

#### **GLOSSARY**

Annualised performance: Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest performance: The highest and lowest performance for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Current Yield: Annual income (interest or dividends) divided by the current price of the security.

CPU: Cents Per Unit to the Glossary

Alpha: Denotes the outperformance of the fund over the benchmark.

Sharpe Ratio: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

Standard Deviation: The deviation of the return stream relative to its own average.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

% Positive Month: The percentage of months since inception where the Fund has delivered positive return.

Average Duration: The weighted average duration of all the underlying interest bearing instruments in the Fund.

Forward Yield: The Forward Yield is the expected combined income of the instruments in the portfolio over the next year expressed as a percentage of the current value of those instruments.
