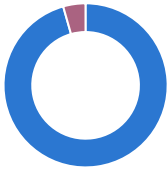
GEOGRAPHIC ALLOCATION (%)

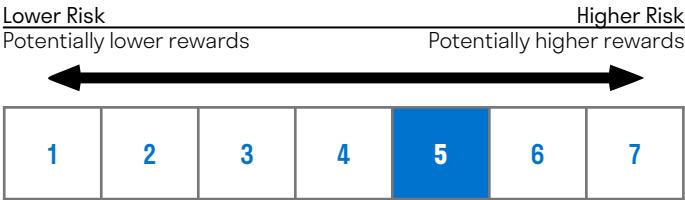
