The Fund's investment objective is to achieve long term capital growth by investing in global equity markets.




RISK INDICATOR







MARKET COMMENTARY

The Fund returned 4.63% for the month, outperforming the benchmark by 1.14%. Global markets enjoyed strong performances in March, with the S&P Global 1200 Index increasing 3.5%, the MSCI ACWI climbing 3.2% and the MSCI Emerging Markets Index rising 2.2% (all in USD).

The US market continues to be supported by resilient economic data and strong corporate earnings. The S&P 500 Index rose 3.1% over the month, despite February inflation coming in higher than expected, which likely delays monetary easing further than the market originally expected at the start of the year. European markets also enjoyed a strong month, rising 3.4% as inflation continued to cool and the economic outlook improved. Within Emerging markets, Taiwan had a strong month driven by continued investors' appetite for Al-related technology businesses, while China was only marginally higher as investors remain cautious about the economic outlook, despite select stimulus by the government. On a sector level, returns were driven by Energy, rising 8.5% and Materials, where the fund is largely neutrally positioned.

Noteworthy portfolio actions include selling out of the holding in Lowe's and trimming the existing position in Evolution, while the exposure to the technology sector was increased by topping up Apple, Automatic Data Processing, Prosus and initiating a new position in Infineon. Lowe's share price has performed very well despite persistent earnings downgrades, which means the share has rerated to unattractive levels. Infineon has lagged behind the semiconductor sector due to concerns about increased Chinese competition, which we think are overblown. Existing positions in BHP Billiton and Petrobras were topped up during the month at good levels.

Notable contributors to Fund performance were positions in Kaspi (+87 bps absolute and relative), JD.com (+51 bps absolute and relative), Google (+46 bps absolute, +23 bps relative) and Tencent (+29 bps absolute, +25 bps relative). Notable detractors from performance over the month came from Apple (-16 bps absolute, +6 bps relative), Evolution (-16 bps absolute and relative), while an underweight holding in Nvidia detracted 32 bps from relative performance following a strong set of quarterly results.

The Fund's positioning remains largely unchanged, with an underweight in the cyclical names. However, exposure to defensive names have decreased, with an increase in Technology names following strong performances. The Fund remains overweight Chinese technology shares and Kazakhstan through positions in Kaspi and Halyk. We are underweight Japanese and US technology shares as we do not believe the risk-reward is attractive at these levels.

Annualised Performance: Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual

Highest & Lowest Performance: The highest and lowest performance for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Current Yield: Annual income (interest or dividends) divided by the current price of the security.

Sharpe Ratio: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

Sortino Ratio: A measure of the risk-adjusted return of a portfolio. It is a modification of the Sharpe ratio but only penalises the returns falling below a user specified target, or required rate of return, while the Sharpe ratio penalises both upside and downside volatility equally.

Standard Deviation: The deviation of the return stream relative to its own average.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

Max Gain: Largest increase in any single month.

% Positive Month: The percentage of months since inception where the Fund has delivered positive return.

Performance Fee Cap: The maximum performance fee that can be charged over a specified period

Specific Risk

Default Risk: The risk that the issuers of fixed income instruments may not be able to meet interest payments nor repay the money they have borrowed. The issuers credit quality is vital. The worse the credit quality, the greater the risk of default and therefore investment loss
