MINIMUM DISCLOSURE DOCUMENT

INVESTMENT AND RETURN OBJECTIVE

The Fund aims to achieve returns above the STeFI Call Index, while minimising the risk of any underperformance. Importantly, the Fund is managed conservatively and it aims to maintain capital stability and liquidity.

INVESTMENT PROCESS

The Fund will only invest in the Big Four corporate banks in South Africa and in South African government and government guaranteed instruments. The Fund invests in cash and high-quality capital market instruments. The Fund is structured to minimise the risk of not meeting the benchmark. Returns achieved above the benchmark are used in specialist strategies designed to enhance yield further.

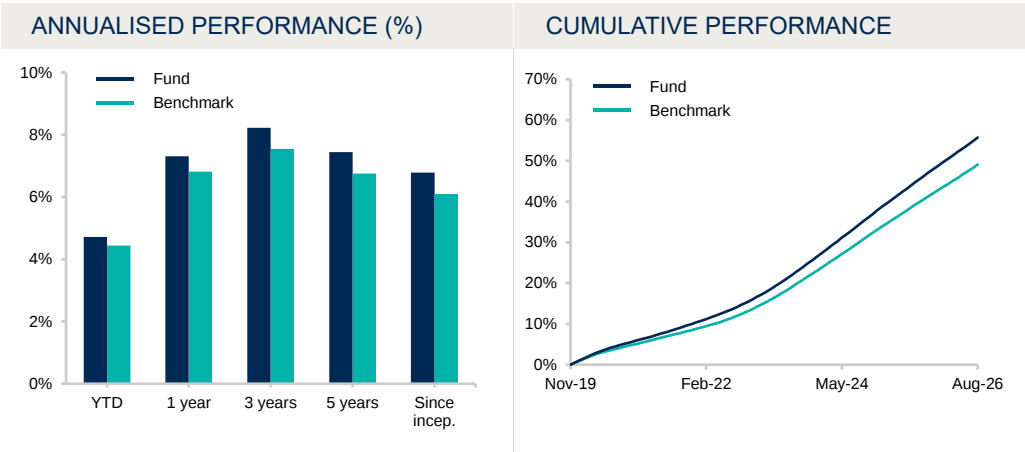
WHO SHOULD INVEST

Investors seeking a liquid, low risk money market offering, with enhanced yields. This Fund is suitable to institutional and corporate investors who do not want exposure to non-bank issued corporate debt.

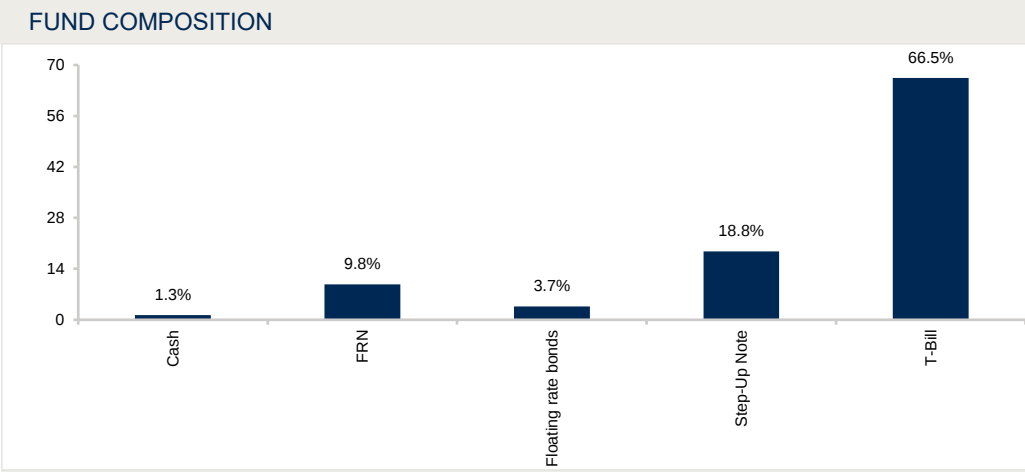
RISK INDICATOR DEFINITION

These portfolios typically have no or low equity exposure, resulting in higher interest yields and stable capital values with the probability of capital losses over the shorter term (3 months) highly unlikely. 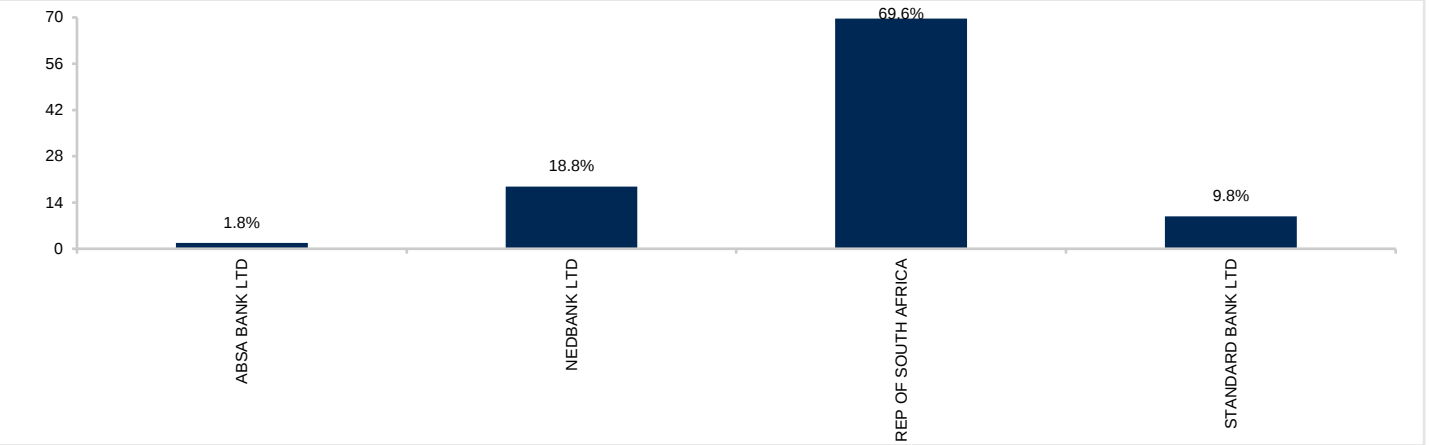

FUND COMMENTARY

Locally, South African money markets were relatively subdued during August as markets continued to digest the South African Reserve Bank's (SARB) surprise decision in July to leave the repo rate unchanged at 7.00%. Inflation remained a key focus for investors, with the SARB continuing to highlight upside risks stemming from elevated global energy prices and ongoing geopolitical tensions in the Middle East. At the same time, softer domestic economic growth and signs of moderating demand have reduced expectations of any immediate policy action, leaving markets broadly comfortable with the current interest rate outlook.

Money market yields were broadly stable through August. Treasury bill yields remained unchanged at the shorter and intermediate tenors, with the 3-month, 6-month and 9-month rates ending the month at 6.89%, 7.41% and 7.67%, respectively. The 12-month Treasury bill yield increased marginally from 7.72% to 7.75%, reflecting a modest term premium at the longer end of the curve.

Bank NCD rates showed mixed performance during the month. The 3-month NCD rate increased from 6.88% to 6.93%, while the 9-month tenor edged higher from 7.45% to 7.48%. In contrast, the 6-month NCD yield declined from 7.15% to 7.10% and the 12-month NCD yield fell from 7.73% to 7.65%.

The relationship between Treasury bill and NCD yields continued to favour government-issued paper beyond the very front end of the curve. While 3-month NCDs offered a modest yield premium of approximately 4 basis points over Treasury bills, Treasury bills remained significantly more attractive from 6 months onwards. At month-end, 6-month Treasury bills yielded 31 basis points more than comparable NCDs, while the yield advantage measured 19 basis points and 10 basis points at the 9- and 12-month tenors respectively. Given the superior credit quality of Treasury bills, investors were able to earn higher yields without assuming additional bank credit risk.

Treasury bill liquidity in the South African market remained healthy throughout August, with weekly auctions attracting solid participation and remaining comfortably subscribed. Market liquidity conditions remained supportive, with ample demand across both government and bank-issued money market instruments.

The Fund delivered another month of solid performance relative to its benchmark during August, supported by its allocation to high-quality yielding assets and active positioning across money market opportunities. The Fund continued to benefit from attractive short-term yields while maintaining a conservative risk profile. With the SARB expected to remain data dependent and the next MPC meeting scheduled for September, the Fund's floating-rate exposure remains well positioned to benefit should interest rates remain elevated for longer than currently anticipated.

GLOSSARY

Annualised performance: Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest performance: The highest and lowest performance for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Current Yield: Annual income (interest or dividends) divided by the current price of the security.

CPU: Cents Per Unit to the Glossary

Alpha: Denotes the outperformance of the fund over the benchmark.

% Positive Month: The percentage of months since inception where the Fund has delivered positive return.

Average Duration: The weighted average duration of all the underlying interest bearing instruments in the Fund.

Fund Specific Risks

Default Risk: The risk that the issuers of fixed income instruments may not be able to meet interest payments nor repay the money they have borrowed. The issuers credit quality is vital. The worse the credit quality, the greater the risk of default and therefore investment loss.

A Money Market portfolio is not a bank deposit account and the price is targeted at a constant value. The total return is made up of interest received and any gain or loss made on any particular instrument; and in most cases the return will have the effect of increasing or decreasing the daily yield, but in the case of abnormal losses it can have the effect of reducing the capital value of the portfolio. The yield is calculated as a weighted average yield of each underlying instrument in the portfolio.
