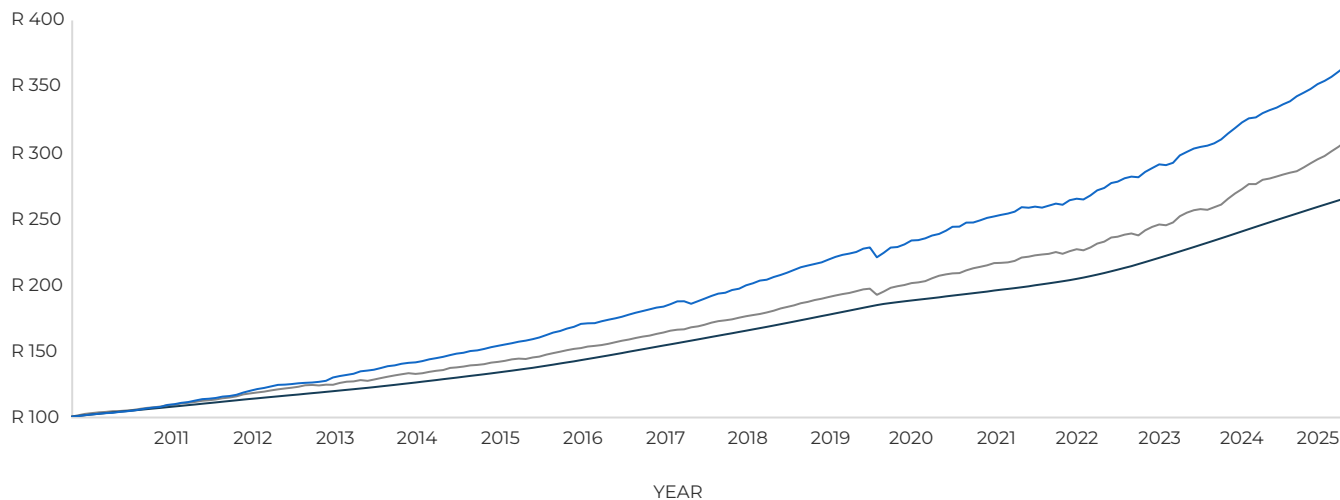

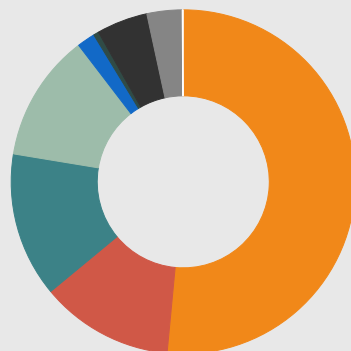

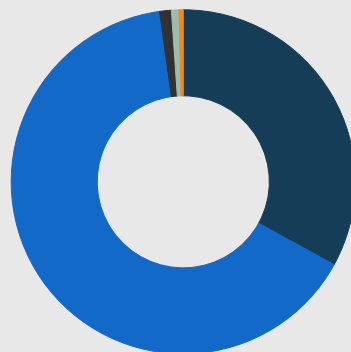

## DEFINITIONS & RISKS

**Annualised Performance:** Longer term performance rescaled to a 1-year period and is the average return per a year, per period. Actual figures available on request.
