FUND COMMENTARY

South Africa goes to the polls on the 29th of May in an election where the ANC as the ruling party is likely to lose its 50% majority control of parliament. This is likely to usher in a new era of coalition politics at the national level in South Africa. Speculation on the outcome of the election, or the probability of how a ruling coalition might look is perhaps unnecessary. Using the experience at local government level as a guide, it is likely any coalition will be unstable, and more than likely subject to shift and change over shorter periods of time due to ideological disagreements. The net effect of instability in South Africa's coalition politics can clearly be seen, with little maintenance expenditure being undertaken, and almost no capital expenditure on new services or infrastructure in areas governed by coalitions. At this stage there is no evidence to adjust Long Beach's long held economic view for South Africa of low growth and a weaker currency over time.

The fund is fully invested in global equities and ETFs. The companies in which the fund is invested are benefitting from structural growth trends including luxury goods, digital commerce and payments, on-demand mobility, travel and remote work, cloud computing and AI, cyber security, digital entertainment, and digital advertising.

The fund has adhered to its policy objective. The fund's asset allocation is broadly similar to 31 December 2023.

Alpha: Denotes the outperformance of the fund over the benchmark.

Sharpe Ratio: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

Standard Deviation: The deviation of the return stream relative to its own average.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

% Positive Month: The percentage of months since inception where the Fund has delivered positive return.
