The Fund aims to achieve significant real returns over the long term and to outperform the ASISA category average of the South African - Multi-Asset - High Equity funds over a full market cycle by maintaining meaningful exposure to growth assets like equities.

INVESTMENT PROCESS

The Fund invests across a range of assets including equities and interest bearing instruments, both domestically and offshore. The asset allocation is anchored at the long-term strategic allocation, but can be varied tactically to target outperformance of the benchmark by capitalising on signals of significant market mispricing. Where possible, a process of enhanced indexation is utilised within asset classes to deliver stable incremental alpha.

WHO SHOULD INVEST

Investors seeking significant real returns over the long term but who are cost conscious. The Fund is suitable for investors with a medium to long-term investment horizon and is Regulation 28 compliant.

RISK INDICATOR DEFINITION



FUND COMMENTARY

During June, the U.S. Federal Reserve maintained the federal funds rate within the 4.25% to 4.5% range throughout June, reflecting a cautious stance amid mixed economic signals and trade tensions. While inflation and employment remained broadly stable, the Fed noted ongoing uncertainties linked to tariff policies and geopolitical risks. Encourag-ingly, easing tensions between the U.S. and China during the month sparked positive market reactions, with global equity indices such as the MSCI World and MSCI Emerging Markets posting gains of 4.22% and 5.65% respectively.

South Africa's 2025 Fiscal Framework and Revenue Proposals were formally adopted by both Houses of Parliament - the National Assembly and the National Council of Provinces. This formal approval, coming after months of delays and political wrangling, signalled the start of a more focused budget process, with parliamentary committees prepar-ing for detailed analysis and public consultation on the Division of Revenue Bill and Appropriation Bill. This progres-sion helped to reduce fiscal uncertainty and provided clearer direction for government spending and revenue collec-tion for the year ahead.

In parallel, the South African Reserve Bank (SARB) and National Treasury continued their collaborative review of the country's inflation targeting framework which SARB governor Lesetja Kganyago has said is close to completion. Both institutions recognised that the current wide inflation target range of 3% to 6% is less aligned with global peers, many of whom aim for tighter targets closer to 2-3%. A series of macroeconomic studies commissioned by the Treasury over the past year support the possibility of narrowing the target to enhance policy effectiveness and better anchor inflation expectations amid changing global economic conditions.

Despite ongoing geopolitical tensions - including U.S. strikes on Iranian nuclear facilities and subsequent missile retal-iations - global financial markets remained relatively stable. Oil prices experienced some volatility but ultimately set-tled without causing significant disruptions. Meanwhile, major indices such as Japan's Nikkei 225 and the U.S. S&P 500 delivered solid returns of 6.64% and 4.96%, respectively, underscoring market resilience amid external shocks. This positive momentum was mirrored in global bond yields, as Japan's 10-year yield fell to 1.43%, the UK's to 4.49%, and the US 10-year yield declined to 4.23%.

Locally, the Johannesburg Stock Exchange (JSE) benefited from improved investor sentiment, with the FTSE/JSE All Share Index rising by 2.35%. Gains were primarily driven by mining and telecommunications stocks, supported by strong global demand and robust commodity prices. The local bond market also showed strength, with the FTSE/JSE All Bond Index Total Return increasing by 2.28% and the FTSE/JSE CILI Index increasing by 0.62%.

The Fund currently holds a neutral view towards South African equity and bonds while being moderately negative on developed market equity and positive on U.S. Bonds. Our view on the rand has turned neutral.

Fund performance was positive for the month due to continued good performance in global equity and fixed interest markets. The appreciating rand detracted from portfolio performance.

GLOSSARY

Annualised Performance: Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest Performance: The highest and lowest performance for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Current Yield: Annual income (interest or dividends) divided by the current price of the security.

Sharpe Ratio: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

Standard Deviation: The deviation of the return stream relative to its own average.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

% Positive Month: The percentage of months since inception where the Fund has delivered positive return.

FUND RISK

Default Risk: The risk that the issuers of fixed income instruments may not be able to meet interest payments nor repay the money they have borrowed. The issuers credit quality is vital. The worse the credit quality, the greater the risk of default and therefore investment loss.
