MINIMUM DISCLOSURE DOCUMENT & GENERAL INVESTOR REPORT

INVESTMENT AND RETURN OBJECTIVE

The Fund aims to return STeFi Call + 3% per annum through a full interest rate cycle by offering investors an enhanced income yield without undue risk on capital by maintaining constrained credit risk exposure.

INVESTMENT PROCESS

The Fund invests in a diversified portfolio consisting primarily of South African vanilla debt, mezzanine and structured instruments across the term structure and credit rating bands. Portfolio risk is managed at both single issuer and portfolio level. The former is done through an inhouse dynamic probability of default (PD) based rating model and the latter is through measuring the Expected Loss (EL), Loss Given Default (LGD) and credit VaR (Value at Risk). The Fund's modified duration will typically be below two years. Credit asset selection is underpinned by minimising default risk and credit spread duration.




WHO SHOULD INVEST

Investors seeking performance in excess of what is available in the money market or a typical income fund. The Fund is Regulation 28 compliant.

RISK INDICATOR DEFINITION

This portfolio typically has longer dated and complex credit exposures, resulting in some capital volatility and liquidity constraints to investors over the shorter term. It is managed in such a manner that the probability of capital losses over one-year periods is unlikely, and in a manner that would cater for client redemptions appropriately.

FUND COMMENTARY

In December, the U.S. Federal Open Market Committee (FOMC) cut the federal funds rate by 25bps, lowering the target to the midpoint of 3.625%. The Fed's updated economic projections pointed to a more cautious policy path, with just a single rate cut in each of 2026 and 2027. Chair Powell reiterated the Fed's commitment to maintaining ample system liquidity, announcing the resumption of Treasury bill purchases to support reserves, signalling an early end to quantitative tightening and a more nuanced outlook for global financial conditions.

Locally, headline CPI for November moderated to 3.5% year-on-year from 3.6% in October, undershooting market expectations of 3.6%. The deceleration was largely driven by the transport category, reflecting lower fuel price inflation. Core inflation edged higher to 3.2% year-on-year from 3.1%, in line with expectations, driven by increases in alcoholic beverages and services prices.

Debt Capital Market (DCM) activity softened in December as issuance tapered off toward year-end. Total term issuance amounted to R3.6bn, a marked decline from R22.4bn in November and R12.5bn in December 2024. Market activity was subdued, with all issuance occurring via private placements. Pepkor Holdings Ltd was the largest issuer, raising R1.75bn in 5-year senior notes, followed by Investec Ltd with R500m of Additional Tier 1 issuance and the Development Bank of Southern Africa, which placed R500m of senior debt. On a full-year basis, total term issuance reached R165.1bn, marginally higher than the R161.4bn recorded over the same period last year.

Regarding our view on credit markets, our theme is determined by a combination of the output of our Credit Cycle Indicator (CCI), consideration of individual counterparty default probabilities, and the yields offered on these opportunities. Our CCI suggests continued heightened risk levels inherent in the South African Credit market, and the Fund's positioning emphasizes holding assets with defensive characteristics, while opportunistically taking on additional risk as deemed appropriate.

The Fund delivered a net return of 116 basis points over the month, outperforming the benchmark, which returned 78 basis points. Year-to-date performance for 2025 stands at 11.61%, ahead of the benchmark return of 10.26%. As at month-end, the Fund's gross yield was 9.84%, with a modified duration of 1.41 and a weighted term to maturity of 5.2 years.

GLOSSARY

Annualised performance: Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest performance: The highest and lowest performance for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Current Yield: Annual income (interest or dividends) divided by the current price of the security.

CPU: Cents Per Unit to the Glossary

Alpha: Denotes the outperformance of the fund over the benchmark.

Sharpe Ratio: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

Standard Deviation: The deviation of the return stream relative to its own average.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

% Positive Month: The percentage of months since inception where the Fund has delivered positive return.

Average Duration: The weighted average duration of all the underlying interest bearing instruments in the Fund.

Forward Yield: The Forward Yield is the expected combined income of the instruments in the portfolio over the next year expressed as a percentage of the current value of those instruments.

Fund Specific Risks

Default Risk: The risk that the issuers of fixed income instruments may not be able to meet interest payments nor repay the money they have borrowed. The issuers credit quality is vital. The worse the credit quality, the greater the risk of default and therefore investment loss.

Derivatives risk: The use of derivatives could increase overall risk by magnifying the effect of both gains and losses in a Fund. As such, large changes in value and potentially large financial losses could result.
