INVESTMENT OBJECTIVE

To provide long-term capital growth to investors and target returns of CPI+4% over rolling 7-year periods. This fund is well diversified across asset classes, actively managed with a higher exposure to global markets and is not Regulation 28 compliant.

RISK INDICATOR AND WHO SHOULD INVEST

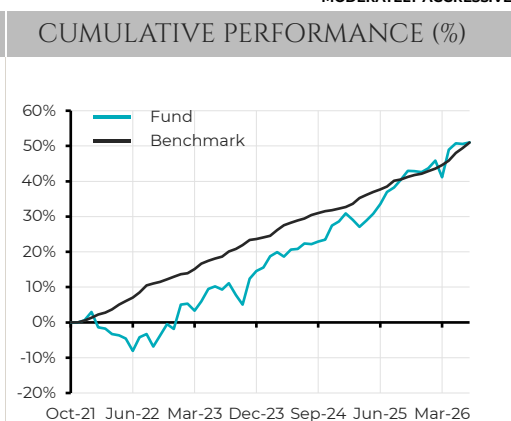

RISK INDICATOR



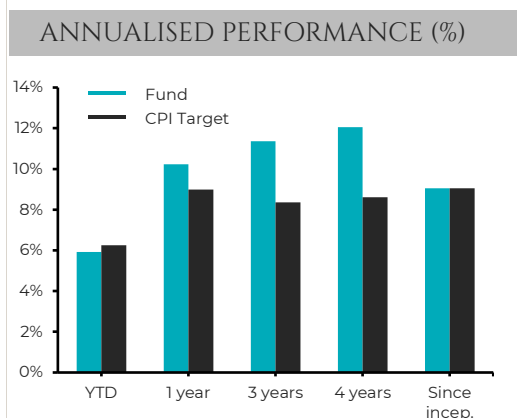

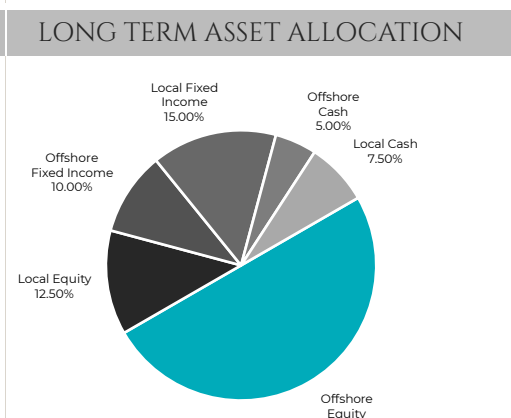

FUND COMMENTARY

Looking at South African asset classes, the FTSE/JSE All Share Index declined by 1.8% year to date but delivered a positive return of 17.2% over the 12-month period. The FTSE/JSE All Bond Index returned 2.8% year to date, taking its 12-month return to 16.0%. The FTSE/JSE All Property Index delivered a solid 6.9% return year to date, bringing its 12-month return to 26.0%.

For offshore assets, the MSCI All Country World Index delivered an 11.3% year-to-date return and returned 22.0% over the 12-month period. The Bloomberg Global Aggregate Bond Index lost 0.8% year to date and delivered a return of 1.6% over the year.

The rand closed at R16.56 against the US dollar.

Global index returns are reported in US dollars.

GLOSSARY

Annualised Performance: Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest performance: The highest and lowest performance for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Total Expense Ratio (TER%): The Total Expense Ratio (TER) is the percentage of the net asset value of the class of the Financial Product incurred as expenses relating to the administration of the Financial Product.

Transaction Costs (TC%): The Transaction Costs (TC) is the percentage of the net asset value of the Financial Product incurred as costs relating to the buying and selling of the assets underlying the Financial Product.

Total Investment Charges TIC (%) = TER (%) + TC (%): The Total Investment Charges (TIC), the TER + the TC, is the percentage of the net asset value of the class of the Financial Product incurred as costs relating to the investment of the Financial Product. It should be noted that a TIC is the sum of two calculated ratios (TER+TC).
