
WHO SHOULD INVEST



FUND COMPOSITION


CUMULATIVE PERFORMANCE

FUND COMMENTARY

With heightened uncertainty markets saw the Federal Open Market Committee (FOMC) keep the federal funds rate unchanged during March, in line with market expectations. The median projections (dot plot) continued to indicate two rate cuts in 2025, two in 2026, and one in 2027. However, the average projection turned slightly less dovish. Fed Chair Jerome Powell reiterated that the FOMC is well-positioned to wait for further clarity and is in no rush to implement additional rate cuts.

Domestically, the Monetary Policy Committee (MPC) also opted to keep the repo rate unchanged at 7.5%. However, the decision was not unanimous, with a 4-2 split among committee members. The Governor's communication remained hawkish, emphasizing concerns about the external environment—particularly the outlook for U.S. monetary policy and risks associated with trade tariffs.

Given the movement in the SA yield curve, we continue to favour floating rate exposure in the 3-year segment, while concentrating our fixed rate exposure in the 10-year segment where we see the greatest value relative to the associated risk. With credit spreads continuing to tighten and latest Bank AT1 credit remaining tight, we have favoured floating rate assets with government exposure underlying, reducing the overall credit risk in the Fund.

The Fund's forward yield remains attractive at 9.41%. The Fund has an interest rate duration of 1.39 years. The current risk in the portfolio aligns with the Fund's risk objective and we see the Fund well positioned to achieve its return objectives.

The Fund slightly underperformed its benchmark for the month. The key contributors to performance were the higher yielding floating assets and Money Market exposure. The Preference Shares were the key detractor.

GLOSSARY

Annualised performance: Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest performance: The highest and lowest performance for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Current Yield: Annual income (interest or dividends) divided by the current price of the security.

CPU: Cents Per Unit to the Glossary

Alpha: Denotes the outperformance of the fund over the benchmark.

Sharpe Ratio: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

Standard Deviation: The deviation of the return stream relative to its own average.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

Max Gain: Largest increase in any single month.

% Positive Month: The percentage of months since inception where the Fund has delivered positive return.

Average Duration: The weighted average duration of all the underlying interest bearing instruments in the Fund.

Forward Yield: The Forward Yield is the expected combined income of the instruments in the portfolio over the next year expressed as a percentage of the current value of those instruments.
