INVESTMENT OBJECTIVE


The Fund will aim to deliver returns in excess of the benchmark over a long term time horizon.

INVESTMENT POLICY

The fund aims to achieve this by investing predominantly into global equities. This is performed through active and unconstrained management in both South African and foreign markets with a focus on equity opportunities within the offshore markets. The Fund will, apart from assets in liquid form, consist solely of participatory interest in Collective Investment Schemes which will invest in a diversified mix of assets, including but not limited to equities, property, preference shares, money market and fixed interest instruments. The underlying collective investment schemes are permitted to invest in listed and unlisted financial instruments in line with conditions as determined by legislation from time to time.

HOW WE AIM TO MEET THE FUND'S OBJECTIVE

The management team track the asset allocation of reputable asset managers with large research capabilities. The research provides insight into where top professionals are allocating assets. FUND COMMENTARY

The Interactive Global Equity Pres FOF A delivered a return of -2.84% for the first quarter of 2025, reflecting the broader market volatility driven by renewed US protectionist trade policy, elevated inflation concerns, and geopolitical uncertainty. The fund's underperformance was largely attributed to weakness in its US equity exposure, particularly in growth-oriented and technology-heavy strategies.

Key detractors included the Invesco QQQ Trust (-8.14%), VanEck Morningstar Wide Moat ETF (-5.08%), and the iShares Core S&P 500 ETF (-4.28%), which all struggled amid heightened scrutiny of Al-led valuations, sector rotation away from mega-cap tech, and fears of escalating trade tensions under President Trump's new administration.

On the positive side, dividend-oriented and quality-focused strategies provided some stability. The Schwab US Dividend Equity ETF returned +3.22%, benefitting from a shift toward incomegenerating assets in a high-interest-rate environment. Additionally, global diversification supported performance, with the Vanguard FTSE All-World ex-US ETF rising +5.96%, driven by stronger equity performance in Europe and select emerging markets.

Overall, the quarter underscores the importance of diversification across regions and investment styles. While short-term market movements were driven by policy shifts and sentiment, maintaining exposure to quality and dividend-paying stocks—alongside global allocations—remains key to managing downside risk and positioning for future recovery.

GLOSSARY

Fund of Funds: A Fund of Funds is a portfolio that invests in portfolios of collective investment schemes, which levy their own charges, which could result in a higher fee structure for these portfolios.

Annualised performance: Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest performance: The highest and lowest performance for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Current Yield: Annual income (interest or dividends) divided by the current price of the security.

CPU: Cents Per Unit to the Glossary

Alpha: Denotes the outperformance of the fund over the benchmark.

Sharpe Ratio: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

Standard Deviation: The deviation of the return stream relative to its own average.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

% Positive Month: The percentage of months since inception where the Fund has delivered positive return.

FUND SPECIFIC RISK

Default Risk: The risk that the issuers of fixed income instruments may not be able to meet interest payments nor repay the money they have borrowed. The issuers credit quality is vital. The worse the credit quality, the greater the risk of default and therefore investment loss.
