## Strategy

The portfolio managers seek to invest in companies that are mispriced, either because they are out of favour or their intrinsic asset value is misunderstood, or their journey to sustainability is misunderstood. Stock-picking is at the core of the fund's investment approach and is the main driver of risk and return, alongside its value biased investment style. The focus is on owning good quality businesses that can benefit from long term trends, which can act as tailwinds for company cash flows and earnings. ESG considerations are integrated in the investment process.

## Objectives & Investment Policy




