MINIMUM DISCLOSURE DOCUMENT

INVESTMENT AND RETURN OBJECTIVE

The Fund aims to achieve returns above the STeFI Call Index, while minimising the risk of any underperformance. Importantly, the Fund is managed conservatively and it aims to maintain capital stability and liquidity.

INVESTMENT PROCESS

The Fund will only invest in the Big Four corporate banks in South Africa and in South African government and government guaranteed instruments. The Fund invests in cash and high-quality capital market instruments. The Fund is structured to minimise the risk of not meeting the benchmark. Returns achieved above the benchmark are used in specialist strategies designed to enhance yield further.

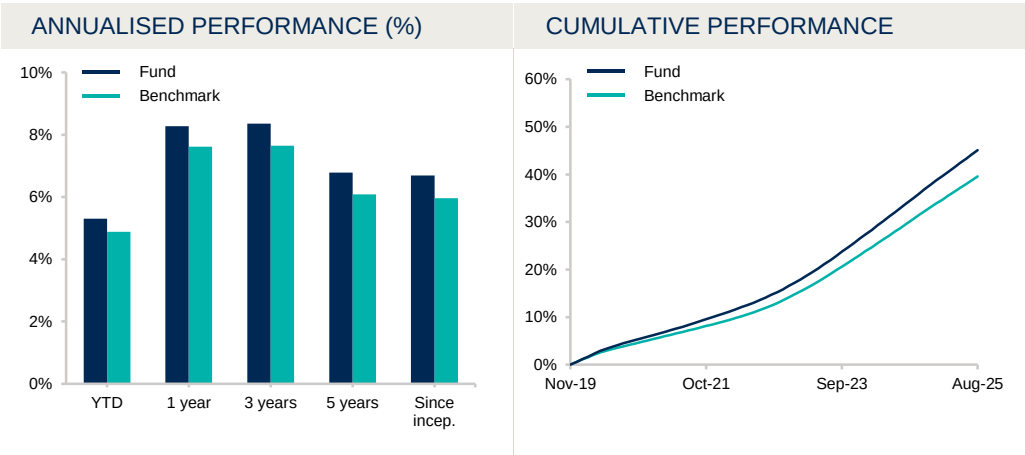
WHO SHOULD INVEST

Investors seeking a liquid, low risk money market offering, with enhanced yields. This Fund is suitable to institutional and corporate investors who do not want exposure to non-bank issued corporate debt.

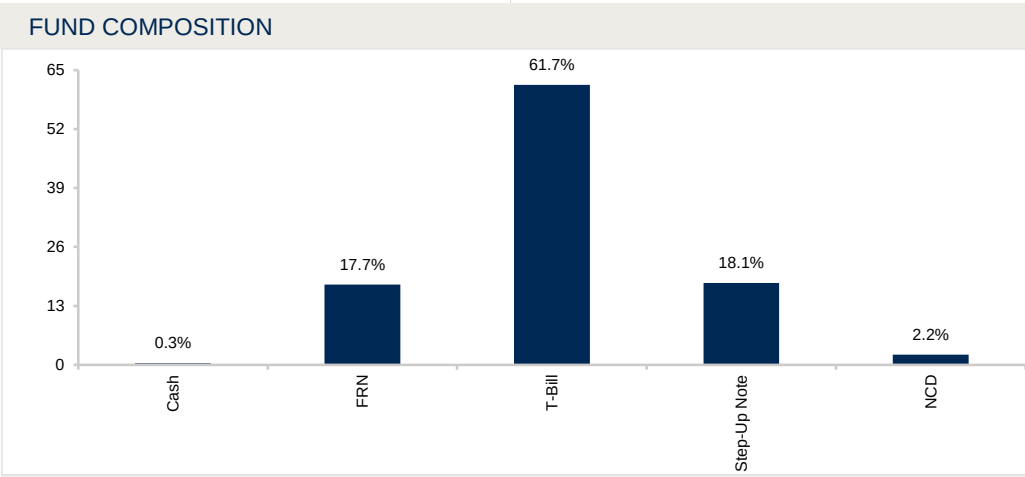
RISK INDICATOR DEFINITION

These portfolios typically have no or low equity exposure, resulting in higher interest yields and stable capital values with the probability of capital losses over the shorter term (3 months) highly unlikely. These portfolios typically target returns in the region of 1% – 3% above inflation before tax over the long term.

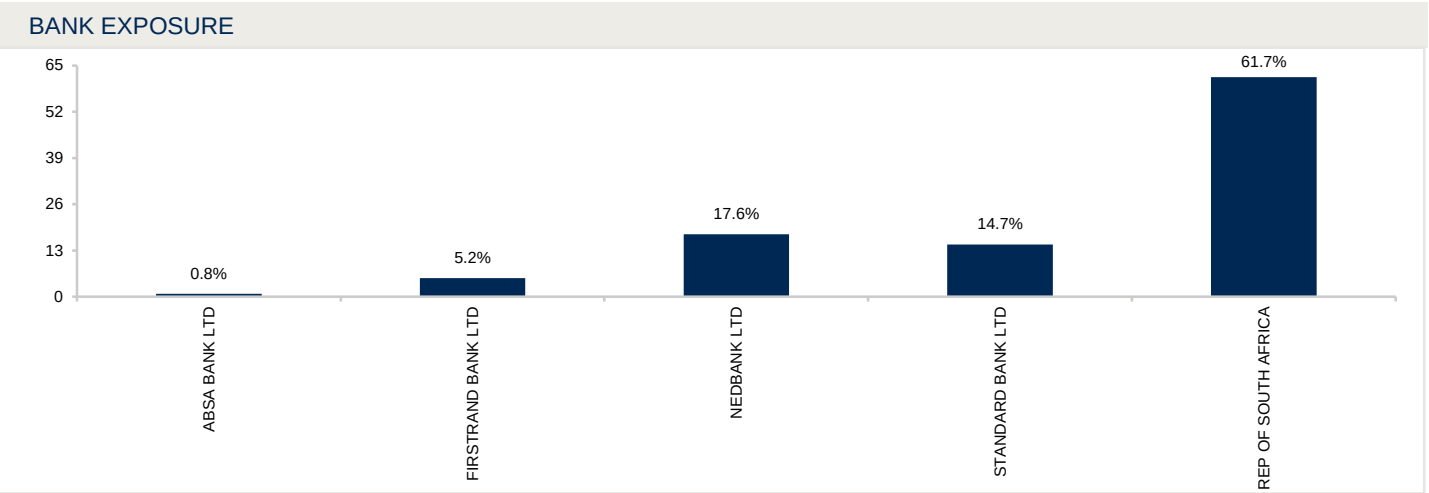

FUND COMMENTARY

Locally, July’s inflation data came broadly in line with expectations. Headline CPI printed at 3.5% year-on-year, while Core CPI registered at 3.0% year-on-year, both in line with consensus estimates. Within the detail, the annual electricity tariff increase was lower than anticipated, providing some relief to consumers and businesses. However, water tariffs rose more than expected, partly offsetting this effect. Food inflation accelerated, reflecting pressures from higher agricultural input costs, while other core goods and services components continued to display broad-based weakness.

With the last repo rate cut, repo rates are now at 7%. This coupled with surprise inflation-target adjustment reinforces SARB’s commitment to supportive monetary policy, strengthening expectations for easier financial conditions outlook ahead.

The 12-month NCD rate together with the 3m Jibar rate compressed close to 12 basis points over the month after the repurchase rate cut of 25 basis points at the end of July.

We still favour Treasury bills when investing in fixed assets rather than Bank NCDs and continue to add credit conservatively when available in the primary or secondary market.

All asset classes contributed positively towards the month’s performance, both the fixed rate exposure and high-quality floating rate corporate assets adding to our above benchmark return.

The Fund delivered strong performance in July, bolstered by positively yielding assets, which contributed meaningfully to the overall return.

There were no detractors over the month.

GLOSSARY

Annualised performance: Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest performance: The highest and lowest performance for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Current Yield: Annual income (interest or dividends) divided by the current price of the security.

CPU: Cents Per Unit to the Glossary

Alpha: Denotes the outperformance of the fund over the benchmark.

% Positive Month: The percentage of months since inception where the Fund has delivered positive return.

Average Duration: The weighted average duration of all the underlying interest bearing instruments in the Fund.

Fund Specific Risks

Default Risk: The risk that the issuers of fixed income instruments may not be able to meet interest payments nor repay the money they have borrowed. The issuers credit quality is vital. The worse the credit quality, the greater the risk of default and therefore investment loss.

A Money Market portfolio is not a bank deposit account and the price is targeted at a constant value. The total return is made up of interest received and any gain or loss made on any particular instrument; and in most cases the return will have the effect of increasing or decreasing the daily yield, but in the case of abnormal losses it can have the effect of reducing the capital value of the portfolio. The yield is calculated as a weighted average yield of each underlying instrument in the portfolio.
