MINIMUM DISCLOSURE DOCUMENT

INVESTMENT AND RETURN OBJECTIVE

The Fund aims to deliver returns close to the MSCI World Index Total Return at low cost. Although the Fund is structured similarly to the MSCI World Index, it is not a tracker fund and can out / underperform the MSCI World Index by small amounts over time.

INVESTMENT PROCESS

The Fund follows an investment policy which firstly endeavours to follow the composition of the MSCI World Index closely and secondly seeks enhancement opportunities to secure for investors an optimum overall return. The Fund can use derivatives to create exposure to the MSCI World Index or subsets thereof in a low cost and efficient manner.

WHO SHOULD INVEST

Investors who are seeking long term capital growth through diversified exposure to the global markets by investing in a fund with a low tracking error relative to the MSCI World Index and who are cost conscious.

RISK INDICATOR DEFINITION

These portfolios typically hold meaningful equity and/or offshore exposure which may result in significant capital volatility over all periods. Due to their nature expected long term returns are higher than for the other risk categories.

FUND COMMENTARY

The 2024 calendar year got off to a fair amount of uncertainty resulting in mixed performances across the markets. Encouraging growth numbers and generally strong earnings helped the MSCI World developed market index close the month up 1.20%. In the US, the S&P 500 index gained 1.68% following a lower-than-expected inflation print coupled with a better-than-expected growth number. Despite the cautious interest rate rhetoric from the Central banks suggesting the battle against inflation is still not yet considered won, the market remains priced for rate cuts later this year. European markets were flat, the Eurostoxx closed the month marginally down 0.12%. Further East, Japan had impressive start to the year, the Nikkei 225 index rose 4.34% for the month as investors anticipate exporter earnings to benefit from the depreciation of the Yen. The MSCI Emerging Market index on the other hand got off to an uninspiring start, down 4.64% for the month and significantly underperforming the developed markets. China was the notable driver for the underperformance, the CSI 300 index lost 5.88% for the month despite regulatory interventions intended to revive the economy and restore investor confidence.

Despite domestic year on year inflation (CPI) coming in at 5.1% against 5.2% and 5.5% prior, the monetary policy committee unanimously voted to leave rates unchanged. The local market was red across all major sectors. The Resource sector led the decline, giving back 5.85% for the month and followed within touching distance by the Financial sector which was down 2.90%. Industrial proved the more resilient, however still down 1.50% for the month. The relative strength in the developed markets and repricing for later rate cuts saw the local currency close the month 1.73% weaker.

The MSCI Daily TR Net (ZAR) Index closed the month up 3.68%. The Fund was behind the benchmark, up 3.38% (gross of fees) for the month.

Contributors to Performance:

The positions that contributed most to the absolute performance of the Fund for the month were NVIDIA Corp (+24.24%), Microsoft Corp (+5.73%) and Meta Platforms Inc (+10.22%).

Detractors from Performance:

The largest detractors from the month's absolute performance were Tesla Inc (-24.63%), Apple Inc (-4.22%), and Intel Corp (-14.27%).

GLOSSARY

Annualised performance: Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest performance: The highest and lowest performance for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Current Yield: Annual income (interest or dividends) divided by the current price of the security.

CPU: Cents Per Unit to the Glossary

Alpha: Denotes the outperformance of the fund over the benchmark.

Sharpe Ratio: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

Standard Deviation: The deviation of the return stream relative to its own average.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

Dividend Yield: The weighted average dividend yield of all the underlying equity in the Fund. The dividend yield of each company is the dividends per share divided by the price.

PE Ratio: The weighted average price earnings ratio of all the underlying equity in the Fund. The price earnings ratio of each company is the price divided by the earnings per share.

Fund Specific Risks

Default Risk: The risk that the issuers of fixed income instruments may not be able to meet interest payments nor repay the money they have borrowed. The issuers credit quality is vital. The worse the credit quality, the greater the risk of default and therefore investment loss.

Derivatives risk: The use of derivatives could increase overall risk by magnifying the effect of both gains and losses in a Fund. As such, large changes in value and potentially large financial losses could result.

Foreign Investment risk: Foreign securities investments may be subject to risks pertaining to overseas jurisdictions and markets, including (but not limited to) local liquidity, macroeconomic, political, tax, settlement risks and currency fluctuations.

Interest rate risk: The value of fixed income investments (e.g. bonds) tends to be inversely related to interest and inflation rates. Hence their value decreases when interest rates and/or inflation rises.

Geographic / Sector risk: For investments primarily concentrated in specific countries, geographical regions and/or industry sectors, their resulting value may decrease whilst portfolios more broadly invested might grow.

Equity investment risk: Value of equities (e.g. shares) and equity-related investments may vary according to company profits and future prospects as well as more general market factors. Transaction Costs (TC) is the percentage of the value of the Fund incurred as costs relating to the buying and selling of the Fund's underlying assets. Transaction cost is a necessary cost in administering the Fund and impacts Fund returns. It should not be considered in isolation as returns may be impacted by many other factors over time including market returns, the type of Fund, investment decisions of the investment manager and the TER. A Feeder Fund is a portfolio that invests in a single portfolio of a collective investment scheme which levies its own charges, and which could result in a higher fee structure for the feeder fund.

Where a current yield has been included for Funds that derive its income primarily from interest bearing income, the yield is a weighted average yield of all underlying interest bearing instruments as at the last day of the month. This yield is subject to change as market rates and underlying investments change.

The Manager retains full legal responsibility for any third-party-named portfolio.
