MINIMUM DISCLOSURE DOCUMENT

INVESTMENT AND RETURN OBJECTIVE

The Fund aims to achieve returns above the STeFI Call Index, while minimising the risk of any underperformance. Importantly, the Fund is managed conservatively and it aims to maintain capital stability and liquidity.

INVESTMENT PROCESS

The Fund will only invest in the Big Four corporate banks in South Africa and in South African government and government guaranteed instruments. The Fund invests in cash and high-quality capital market instruments. The Fund is structured to minimise the risk of not meeting the benchmark. Returns achieved above the benchmark are used in specialist strategies designed to enhance yield further.

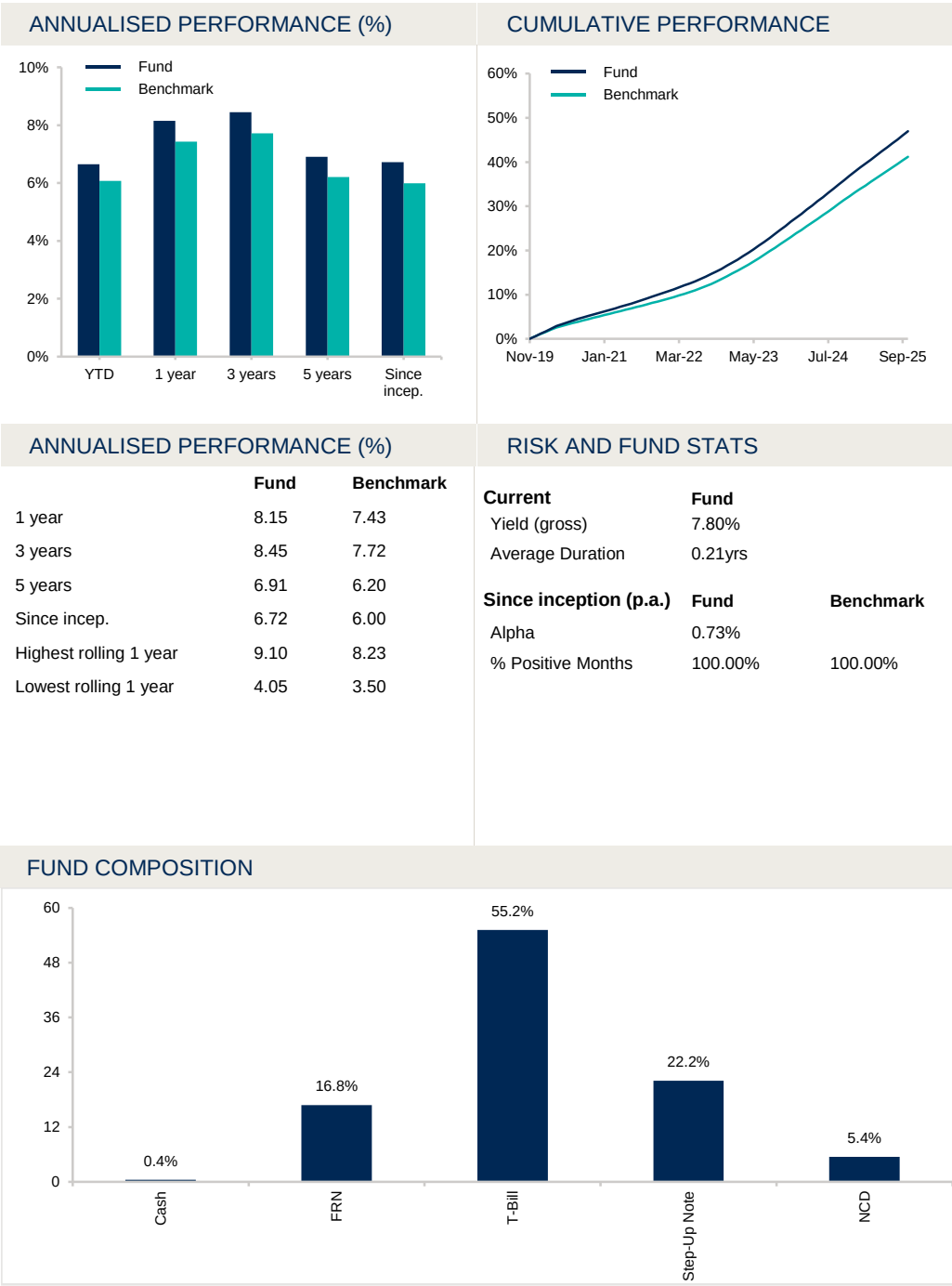
WHO SHOULD INVEST

Investors seeking a liquid, low risk money market offering, with enhanced yields. This Fund is suitable to institutional and corporate investors who do not want exposure to non-bank issued corporate debt.

RISK INDICATOR DEFINITION

These portfolios typically have no or low equity exposure, resulting in higher interest yields and stable capital values with the probability of capital losses over the shorter term (3 months) highly unlikely. These portfolios typically target returns in the region of 1% – 3% above inflation before tax over the long term.

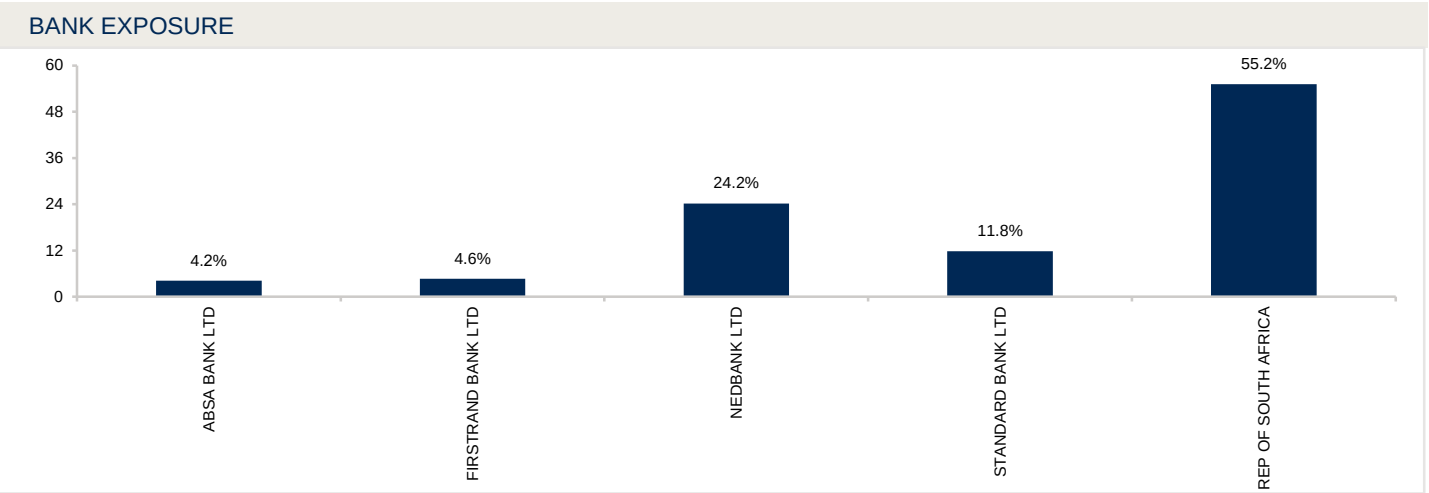

FUND COMMENTARY

Domestically the background for October was dominated by inflation data and its implications for future monetary policy. Headline inflation for September came in at 3.4%, a slight increase from August's 3.3% but below market sentiment. This inflation figure, remain comfortably within the SARB's 3-6% target range, which has fuelled speculation that the SARB may have room to cut rates at its final meeting for the year on November 20.

South Africa's money market rates and treasury bills held firm throughout October 2025, anchored by the South African Reserve Bank's (SARB) steady repo rate and influenced by growing expectations of a potential interest rate cut in November.

These rates indicate a relatively flat yield curve for short-term government debt, with the tbills offering a higher return than bank OTC paper. The consistent demand at the Tbill auctions throughout the month, points to healthy liquidity in these money market assets.

The NCD rates came in around 5points in 9 and 12 month tenor and 2.5points in the shorter 3 and 6 month area, while Treasury bills offered better yields pickup around 33 Basis points in the 6month over NCD and 26 basis points pickup in the 9 month over NCD.

We still favour Treasury bills when investing in fixed assets rather than Bank NCDs and continue to add credit conservatively when available in the primary or secondary market.

All asset classes contributed positively towards the month's performance, both the fixed rate exposure and high-quality floating rate corporate assets adding to our above benchmark return.

The Fund delivered strong performance in October, bolstered by positively yielding assets, which contributed to meaningful overall return to the fund.

GLOSSARY

Annualised performance: Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest performance: The highest and lowest performance for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Current Yield: Annual income (interest or dividends) divided by the current price of the security.

CPU: Cents Per Unit to the Glossary

Alpha: Denotes the outperformance of the fund over the benchmark.

% Positive Month: The percentage of months since inception where the Fund has delivered positive return.

Average Duration: The weighted average duration of all the underlying interest bearing instruments in the Fund.

Fund Specific Risks

Default Risk: The risk that the issuers of fixed income instruments may not be able to meet interest payments nor repay the money they have borrowed. The issuers credit quality is vital. The worse the credit quality, the greater the risk of default and therefore investment loss.

Interest rate risk: The value of fixed income investments (e.g. bonds) tends to be inversely related to interest and inflation rates. Hence their value decreases when interest rates and/or inflation rises.

Transaction Costs (TC) is the percentage of the value of the Fund incurred as costs relating to the buying and selling of the Fund's underlying assets. Transaction cost is a necessary cost in administering the Fund and impacts Fund returns. It should not be considered in isolation as returns may be impacted by many other factors over time including market returns, the type of Fund, investment decisions of the investment manager and the TER. A Money Market portfolio is not a bank deposit account and the price is targeted at a constant value. The total return is made up of interest received and any gain or loss made on any particular instrument; and in most cases the return will have the effect of increasing or decreasing the daily yield, but in the case of abnormal losses it can have the effect of reducing the capital value of the portfolio. The yield is calculated as a weighted average yield of each underlying instrument in the portfolio. Excessive withdrawals from the portfolio may place the portfolio under liquidity pressures and a process of ring-fencing of withdrawal instructions and managed pay-outs over time may be followed. Where a current yield has been included for Funds that derive its income primarily from interest bearing income, the yield is a weighted average yield of all underlying interest bearing instruments as at the last day of the month. This yield is subject to change as market rates and underlying investments change.
