MINIMUM DISCLOSURE DOCUMENT

INVESTMENT AND RETURN OBJECTIVE

The Fund aims to return CPI + 3% per annum through a full interest rate cycle while providing stability by aiming never to lose capital over any rolling 3 month period.

INVESTMENT PROCESS

This Fund invests in local money market, bonds, inflation-linked bonds, preference shares and derivatives to meet the investment objectives. Fund performance can be generated from taking interest rate views or duration, yield enhancement via credit instruments, asset allocation between income producing asset classes and also via the use of derivatives.

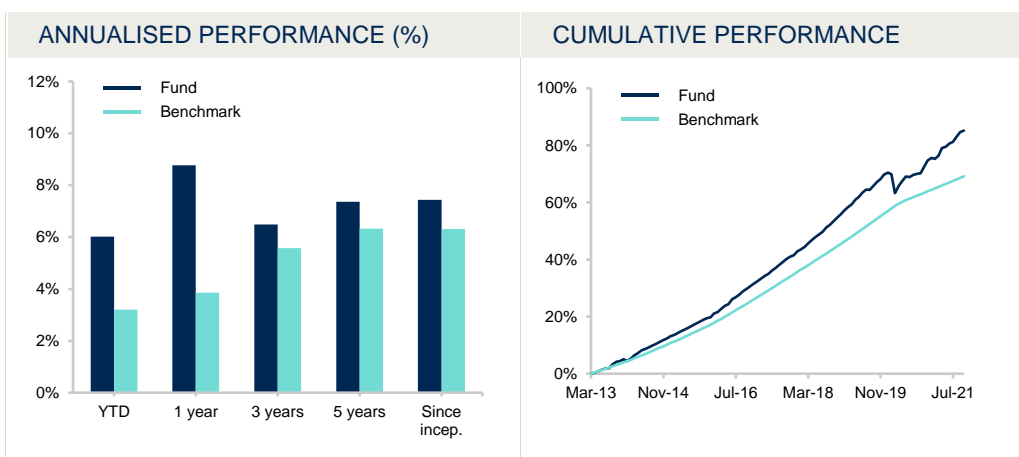
WHO SHOULD INVEST

Investors seeking stable real returns and aiming to maximise income via exposure to primarily the South African Money and Bond markets. This Fund is suitable to investors with a short- to medium-term investment horizon and is Regulation 28 compliant.

RISK INDICATOR DEFINITION

These portfolios typically have no or low equity exposure, resulting in higher interest yields and stable capital values with the probability of capital losses over the shorter term (3 months) highly unlikely. These portfolios typically target returns in the region of 1% – 3% above inflation before tax over the long term.

FUND COMMENTARY

The global economy continues to exhibit an uneven recovery from the Covid-19-induced recession of 2020, strengthened by widespread vaccination rollouts and accommodative fiscal and monetary policy settings in advanced economies. Indicators of economic activity in some major global economies are now above their pre-Covid trend. The spread of the more contagious Delta variant of the virus, coupled with supply bottlenecks, is casting a shadow over the near-term growth prospects for the global economy. Potential tapering of asset purchases by the Fed as well as concerns over inflationary pressures is continuing to create uncertainty for market participants, seeing a risk off tilt to markets during October. The quantitative easing program has played a vital role in the economic recovery and, as such, Jerome Powell, the Chairman of the Federal Reserve, has assured the public that the policy will remain accommodative until their goals on employment and inflation are reached. The local market continues to aggressively price interest rate hikes and with still subdued GDP and Inflation expectations within the target range we see this pricing as showing value in fixed rate assets and taking advantage our term structure. As such, we favour duration/ fixed rate risk in the portfolio. We continue to see the current inflation environment as transitory and should see SA Fixed Income assets benefit from continued foreign flows. The Fund performed ahead of cash for the month. Most of the assets contributed to the return for the month with Preference shares being the most notable after a strong month. The fixed-rate (duration) bond and money market positions detracted from the performance this month. We remain vigilant in our risk management with yields suppressed and risk elevated. To this end we continue to hold protection strategies against our duration and offshore exposure.

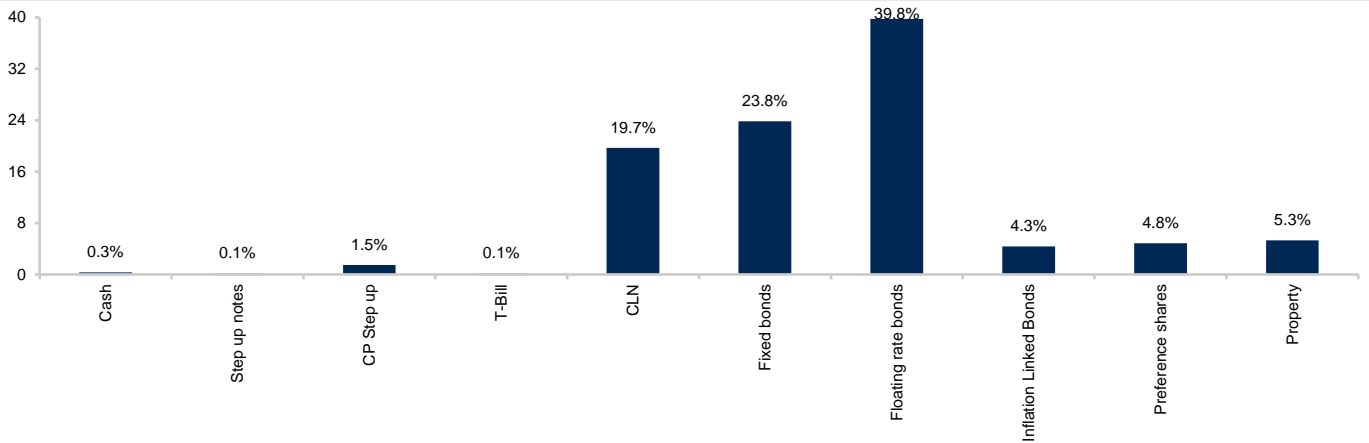

GLOSSARY

Annualised performance: Annualised performance show longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest performance: The highest and lowest performance for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Current Yield: Annual income (interest or dividends) divided by the current price of the security.

CPU: Cents Per Unit to the Glossary

Alpha: Denoted the outperformance of the fund over the benchmark.

Sharpe Ratio: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

Standard Deviation: The deviation of the return stream relative to its own average.

% Positive Month: The percentage of months since inception where the Fund has delivered positive return.

Average Duration: The weighted average duration of all the underlying interest bearing instruments in the Fund.

Fund Specific Risks

Default Risk: The risk that the issuers of fixed income instruments may not be able to meet interest payments nor repay the money they have borrowed. The issuers credit quality is vital. The worse the credit quality, the greater the risk of default and therefore investment loss.

Derivatives risk: The use of derivatives could increase overall risk by magnifying the effect of both gains and losses in a Fund. As such, large changes in value and potentially large financial losses could result.

Interest rate risk: The value of fixed income investments (e.g. bonds) tends to be inversely related to interest and inflation rates. Hence their value decreases when interest rates and/or inflation rises.

% Property risk: Investments in real estate securities can carry the same risks as investing directly in real estate itself. Real estate prices move in response to a variety of factors, including local, regional and national economic and political conditions, interest rates and tax considerations.

Transaction Costs (TC) is the percentage of the value of the Fund incurred as costs relating to the buying and selling of the Fund's underlying assets. Transaction cost is a necessary cost in administering the Fund and impacts Fund returns. It should not be considered in isolation as returns may be impacted by many other factors over time including market returns, the type of Fund, investment decisions of the investment manager and the TER.

Where a current yield has been included for Funds that derive its income primarily from interest bearing income, the yield is a weighted average yield of all underlying interest bearing instruments as at the last day of the month. This yield is subject to change as market rates and underlying investments change.
