INVESTMENT OBJECTIVE

The aim is to maximise investor total return over the long term through a focused portfolio of high quality JSE listed equity securities.

The Fund has adhered to its policy objective.

FUND FEATURES

A concentrated equity-only portfolio that may invest across all sectors of the ISE. The portfolio will hold between 20 - 30 companies.

FUND COMMENTARY

August marked a resilient performance for the South African equity market, with the FTSE/JSE All Share Index maintaining levels above the historic 100,000-point milestone reached earlier in the year. Investor sentiment remained broadly positive, supported by strong earnings across key sectors such as mining, banking, and technology. Complementing the equity market's strength, the South African Rand appreciated by $\pm 3.0\%$ against the US Dollar in August.

Tencent posted an impressive quarterly update to 30 June 2025. Revenue grew +15%, driven by strong performances in gaming and advertising. Gross profit rose +22% as higher-margin segments continued to outperform, although net earnings per share (non-IFRS) growth was a more measured +13%, reflecting increased marketing investment and lower associate contributions, notably from Pinduoduo. Prosus provided investors with an update on the Just Eat Takeaway (JET) acquisition with clearance from the European Commission now secured. The approval requires Prosus to reduce its Delivery Hero stake within 12 months, with deal closure expected in October. Prosus' first-quarter update noted revenue growth of 15% with adjusted EBITDA growing +54% YoY, at the top end of their target range.

Standard Bank delivered 1H25 diluted HEPS growth of +10%, supported by share buybacks, and resilient trading income. Management reaffirmed a strong FY25 outlook, guiding to mid-to-high single-digit revenue growth and reiterating their medium-term target of an 18–22% Return on Equity (ROE). African operations remain a key differentiator to peers, with contributions expected to lift group ROE to around 20% over the medium term. Notably, trading income for the group continues to stand out, now exceeding the combined total of Absa, Nedbank, and FirstRand.

In a trading update released for FY25, Shoprite guided for group sales growth of +9%, with Checkers once again the standout performer, delivering +14% sales growth. Shoprite and Usave growth moderated, but online platform Sixty60 maintained strong momentum, expanding

Capitec issued a trading update highlighting continued broad-based strength across its operations, guided for 1H26 HEPS growth of between +22% to +27%, ahead of market expectations.
