

Fund Objective

The fund will, apart from assets in liquid form, consist solely of participatory interest in the approved, Sigma Select Global Leaders Fund under the Prescient Global Funds ICAV, an open ended umbrella fund with segregated liability between funds, domiciled in Ireland.

The investment objective of the underlying fund is to outperform the Benchmark, as measured by the MSCI ACWI, over the long term. The underlying fund will seek to achieve its objective primarily through investing of up to 100% of its net assets in global equities which are listed or traded on Recognised Exchanges, or subject to the investment restrictions set out in the supplement.

Fund Strategy

The Fund capital is allocated to a carefully considered blend of independently managed global and specialist equity strategies.

The Fund is constructed by optimally blending the various manager styles and strategies to achieve the return target over the long-term.

A rigorous investment process underpins the identification and selection of managers according to their key strengths and specialisation.

These managers include the best active stock-pickers that the fund manager has encountered globally and they all have long term track-records of successfully generating superior returns for their investors.

Each manager is constantly assessed relative to their appropriate benchmarks and must consistently comply with the fund manager's stringent due diligence criteria.

The Fund exposure is constantly monitored and reviewed, and may be adjusted from time to time, having regard to the prevailing market conditions.

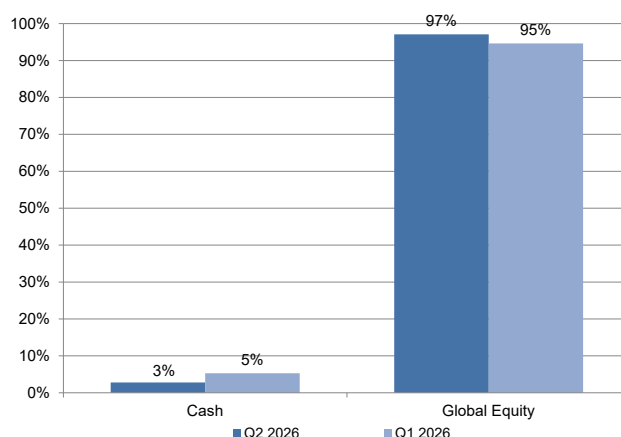

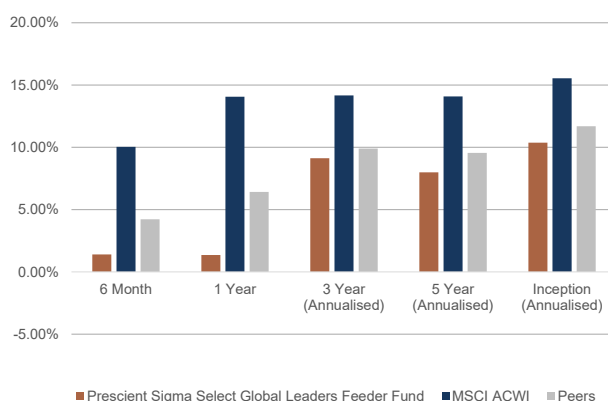


Illustration showing growth of R1,000 invested at date of inception ¹

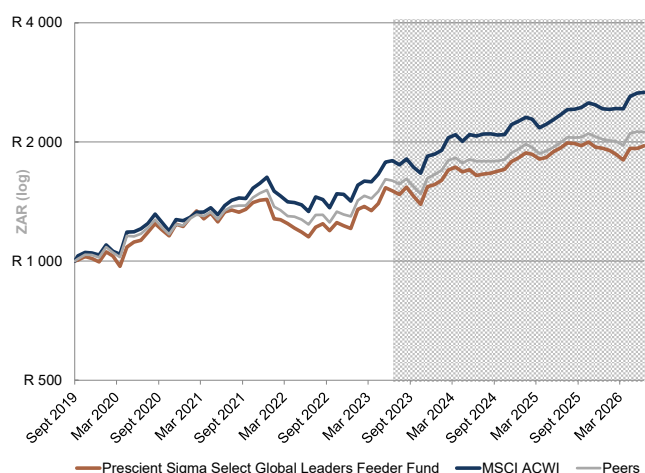
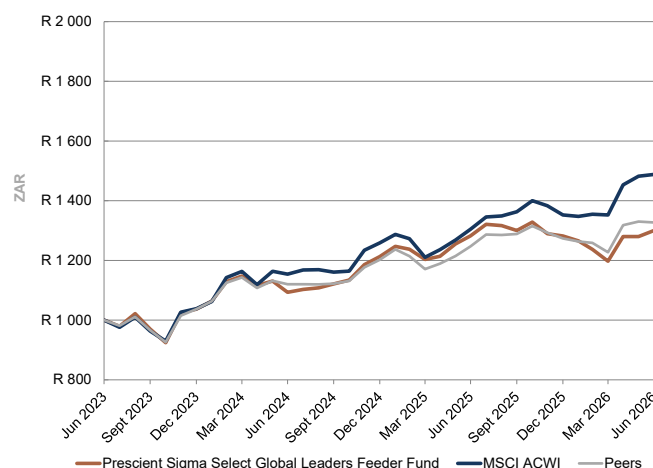


Illustration showing growth of R1,000 invested 3 years ago

Quarterly Commentary - Q2 2026

Global equity markets rebounded sharply in the second quarter of 2026, recovering the ground lost during the first quarter as the energy shock that had unsettled markets earlier in the year rapidly unwound. A ceasefire between the United States and Iran on the 17th of June reopened the Strait of Hormuz, easing the geopolitical risk premium that had weighed on sentiment. The MSCI ACWI rose +14.9% in US\$ over the quarter, taking the year-to-date return to +11.3%.

Market leadership remained relatively narrow and concentrated. The rally was led by artificial intelligence hardware companies, with the strongest gains coming from semiconductors, memory and power infrastructure rather than software. Emerging markets and Japan led the regional rankings, with the MSCI Emerging Markets Index up +24.2% and the Nikkei 225 up +34.5%, over the quarter, all in US\$

The Sigma Select Global Leaders Fund returned +13.2% over the quarter, modestly trailing the MSCI ACWI by -1.7%. In a market propelled by a handful of the largest technology names, the Fund's diversified, valuation-aware positioning lagged the concentrated benchmark marginally, even though several of the underlying managers delivered strong absolute gains.

The Lyrical US Value Equity Fund (+25.0%), Contrarius Global Equity Fund (+21.9%), Sands Capital Global Growth Fund (+22.0%) and Orbis Global Equity Fund (+19.8%) were the standout contributors, with the latter two benefiting from value-oriented semiconductor and memory holdings including Samsung Electronics, SK Hynix and Taiwan Semiconductor Manufacturing Company.

Conversely, the Lindsell Train Global Equity Fund (+2.5%) and Prusik Asian Equity Income Fund (+4.5%) were the most significant detractors. Both hold high-quality, cash-generative businesses with little exposure to the semiconductor rally that dominated the quarter, leaving them well behind a narrowly led market.

During the quarter the Fund introduced the Lansdowne Developed Markets Long Only Fund, a high-conviction, concentrated strategy whose flexible, research-driven approach and holdings in quality businesses across the artificial intelligence supply chain, banks and airlines complement the existing manager line-up.

The concentration that has come to define global equity markets, while uncomfortable for relative performance in recent years, is creating an increasingly attractive environment for our active managers. Outside the handful of mega-caps that are priced for perfection, they continue to find quality businesses trading at meaningful discounts, with attractive growth prospects and far less embedded expectations.

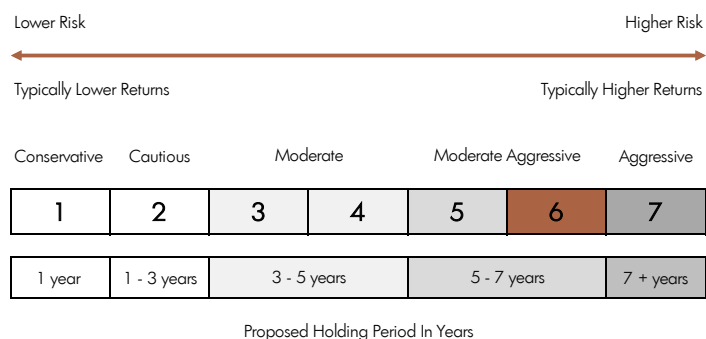
The largest index names, by contrast, are now displaying extreme volatility on any disappointment. Our managers hold selected mega-caps where the fundamental case is compelling, but their exposure is measured and research-driven rather than an indiscriminate ownership of the entire complex.

Going into the second half of 2026, the Fund retains its regionally diversified construction and continued underweight to expensive US large caps. This positioning should allow it to benefit as market leadership broadens and valuation dislocations narrow over the medium to longer term

Fund Specific Risks

In addition to the risk captured by the indicator above, the overall Fund value may be considerably affected by:

- **Default risk:** The risk that the issuers of fixed income instruments (e.g. bonds) may not be able to meet interest payments nor repay the money they have borrowed. The issuers credit quality is vital. The worse the credit quality, the greater the risk of default and therefore investment loss.

Glossary Summary

Annualised Performance: Annualised performance shows longer term performance rescaled to a 1-year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest and Lowest return: The highest and lowest returns for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Sharpe Ratio: The Sharpe Ratio is used to indicate the excess return the portfolio delivers over the risk-free rate per unit of risk adopted by the fund.

Standard Deviation: The deviation of the return stream relative to its own average.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

Max Gain: Largest increase in any single month.

%Positive Month: The percentage of months since inception where the fund has delivered positive return.

Volatility: Volatility is a statistical measure of the dispersion of returns for a given security or market index.

Feeder Fund: A Feeder Fund is a portfolio that invests in a single portfolio of a collective investment scheme which levies its own charges, and which could result in a higher fee structure for the feeder fund.
