



Investment Objective

The Fairtree Global Emerging Markets Prescient Feeder Fund is an actively managed global equity fund. The objective of the fund is to offer long term capital growth by investing in emerging equity markets or in companies that derive a significant portion of their revenue in emerging economies. The portfolio is constructed in a diversified manner and aims to provide returns above the index.

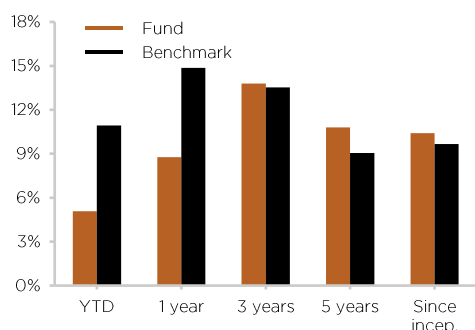
Investment Policy

The objective of the Fairtree Global Emerging Markets Prescient Feeder Fund is to provide investors with long term capital growth by investing primarily in large and mid-cap stocks within emerging equity markets, or in companies that derive a significant portion of their revenue, profits or asset base from emerging economies. Our investment philosophy is to buy quality companies, that are growing earnings, at attractive valuations below intrinsic value. In order to achieve this objective, the portfolio uses a quantitative screening process, based on various factors, to identify the most attractive opportunities. Fundamental research is then performed to determine the inclusion and sizing of positions.

RISK INDICATOR

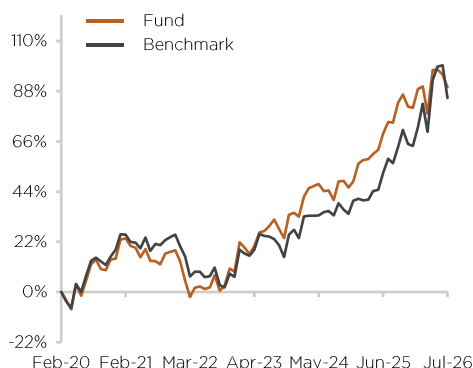


ANNUALISED PERFORMANCE (%)

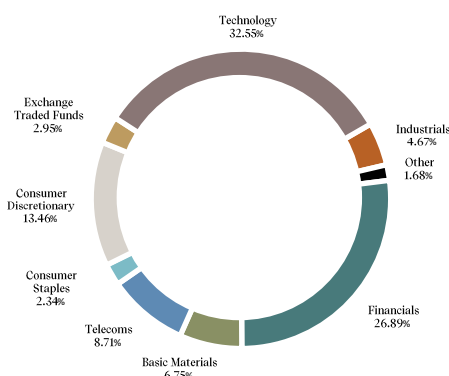

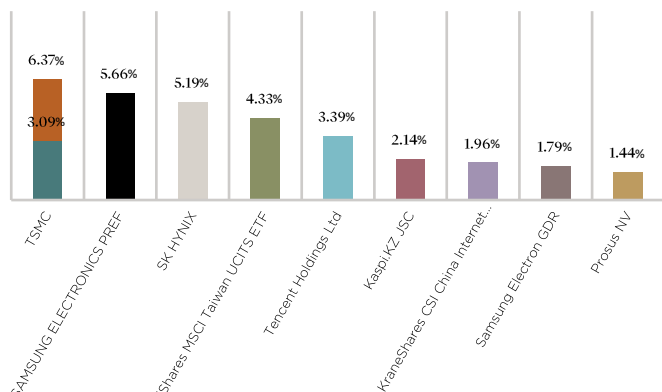

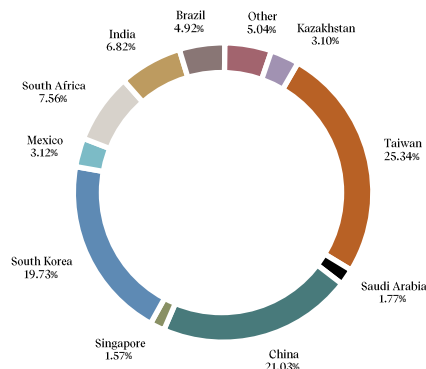

MARKET COMMENTARY

The fund returned -2.75% in ZAR, outperforming the benchmark by 4.41%. The MSCI Emerging Market Index decreased 7.16% in ZAR and 3.07% in USD, while the MSCI ACWI Index gained 0.08%. Within emerging markets, Indonesia and China were the standout performers, advancing 9.4% and 9.0% respectively. South Korea and Taiwan were the main detractors, declining 22.2% and 5.4% (all figures in USD).

Geopolitics returned to the fore as oil prices surged, with Brent crude rising 23.6% after the United States launched strikes on Iran and revoked a sanctions waiver amid renewed tensions in the Strait of Hormuz. Looking ahead, global equity markets enter August balancing robust corporate earnings, underpinned by heavy artificial intelligence spending, against a higher-for-longer policy rate environment, shifting geopolitical energy risks and a broadening rotation out of the most crowded technology names into value and more defensive parts of the market.

Emerging markets declined in July, with the MSCI Emerging Markets Index falling 3.1%, as the sharp correction across the semiconductor complex weighed heavily on the region's largest index constituents. Performance diverged markedly on a country level. South Korea, which had led the emerging market rally for much of the year, was by far the weakest market, collapsing 22.2% as Samsung and SK Hynix reversed sharply despite robust earnings, while Taiwan fell 5.4% as TSMC and the broader chip supply chain were caught in the same profit-taking. In contrast, markets with little semiconductor exposure rebounded strongly. Indonesia was the standout performer, rising 9.4% as sentiment steadied, the rupiah firmed, and Bank Indonesia introduced measures to attract inflows and support growth. China gained 9.0% on renewed policy optimism ahead of the July Politburo meeting, which raised hopes of stronger easing and accelerated fiscal support, alongside a rebound in its technology and semiconductor shares. Brazil advanced 6.4%, helped by a firmer real and growing expectations of interest rate cuts.

On a sector level, Financials was the best-performing sector in the benchmark over the month, where the fund's overweight position and stock selection contributed to relative performance. The fund's substantial underweight to Information Technology was the largest relative contributor, as the sector saw a sell-off across the memory and semiconductor names. The overweight to Consumer Discretionary was a meaningful contributor, while the underweight positions in Energy and Health Care were modest detractors from relative performance.

On a country level, the portfolio's underweight to South Korea was the largest single contributor to relative performance. Stock selection in Taiwan detracted modestly, and the underweight to China was a small drag as that market rallied. Samsung and SK Hynix together account for approximately 65% of the MSCI Korea Index and around 13% of the MSCI EM Index, while TSMC represents around 58% of the MSCI Taiwan Index and approximately 15.5% of the MSCI EM Index. The portfolio maintains a maximum regulatory position limit of 10% per stock, resulting in an unavoidable underweight to these names, which had weighed on relative performance for much of the year but worked firmly in the fund's favour in July as the shares reversed. Even after this correction, Samsung, SK Hynix and TSMC still account for close to 30% of the MSCI EM Index, underscoring how concentrated the benchmark remains in just a few stocks.

Notable portfolio actions during July included using the sell-off to add to the fund's core semiconductor and China exposure. Within semiconductors and AI hardware, the fund added to SK Hynix, TSMC and Auras Technology. It increased its China exposure through the KraneShares CSI China Internet ETF and CATL. New positions were initiated in Mahindra & Mahindra and Kalyan Jewellers, broadening the portfolio's exposure to India, while other additions included Sasol and AI Rajhi Bank. The fund fully exited FirstRand and trimmed Nu Holdings, reducing exposure where the risk-reward or portfolio fit had become less compelling.

Notable contributors to fund performance were positions in JD.com (+46bps absolute and +39bps relative), Kalyan Jewellers (+32bps absolute and +32bps relative) and Tencent (+32bps absolute and +2bps relative). Notable detractors from performance over the month came from SK Hynix (-353bps absolute and +114bps relative), Samsung (-77bps absolute and +49bps relative) and iShares MSCI Taiwan UCITS ETF (-58bps absolute and relative).

The fund does not currently have significant relative (>4%) country positions at the moment. We remain overweight South Africa, Brazil and Kazakhstan and have modest underweight positions in Taiwan, Korea, India and China.



Glossary

Annualised Performance: Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest Performance: The highest and lowest performance for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Current Yield: Annual income (interest or dividends) divided by the current price of the security.

Alpha: Denotes the outperformance of the fund over the benchmark.

Sharpe Ratio: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

Sortino Ratio: A measure of the risk-adjusted return of a portfolio. It is a modification of the Sharpe ratio but only penalises the returns falling below a user specified target, or required rate of return, while the Sharpe ratio penalises both upside and downside volatility equally.

Standard Deviation: The deviation of the return stream relative to its own average.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

Max Gain: Largest increase in any single month.

% Positive Month: The percentage of months since inception where the Fund has delivered positive return.

Specific Risk

Default Risk: The risk that the issuers of fixed income instruments may not be able to meet interest payments nor repay the money they have borrowed. The issuers credit quality is vital. The worse the credit quality, the greater the risk of default and therefore investment loss.
