

# PRESCIENT DEFENSIVE FUND (A1)

## MINIMUM DISCLOSURE DOCUMENT

### INVESTMENT AND RETURN OBJECTIVE

The Fund aims to achieve healthy real returns over the long term and to outperform the ASISA category average of the South African - Multi-Asset - Low Equity funds over a full market cycle by maintaining moderate exposure to growth assets like equities.

### INVESTMENT PROCESS

This Fund invests in local and offshore money market, bonds and inflation-linked bonds, property, preference and ordinary shares, derivatives and unlisted instruments to meet the investment objectives. Fund performance can be generated from taking interest rate views or duration, yield enhancement via credit instruments, asset allocation and exposure equities.

### WHO SHOULD INVEST

Investors seeking real returns coupled with a stable and attractive income yield via significant exposure to the South African interest bearing markets. Although the Fund's mandate allows investment up to 40% in equities, it is expected to have lower actual exposure on average. This Fund is suitable to investors with a medium to long-term investment horizon and is Regulation 28 compliant.


### RISK INDICATOR DEFINITION

These portfolios typically have moderate equity exposure or in the case of bond funds, longer duration bond exposure, resulting in some capital volatility over the shorter term. They are managed in such a manner that the probability of capital losses over one year periods is unlikely. These portfolios typically target returns in the region of 3% - 4% above inflation over the long term.

## RISK INDICATOR




ANNUALISED PERFORMANCE (%)



## FUND COMMENTARY

In the United States, Federal Reserve Chair Jerome Powell held interest rates steady at between 3.5% and 3.75% at the Fed's first policy decision of 2026, a widely anticipated outcome and a reaffirmation of the Fed's independence. Powell's term is due to end in May, and President Donald Trump has recently announced his successor. Trump has repeatedly criticised Powell and the Fed for not cutting rates more aggressively and has suggested that the next chair will pursue a looser monetary stance.

In early January, South Africa was removed from the EU's list of high-risk Third-Country Jurisdictions, following its removal from the Financial Action Task Force (FATF) grey list last year. In a statement, the EU acknowledged the efforts of South Africa and five other African countries to strengthen their anti-money laundering and counter-terrorism financing (AML/CFT) frameworks.

Turning to economic growth, National Treasury expects South Africa's GDP growth to rise modestly to 1.5%. This remains well below the level required to meaningfully expand the economy or make a meaningful dent in the unemployment crisis. Toward the end of January, the South African Reserve Bank (SARB) adopted a cautious stance at its first Monetary Policy Committee (MPC) meeting of 2026, opting to keep the repo rate unchanged at 6.75%, despite a stronger rand and a benign inflation outlook. The decision was split, with two members voting for a 25-basis-point cut and four voting to hold rates steady.

Despite South African government bonds delivering returns of nearly 25% in 2025, a repeat performance appears unlikely in the year ahead. The rally reflected a structural recalibration of the yield curve toward a lower inflation equilibrium. Importantly, it was not the announcement of the lower target itself that drove yields lower, but rather the SARB's global credibility, which restored investor confidence and attracted renewed demand for government bonds.

Over the past month developed market equity returned +2.42%, emerging market equity +8.81% while US Treasuries were relatively flat. In South Africa the Top40 index returned +3.98%, SA bonds +1.95% and ILB's +1.33%, while the Rand ended the month +2.54% stronger at 16.14 to the Dollar.

Fund performance was positive for the month, mainly due to strong positive performance from local bonds and offshore equity.

The Fund currently holds a moderately negative view towards South African and developed market equity as well as local bonds. Our view on the rand has changed to neutral.

## GLOSSARY

**Annualised performance:** Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

**Highest & Lowest performance:** The highest and lowest performance for any 1 year over the period since inception have been shown.

**NAV:** The net asset value represents the assets of a Fund less its liabilities.

**Current Yield:** Annual income (interest or dividends) divided by the current price of the security.

**CPU:** Cents Per Unit to the Glossary

**Sharpe Ratio:** The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

**Max Drawdown:** The maximum peak to trough loss suffered by the Fund since inception.

**% Positive Month:** The percentage of months since inception where the Fund has delivered positive return.

## Fund Specific Risks

**Default Risk:** The risk that the issuers of fixed income instruments may not be able to meet interest payments nor repay the money they have borrowed. The issuers credit quality is vital. The worse the credit quality, the greater the risk of default and therefore investment loss.
