INVESTMENT AND RETURN OBJECTIVE

The Fund aims to return CPI + 3% per annum through a full interest rate cycle while providing stability by aiming never to lose capital over any rolling 3 month period.

INVESTMENT PROCESS

This Fund invests in local and offshore money market, bonds, inflation-linked bonds, preference shares, local only listed property and derivatives to meet the investment objectives. Fund performance can be generated from taking interest rate views, yield enhancement via credit instruments, asset allocation between income producing asset classes and also via the use of derivatives.

WHO SHOULD INVEST

Investors seeking stable real returns and aiming to maximise income via exposure to primarily the South African Money and Bond markets. This Fund is suitable to medical aid schemes where investments need to comply with Regulation 30 of the Medical Schemes Act.

RISK INDICATOR DEFINITION

These portfolios typically have no or low equity exposure, resulting in higher interest yields and stable capital values with the probability of capital losses over the shorter term (3 months) highly unlikely. These portfolios typically target returns in the region of 1% – 3% above inflation before tax over the long term.

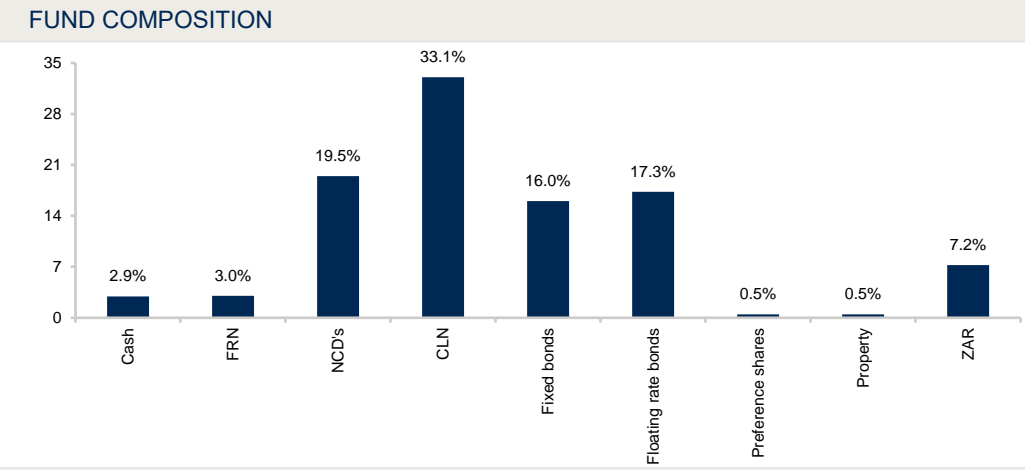

FUND COMMENTARY

South African fixed-income markets ended 2025 on a constructive note, supported by an improving inflation outlook and the South African Reserve Bank’s initial steps toward policy normalisation. Following its 25 basis point cut in November, which reduced the repo rate to 6.75%, the SARB maintained a cautiously accommodative stance in December, reiterating that inflation is trending toward the midpoint of its newly adopted 3% ± 1pp target band. The Committee noted that risks to inflation have moderated amid subdued domestic demand and a more favourable global disinflation environment. Local bonds remained well supported into year-end, with longer-dated maturities benefiting from stabilising fiscal sentiment and continued foreign demand for South Africa’s elevated real yields. The rand traded in a relatively narrow range, underpinned by lower global yields and resilient emerging-market flows.

Globally, markets closed the year increasingly confident that the US Federal Reserve is moving along a gradual, data-dependent easing path. Softer inflation outcomes and signs of cooling in the US labour market reinforced expectations for further policy normalisation in early 2026. US Treasury yields declined modestly over the month, led by the front end, while credit markets remained resilient: investment-grade spreads were stable near cycle lows and high-yield sentiment improved as volatility subsided.

For South Africa, the combination of moderating inflation, improving real policy rates, and a supportive global backdrop continues to provide a favourable environment for fixed-income assets heading into 2026. Within the Fund, we maintained a preference for floating-rate exposure in the short- to medium-dated segments of the curve, where attractive carry and lower duration risk support portfolio stability. With credit spreads tight, we remain focused on quality and liquidity. Overall positioning remains balanced — prioritising stable income generation, capital preservation, and flexibility to selectively add risk as opportunities emerge.

The Fund’s forward yield remains attractive at 8.52%. The Fund has a total duration (including ILBs) of 0.97 years. The current risk profile aligns with the Fund’s risk objective, and we believe the Fund is well positioned to achieve its return objectives.

The Fund delivered a positive performance in December. Key contributors were the good yielding assets in the portfolio and our preferred duration bond, the R2032. The only notable detractor for the month being our USD exposure.

GLOSSARY

Annualised performance: Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest performance: The highest and lowest performance for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Current Yield: Annual income (interest or dividends) divided by the current price of the security.

CPU: Cents Per Unit to the Glossary

Alpha: Denotes the outperformance of the fund over the benchmark.

Sharpe Ratio: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

Standard Deviation: The deviation of the return stream relative to its own average.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

Max Gain: Largest increase in any single month.

% Positive Month: The percentage of months since inception where the Fund has delivered positive return.

Average Duration: The weighted average duration of all the underlying interest bearing instruments in the Fund.

Forward Yield: The Forward Yield is the expected combined income of the instruments in the portfolio over the next year expressed as a percentage of the current value of those instruments.

Fund Specific Risks

Default Risk: The risk that the issuers of fixed income instruments may not be able to meet interest payments nor repay the money they have borrowed. The issuers credit quality is vital. The worse the credit quality, the greater the risk of default and therefore investment loss.

Derivatives risk: The use of derivatives could increase overall risk by magnifying the effect of both gains and losses in a Fund. As such, large changes in value and potentially large financial losses could result.

Interest rate risk: The value of fixed income investments (e.g. bonds) tends to be inversely related to interest and inflation rates. Hence their value decreases when interest rates and/or inflation rises.

Derivative counterparty risk: A counterparty to a derivative transaction may experience a breakdown in meeting its obligations thereby leading to financial loss.

Liquidity risk: If there are insufficient buyers or sellers of particular investments, the result may lead to delays in trading and being able to make settlements, and/or large fluctuations in value. This may lead to larger financial losses than expected.
