Investment Objective

The Fairtree Global Emerging Markets Prescient Fund is an actively managed global equity fund. The objective of the fund is to offer long term capital growth by investing in emerging equity markets or in companies that derive a significant portion of their revenue in emerging economies. The portfolio is constructed in a diversified manner and aims to provide returns above the index.


Investment Policy

The objective of the Fairtree Global Emerging Markets Prescient Fund is to provide investors with long term capital growth by investing primarily in large and mid-cap stocks within emerging equity markets, or in companies that derive a significant portion of their revenue, profits or asset base from emerging economies. Our investment philosophy is to buy quality companies, that are growing earnings, at attractive valuations below intrinsic value. In order to achieve this objective, the portfolio uses a quantitative screening process, based on various factors, to identify the most attractive opportunities. Fundamental research is then performed to determine the inclusion and sizing of positions.



MARKET COMMENTARY

The fund returned 1,13% for the month, outperforming the benchmark by 0,72%. The MSCI ACWI Index returned 5.75%, with the biggest gainers, the Netherlands and the US, increasing 8.7% and 6.4% respectively. The MSCI Emerging Markets Index increased by 4.3%, driven by Taiwan and Indonesia, increasing 12.5% and 10.6% respectively (all in USD).

US equities rose by 6.4% in May, continuing their recovery post the volatility seen in April. The rally was supported by solid corporate earnings, easing trade tensions, and expectations of tariff relief. US real GDP contracted by an annualised 0.3% in Q1, largely driven by a surge in imports ahead of anticipated tariffs and reduced government spending. The US unemployment rate held steady at 4.2% in April, while inflation eased slightly to 2.3% from 2.4% in the previous month. The Federal Reserve kept its benchmark interest rate unchanged at 4.25% - 4.5%, citing heightened economic uncertainty and the potential impact of upcoming tariffs. European equities extended their momentum in May, rising 4.56%, supported by the ECB's eighth rate cut since June 2024, which lowered rates by 25 basis points to 2% in an attempt to stimulate eurozone growth. Markets were buoyed by strong performances in the Netherlands and Germany, which gained 8.7% and 5.7% respectively. Sentiments were lifted by Germany's proposed €46 billion corporate tax relief package, easing trade tensions, a decline in eurozone inflation to 1.9%, solid corporate earnings, and renewed investor interest in undervalued European stocks. In Emerging Markets, Taiwan's market surged 12.5%, driven by booming Al-related semiconductor demand, easing US-China trade tensions, and strong foreign capital inflows. Indonesia's market rose 10.6%, driven by renewed foreign inflows, strong institutional support, easing trade tensions, and solid economic fundamentals. South Korea also advanced 7.9%, propelled by semiconductor demand, corporate reform momentum, and increased foreign investor interest.

On a sector level, Consumer Discretionary and Consumer Staples were the worst-performing sectors over the month, while Information Technology and Industrials were the best-performing sectors. The fund's overweight holding in Consumer Discretionary and underweight in Information Technology detracted from relative performance, while stock picking in the Materials and Utilities sector added to relative performance. Notable portfolio actions during the month included initiating positions in South African precious metals and mining companies, Gold Fields, African Rainbow Minerals, Northam and Impala Platinum, supported by record-high gold prices and stabilising demand for PGMs. The existing position in Naspers was partially switched to Tencent, while Alibaba was trimmed. The holdings in Bosideng, HCL Technologies and Giant Biogene were sold.

Notable contributors to fund performance were positions in TSMC (+77bps absolute and -14bps relative), Samsung E&A (+22bps absolute and relative) and Wiwynn (+18bps absolute and +15bps relative). Notable detractors from performance over the month came from Kaspi (-57bps absolute and relative), Alibaba (-34bps absolute and -13bps relative) and Pinduoduo (-26bps absolute and -16bps relative). Alibaba reported a reasonable set of results; however, it missed consensus expectations, while capital intensity increased as management invested in the cloud and Al infrastructure segment.

The fund is positioned with a large relative overweight in South Korea, Kazakhstan, and South Africa, where we continue to find compelling opportunities, particularly in South Korea and South Africa. Conversely, the fund remains underweight India, China, and Taiwan, with India and Taiwan continuing to trade at elevated valuations relative to their histories and broader emerging market peers.

Max Gain: Largest increase in any single month.

% Positive Month: The percentage of months since inception where the Fund has delivered positive return.

Specific Risk
