## MINIMUM DISCLOSURE DOCUMENT

### INVESTMENT AND RETURN OBJECTIVE

The Fund aims to achieve significant real returns over the long term and to outperform the average South African balanced unit trust fund over a full market cycle by maintaining meaningful exposure to growth assets like equities.

### INVESTMENT PROCESS

The Fund invests in equities and interest bearing assets domestically and overseas. The allocation to the underlying asset classes will typically remain fixed at the benchmark weights but can be varied tactically from time to time to capitalise on perceived mispricing in the market. The exposure to the underlying asset classes will be managed on an enhanced indexation basis where possible, utilising Portable Alpha techniques to deliver consistent and predictable outperformance of the respective asset class benchmarks.

### WHO SHOULD INVEST

Investors seeking significant real returns over the long term but who are cost conscious. The Fund is suitable for investors with a medium to long-term investment horizon and is Regulation 28 compliant.

### RISK INDICATOR DEFINITION

These portfolios typically exhibit more volatility and potential for capital losses due to higher exposure to equities and exposure to offshore markets where currency fluctuations may result in capital losses. These portfolios typically target returns in the region of 5% - 6% above inflation over the long term.

## FUND COMMENTARY

In February, local fiscal policy came under the spotlight as Minister Mboweni delivered his maiden budget speech in parliament. While it was generally considered a credible budget by the market, Mr Mboweni's speech highlighted structural impediments to growth that continue to plague South Africa. We saw more fiscal slippage with the main budget deficit forecast at 4.7% (from 4.4% in the MTBPS) for FY19/20, but expect it to compress marginally over the medium term expenditure framework. Eskom received a R69bn injection over the next three years (R23bn per year) – the main culprit for wider deficits. This was somewhat offset by underspending of around R50.3bn elsewhere over the medium term, with compensation budgets cut by R27bn over the next three years (despite the elevated multi-year wage settlement in 2018) and the goods and services budgets of selected entities cut by 1%. The budget is clearly negative from a credit rating perspective, but it is unclear at this stage whether the deterioration will be sufficient to tilt the odds towards a downgrade by Moody's.

### Contributors to performance:

Local equities once again contributed positively as trade tension between the US and China showed signs of receding. Furthermore, a weaker rand led to a positive contribution from the Fund's offshore component.

### Detractors from performance:

Local bonds and bond proxies such as local property, detracted from performance on the back of rand weakness. The weaker rand was mainly a reflection of South Africa's worsening fiscal metrics, which was revealed during the budget speech.

## GLOSSARY

**Annualised performance:** Annualised performance show longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

**Highest & Lowest performance:** The highest and lowest performance for any 1 year over the period since inception have been shown.

**NAV:** The net asset value represents the assets of a Fund less its liabilities.

**Current Yield:** Annual income (interest or dividends) divided by the current price of the security.

**CPU:** Cents Per Unit to the Glossary

**Alpha:** Denoted the outperformance of the fund over the benchmark.

**Sharpe Ratio:** The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

**Standard Deviation:** The deviation of the return stream relative to its own average.

**Max Drawdown:** The maximum peak to trough loss suffered by the Fund since inception.

**% Positive Month:** The percentage of months since inception where the Fund has delivered positive return.

## Fund Specific Risks

**Default Risk:** The risk that the issuers of fixed income instruments may not be able to meet interest payments nor repay the money they have borrowed. The issuers credit quality is vital. The worse the credit quality, the greater the risk of default and therefore investment loss.
