### INVESTMENT AND RETURN OBJECTIVE

The Fund aims to outperform the FTSE/JSE Africa Top 40 index. Tracking error to the index is minimised in the process.

The Fund is an equity index fund where returns are enhanced by taking advantage of low risk arbitrage opportunities in the market. Additional benefits are gained from efficient implementation of cash flows, dividend reinvestments, management of corporate actions, use of future discounts and index rebalancing. The Fund aims to remain fully invested in equities at all times.

### WHO SHOULD INVEST

Investors seeking broad based exposure to the large capitalisation sector of the South African equity market. This Fund is appropriate for investors with a long-term investment horizon.

## FUND COMMENTARY

The positive momentum in global equity markets extended into February, although performance was more uneven across regions and sectors as investors digested shifting expectations around monetary policy and growth. While the broader risk-on backdrop remained intact, market leadership rotated meaningfully during the month, reflecting a continued broadening of participation beyond the dominant technology segment. The MSCI World Index finished February up 0.73%, taking year-to-date returns to 2.99%.

In the United States, equity markets paused following the strong start to the year. The S&P 500 declined 0.76% for the month, as some profit-taking emerged within the technology complex following an extended period of outperformance. Investors remained focused on the trajectory of inflation and the timing of potential policy easing, with stronger-than-expected economic data reinforcing the view that interest rates may remain elevated for longer than previously anticipated.

European equities delivered a more constructive outcome. The Euro Stoxx Index rose 3.00% in February, extending its strong start to the year. Performance was supported by improving economic sentiment, stabilising inflation dynamics and continued resilience in corporate earnings. Cyclical sectors benefited from the improved outlook, contributing to the region's relative outperformance.

Japan remained one of the strongest performing developed markets. The Nikkei 225 surged 9.23% during the month, reflecting robust corporate earnings momentum, continued corporate governance reforms and sustained foreign investor inflows. Currency dynamics and improving domestic demand conditions also supported the market's strong performance.

Emerging markets delivered solid gains overall. The MSCI Emerging Markets Index advanced 5.50% in February, materially outperforming developed market peers. Strength was broad-based across several commodity-linked and Asian markets. Within China, the CSI 300 Index rose 1.42% as targeted policy support and improved investor sentiment continued to stabilise the domestic equity market.

Locally, South African equities delivered a strong month. The FTSE/JSE All Share Index climbed 7.01%, with performance driven largely by resource-linked companies amid a sharp rebound in commodity prices. Basic materials were the standout sector, surging 13.42% for the month and extending their year-to-date gains to 27.80%. Financials also delivered solid returns, rising 7.32%, supported by improving investor sentiment and robust earnings expectations. In contrast, the technology sector declined 10.63%, reflecting ongoing volatility within global technology shares.

Currency dynamics provided an additional tailwind for local assets. The rand strengthened by 1.30% against the US dollar during February, continuing the firm tone seen earlier in the year as improved global risk appetite and stronger commodity prices supported emerging market currencies.

Overall, February reinforced the theme of widening market participation across both regions and sectors. While macroeconomic uncertainty remains present, the combination of resilient economic activity, stabilising inflation trends and supportive policy expectations continues to provide a constructive backdrop for global risk assets.

The top contributors to the Fund's performance for the month were Anglogold Ashanti Plc (30.33%), Valterra Platinum Ltd (22.66%) and Gold Fields Ltd (9.27%). Detractors included Naspers Ltd (-10.71%), Prosus NV (-11.63%) and Sibanye Stillwater Ltd (-5.12%).

## GLOSSARY

**Annualised performance:** Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

**Highest & Lowest performance:** The highest and lowest performance for any 1 year over the period since inception have been shown.

**NAV:** The net asset value represents the assets of a Fund less its liabilities.

**Current Yield:** Annual income (interest or dividends) divided by the current price of the security.

**CPU:** Cents Per Unit to the Glossary

**Alpha:** Denotes the outperformance of the fund over the benchmark.

**Sharpe Ratio:** The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

**Standard Deviation:** The deviation of the return stream relative to its own average.

**Max Drawdown:** The maximum peak to trough loss suffered by the Fund since inception.

**Dividend Yield:** The weighted average dividend yield of all the underlying equity in the Fund. The dividend yield of each company is the dividends per share divided by the price.

**PE Ratio:** The weighted average price earnings ratio of all the underlying equity in the Fund. The price earnings ratio of each company is the price divided by the earnings per share.

## Fund Specific Risks

**Default Risk:** The risk that the issuers of fixed income instruments may not be able to meet interest payments nor repay the money they have borrowed. The issuers credit quality is vital. The worse the credit quality, the greater the risk of default and therefore investment loss.
