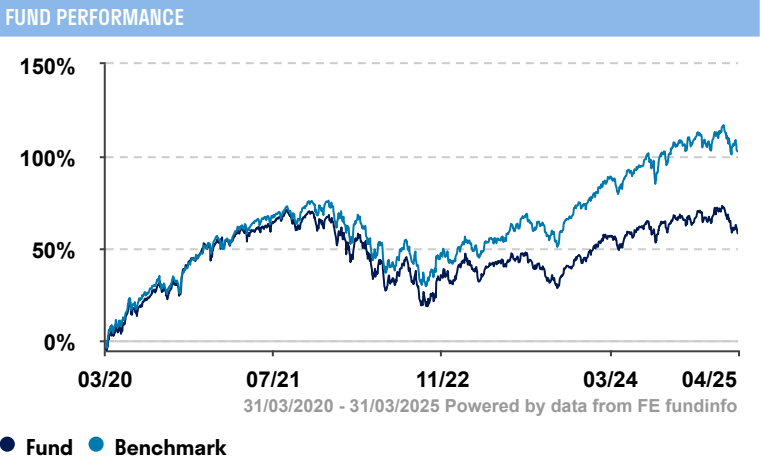

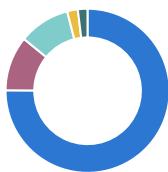

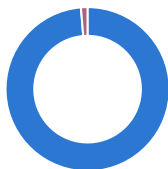
GEOGRAPHIC ALLOCATION (%)
