### INVESTMENT AND RETURN OBJECTIVE

The Fund aims to generate real returns in US Dollars and is benchmarked to the US inflation rate.

### INVESTMENT PROCESS

The investment universe includes fixed, floating, real and nominal money market and bond market investments, derivatives and global currencies. Fund performance can be generated from taking interest rate views or duration, yield enhancement via credit instruments, asset allocation between income producing asset classes, the use of derivatives and currency management.

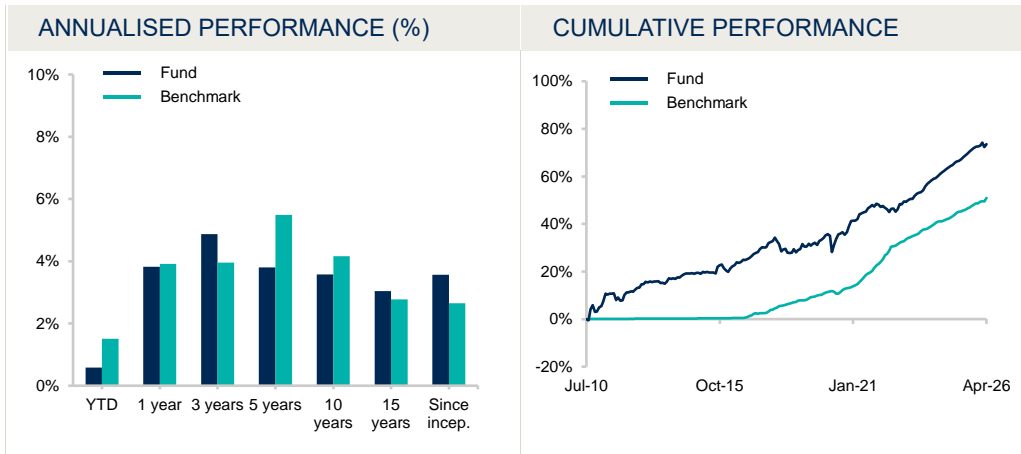
### WHO SHOULD INVEST

Investors seeking a hedge against any rand depreciation while gaining exposure to high yielding offshore assets that are not available locally in South Africa. Although this is a roll-up fund and does not distribute income, it is suitable to investors with a medium to long-term investment horizon who wishes to fund income withdrawals by redeeming units, due to the exposure to yield generating assets held in the Fund and therefore a lower probability of selling underlying units at inappropriate times such as in a market downturn.

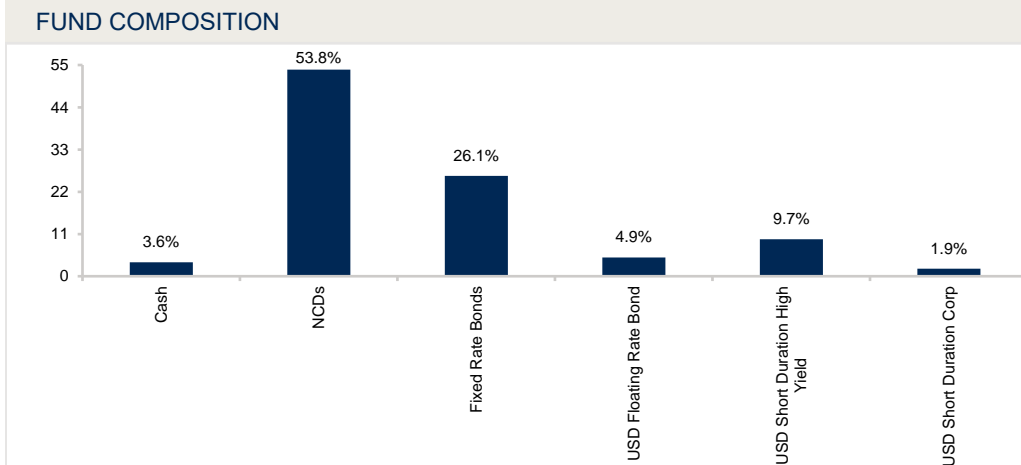
### RISK INDICATOR DEFINITION

This portfolio typically has no equity exposure, resulting in higher interest yields and stable capital values with the probability of capital losses in USD terms over the shorter term unlikely. This portfolio typically targets a return in the region of 1% – 3% above US inflation over the long term.

## FUND COMMENTARY

Global fixed-income markets stabilised in April after a more challenging March, although the environment remained complex as investors continued to weigh sticky inflation, mixed US growth signals, and elevated geopolitical risk. The broader disinflation trend remains intact, but recent data has reinforced its uneven pace, and markets continue to recalibrate the timing and trajectory of further central bank easing.

US Treasury yields traded in a relatively narrow range over April, with the 10-year ending modestly higher and the curve broadly unchanged from end-March levels, as easing oil prices through most of the month were partially offset by a late-month back-up on stalled US-Iran peace talks. The Federal Reserve held the funds rate steady at 3.50–3.75% at its 29 April meeting, but the decision was marked by an unusually divided 8-4 vote — the most dissent since 1992 — with members split between those favouring a near-term cut and those opposing the statement's continued easing bias. The meeting underscored the genuine uncertainty around the policy path, particularly with core inflation having ticked up to 3.2% and a leadership transition at the Fed approaching. Credit markets, by contrast, performed well: investment-grade spreads remained close to multi-decade tights and risk assets rallied, with all-in yields continuing to look attractive across high-quality income segments.

Against this backdrop, the Fund maintained a cautious and highly selective approach to risk. Portfolio positioning continues to emphasise high-quality income streams, with a focus on liquidity and capital preservation. Exposure to interest rate risk remains measured, reflecting the divided Fed, the Middle East overhang, and the potential for renewed volatility as the policy and political backdrop evolves.

The Fund continues to benefit from the broad opportunity set available in global income markets, including government bonds, investment-grade credit, and selected income-generating ETFs. With credit spreads near cycle tights, security selection has become increasingly important, and we remain disciplined in adding risk only where the income compensation is appropriate. Importantly, elevated starting yields continue to provide a strong foundation for forward returns, even in a more volatile environment.

Consistent with its objective of avoiding capital loss over rolling 12-month periods, the Fund remains positioned to navigate uncertain conditions while retaining the flexibility to allocate capital opportunistically as dislocations arise.

Overall positioning remains balanced, prioritising capital preservation, stable income generation, and the ability to capture opportunities as global rate cycles evolve through 2026.

The Fund's forward yield remains attractive at 4.84%, with an interest rate duration of 1.69 years. The portfolio's current risk profile aligns with the Fund's risk objective, and we believe the Fund is well positioned to achieve its return objectives.

The Fund delivered a positive return for April, with the rebound in global fixed-income markets supporting performance across the portfolio. The duration assets in the Fund, which had detracted in March, were among the largest contributors as US Treasury yields stabilised and credit spreads remained well anchored. The shorter-term Money Market assets again contributed positively, providing a stable income base through the month.

## GLOSSARY

**Annualised performance:** Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

**Highest & Lowest performance:** The highest and lowest performance for any 1 year over the period since inception have been shown.

**NAV:** The net asset value represents the assets of a Fund less its liabilities.

**Current Yield:** Annual income (interest or dividends) divided by the current price of the security.

**CPU:** Cents Per Unit to the Glossary

**Alpha:** Denotes the outperformance of the fund over the benchmark.

**Sharpe Ratio:** The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

**Standard Deviation:** The deviation of the return stream relative to its own average.

**Max Drawdown:** The maximum peak to trough loss suffered by the Fund since inception.

**Average Duration:** The weighted average duration of all the underlying interest bearing instruments in the Fund.

**Forward Yield:** The Forward Yield is the expected combined income of the instruments in the portfolio over the next year expressed as a percentage of the current value of those instruments.

## Fund Specific Risks

**Default Risk:** The risk that the issuers of fixed income instruments may not be able to meet interest payments nor repay the money they have borrowed. The issuers credit quality is vital. The worse the credit quality, the greater the risk of default and therefore investment loss.
