Fund objective

Abax SA Absolute Prescient Fund is a domestic fund with a mandate to invest across a wide range of South African asset classes. The Fund has a mandated maximum net equity exposure of 40%. The Fund is suitable for retirement savings and complies with Regulation 28.

The Fund's primary objective is to outperform Inflation + 3% p.a., over rolling 3 year periods (net of fees), without any negative 12-month periods.

The Fund has a low to moderate risk profile, and is suitable for investors seeking some capital growth and income without having to assume high levels of capital volatility.

About the Fund

The Fund is actively managed and draws upon Abax's full skillset: asset allocation, valuation-based equity and fixed income security selection.

The Fund is managed by Philip Liebenberg, Matthew de Wet and Wallie van der Walt.






