

# PRESCIENT INCOME PLUS FUND (A2)

## MINIMUM DISCLOSURE DOCUMENT

### INVESTMENT AND RETURN OBJECTIVE

The Fund aims to return STeFi Call + 3% per annum through a full interest rate cycle by offering investors an enhanced income yield without undue risk on capital by maintaining constrained credit risk exposure.

### INVESTMENT PROCESS

The Fund invests in a diversified portfolio consisting primarily of South African vanilla debt, mezzanine and structured instruments across the term structure and credit rating bands. Portfolio risk is managed at both single issuer and portfolio level. The former is done through an inhouse dynamic probability of default (PD) based rating model and the latter is through measuring the Expected Loss (EL), Loss Given Default (LGD) and credit VaR (Value at Risk). The Fund's modified duration will typically be below two years. Credit asset selection is underpinned by minimising default risk and credit spread duration.

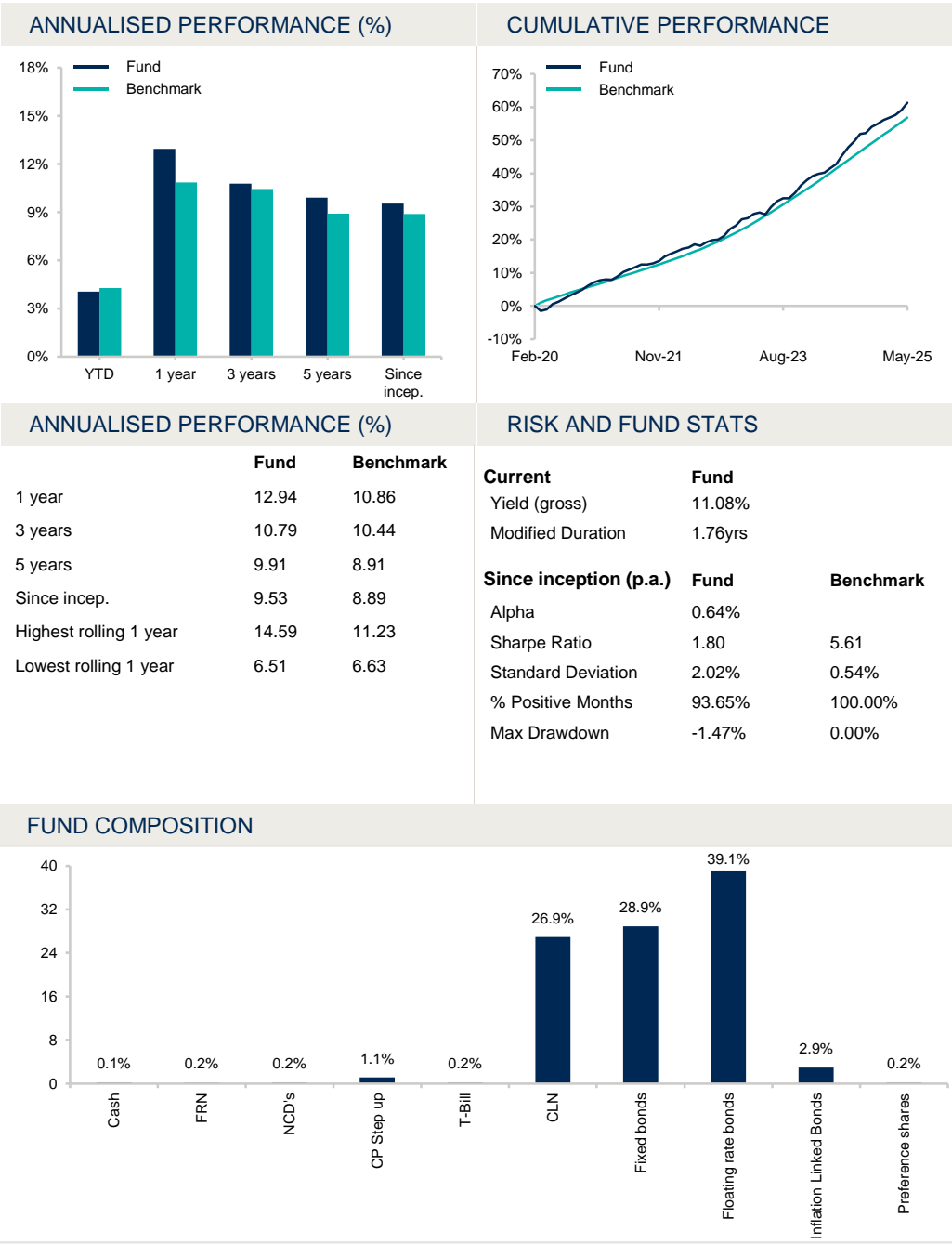
### WHO SHOULD INVEST

Investors seeking performance in excess of what is available in the money market or a typical income fund. The Fund is Regulation 28 compliant.

### RISK INDICATOR DEFINITION

This portfolio typically has longer dated and complex credit exposures, resulting in some capital volatility and liquidity constraints to investors over the shorter term. It is managed in such a manner that the probability of capital losses over one-year periods is unlikely, and in a manner that would cater for client redemptions appropriately.

## FUND COMMENTARY

On the global front, tensions eased between the US and China, with both countries agreeing to a 90-day pause on the proposed tariffs. Markets rallied in response with the Rand gaining nearly 3% against the dollar, and SA Bonds posting a return of 2.7% for the month.

In local news, National Treasury tabled Budget 3.0, which was met with a significantly warmer reception than its earlier iteration. The proposed VAT hike was withdrawn, and fuel levies were increased to offset the anticipated revenue shortfall. Meanwhile, the SARB Monetary Policy Committee (MPC) met on 29 May and cut the repo rate by 25 basis points to 7.25%. For the first time this year, the decision was unanimous, with five members supporting a 25bp cut and one member favouring a 50bp reduction. Following the April CPI print of 2.8%, Governor Kganyago used the opportunity to propose a shift toward a 3% inflation target, replacing the current 3%–6% range. While this adjustment could result in interest rates remaining elevated for longer, the governor indicated it would ultimately support a future of both lower inflation and lower interest rates.

Debt Capital Market (DCM) activity declined for a second consecutive month, with term issuance totalling R6.5bn in May, down from R7.3bn in April and significantly lower than R16.9bn in May 2024. Nedbank Group raised R2.5bn in Tier 2 paper via private placement, while KAP Limited and Fortress Real Estate Investments Limited issued R1.6bn and R820m in senior paper, respectively. Notably, Standard Bank of South Africa Limited issued the first ZARONIA-linked bond in a 3-year senior format, priced at a margin of 102bps. Year-to-date term issuance now stands at R39.3bn, compared to R59.2bn over the same period last year.

Regarding our view on credit markets, our theme is determined by a combination of the output of our Credit Cycle Indicator (CCI), consideration of individual counterparty default probabilities, and the yields offered on these opportunities. Our CCI suggests continued heightened risk levels inherent in the South African Credit market, and the Fund's positioning emphasizes holding assets with defensive characteristics, while opportunistically taking on additional risk as deemed appropriate.

The Fund reported a net return of 136bp for the month, while the benchmark performance was measured at 86bp. The Fund's gross yield is at 11.08%, modified duration is at 1.76, and its weighted term to maturity is 4.64 years.

## GLOSSARY

**Annualised performance:** Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

**Highest & Lowest performance:** The highest and lowest performance for any 1 year over the period since inception have been shown.

**NAV:** The net asset value represents the assets of a Fund less its liabilities.

**Current Yield:** Annual income (interest or dividends) divided by the current price of the security.

**CPU:** Cents Per Unit to the Glossary

**Alpha:** Denotes the outperformance of the fund over the benchmark.

**Sharpe Ratio:** The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

**Standard Deviation:** The deviation of the return stream relative to its own average.

**Max Drawdown:** The maximum peak to trough loss suffered by the Fund since inception.

**% Positive Month:** The percentage of months since inception where the Fund has delivered positive return.

**Average Duration:** The weighted average duration of all the underlying interest bearing instruments in the Fund.

**Forward Yield:** The Forward Yield is the expected combined income of the instruments in the portfolio over the next year expressed as a percentage of the current value of those instruments.

## Fund Specific Risks

**Default Risk:** The risk that the issuers of fixed income instruments may not be able to meet interest payments nor repay the money they have borrowed. The issuers credit quality is vital. The worse the credit quality, the greater the risk of default and therefore investment loss.

**Derivatives risk:** The use of derivatives could increase overall risk by magnifying the effect of both gains and losses in a Fund. As such, large changes in value and potentially large financial losses could result.
