
Risk Indicator Definition

ANNUALISED PERFORMANCE (%)







MARKET COMMENTARY

Market Dynamics:

European credit markets stalled during October as the benchmark iTraxx XOver 5-year Spread index did very little over the month. The iTraxx XOver spread index started October at 262 basis points (bps), and briefly visited levels in the 280's, but the market promptly rallied back to an intra-month low of 257 bps. It did weaken a tad during the final few trading sessions, ending the month at 265 bps.

The iTraxx XOver Total Return Index produced an uninspiring 0.33% during the month, but it did manage to beat the Barclays 3-month Euribor Index (which delivered 0.18%) and also outperformed the iTraxx Main Total Return Index (125 equally weighted investment grade names), which eked out 0.29%. This pedestrian performance does obscure the year-to-date numbers, which look a bit more exciting. The index has delivered 6.74% so far this calendar year, which is 4.88% in front of the Barclays 3-month Euribor index. Looking forward, it might be quite difficult to extend this performance trace, but when one considers the extent of the current global equity bull run, there could be further gains available to investors over the short run.

On the default side of things, Markit reported no sizable credit events in the Credit Default Swap (CDS) markets across the globe, although I certainly can point to a couple of names that are teetering on the edge.

As expected, and highlighted in last month's piece, the Federal Reserve cut rates by 25 bps, but the Federal Reserve Governor had a message of caution to those expecting further aggressive rate cuts going forward.

During the month, the fund (A-class) gained 0.15% on an after-all-fees basis, underperforming the benchmark by 18 bps. The main detractor of performance was the small exposure to Kleopatra, which has defaulted on its obligations. The instrument lost some 29% of its value during the month, subtracting around 0.10% of fund performance over the month.

Annualised Performance: Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest Performance: The highest and lowest performance for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Current Yield: Annual income (interest or dividends) divided by the current price of the security.

Alpha: Denotes the outperformance of the fund over the benchmark.

Sharpe Ratio: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

Sortino Ratio: A measure of the risk-adjusted return of a portfolio. It is a modification of the Sharpe ratio but only penalises the returns falling below a user specified target, or required rate of return, while the Sharpe ratio penalises both upside and downside volatility equally.

Standard Deviation: The deviation of the return stream relative to its own average

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

Max Gain: Largest increase in any single month.

% Positive Month: The percentage of months since inception where the Fund has delivered positive return.

Glossary

Default Risk: The risk that the issuers of fixed income instruments may not be able to meet interest payments nor repay the money they have borrowed. The issuers credit quality is vital. The worse the credit quality, the greater the risk of default and therefore investment loss.
