FUND PROFILE

The Mentenova Local Equity Prescient Fund of Funds is an actively managed local equity fund of funds. The fund will be actively managed with exposure to local equities to maximize returns for investors. Given the risk profile, an investment horizon of more than 5 years is required.

INVESTMENT OBJECTIVE

The objective of the Fund is to outperform its benchmark on a total return basis in a cost-effective manner. The above fund adhered to the investment policy objectives as stated in the Supplemental Deeds.

INVESTMENT UNIVERSE

The Fund will invest in an optimally diversified number of funds blended using Mentenova's proprietary portfolio construction process to achieve its objective. The portfolio construction will involve a focus on only local equity opportunities subject to the investment conditions determined by legislation from time to time.

RISKS ASSOCIATED WITH THIS FUND

Risks include general market conditions and market volatility, company specific risk, interest rate risk, inflation risk, default risk, economic and political risk.






PORTFOLIO EQUITY HOLDINGS

Portfolio Date: 2025/04/30




TOP EQUITY HOLDINGS (LOOK THROUGH) (%)


EQUITY SECTOR ALLOCATION (LOOK THROUGH)

DISCLAIMER

A higher TER does not necessarily imply a poor return, nor does a low TER imply a good return. The current TER cannot be regarded as an indication of future TER's. During the phase in period TER's do not include information gathered over a full year. Transaction Costs (TC) is the percentage of the value of the Fund incurred as costs relating to the buying and selling of the Fund's underlying assets. Transaction costs are a necessary cost in administering the Fund and impacts Fund returns. It should not be considered in isolation as returns may be impacted by many other factors over time including market returns, the type of Fund, investment decisions of the investment manager and the TER

GLOSSARY

Annualised performance: Annualised performance show longer term performance rescaled to a 1-year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest return: The highest and lowest returns for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Positive Months: The number of individual 1 month periods during the specified time period where the return was not negative

Maximum Drawdown: Maximum loss in a peak-to-trough decline before a new peak is obtained, quoted as the percentage between the peak and the trough.

Fund of Funds: A Fund of Funds is a portfolio that invests in portfolios of collective investment schemes, which levy their own charges, which could result in a higher fee structure for these portfolios.
