The investment objective of the Fund is to achieve long-term capital appreciation. The Fund will seek to achieve its objective by investing primarily in a portfolio of equity securities and equity-related securities issued by companies that are domiciled, listed, or that derive over half their revenues or profits from countries classified as emerging market countries by MSCI and from frontier market countries. The fund adheres to its policy objective.

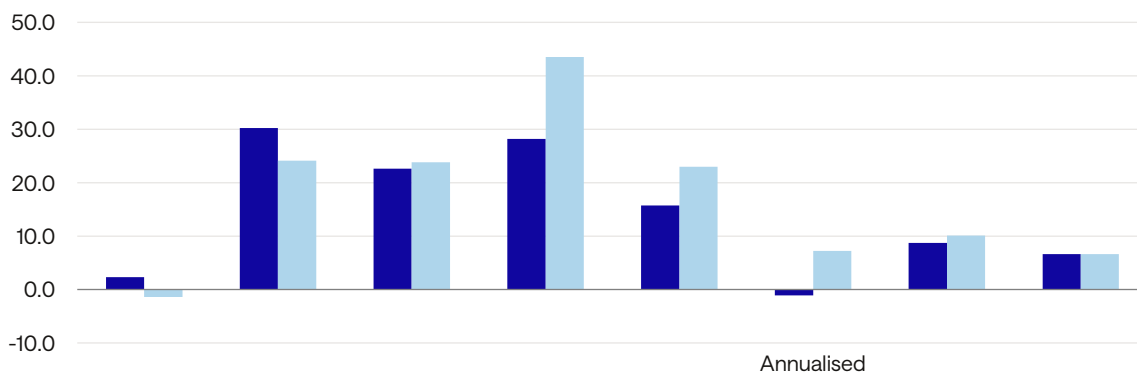

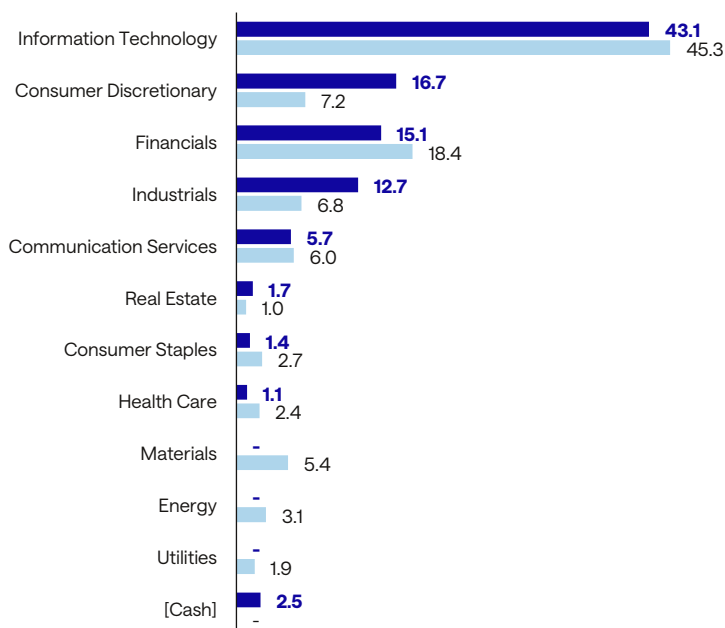

Key Risks

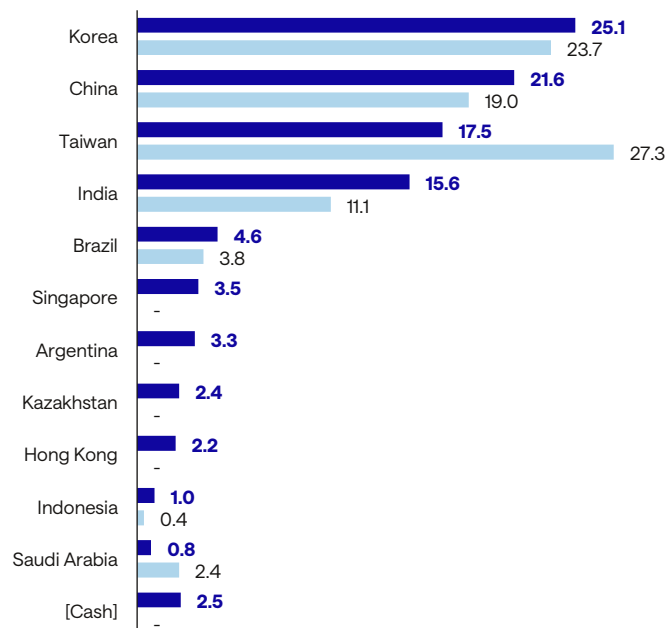
Market Liquidity: The value of the Fund may be affected by market liquidity risk, which may negatively affect how the fund executes transactions.

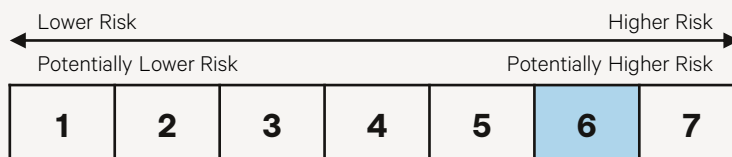
