- % POSITIVE MONTH: The percentage of months since inception where the Fund has delivered positive return.
- ALPHA: Denoted the outperformance of the fund over the benchmark.
- ANNUALISED PERFORMANCE: Annualised performance show longer term performance
  rescaled to a 1 year period. Annualised performance is the average return per year over
  the period. Actual annual figures are available to the investor on request.
- AVERAGE CREDIT QUALITY: The weighted average credit quality of all the underlying interest bearing instruments in the Fund (internally calculated).
- AVERAGE DURATION: The weighted average duration of all the underlying interest bearing instruments in the Fund.

 DIVIDEND YIELD: The weighted average dividend yield of all the underlying equity in the Fund. The dividend yield of each company is the dividends per share divided by the price.

- HIGH WATER MARK: The highest level of performance achieved over a specific period.
- HIGHEST & LOWEST RETURN: The highest and lowest returns for any 1 year over the period since inception have been shown.
- MAX DRAWDOWN: The maximum peak to trough loss suffered by the Fund since inception.
- MAX GAIN: Largest increase in any single month.
- NAV: The net asset value represents the assets of a Fund less its liabilities.
