#### INVESTMENT AND RETURN OBJECTIVE

The Fund aims to return STeFi Call + 3% per annum through a full interest rate cycle by offering investors an enhanced income yield without undue risk on capital by maintaining constrained credit risk exposure.

#### INVESTMENT PROCESS

The Fund invests in a diversified portfolio consisting primarily of South African vanilla debt, mezzanine and structured instruments across the term structure and credit rating bands. Portfolio risk is managed at both single issuer and portfolio level. The former is done through an inhouse dynamic probability of default (PD) based rating model and the latter is through measuring the Expected Loss (EL), Loss Given Default (LGD) and credit VaR (Value at Risk). The Fund's modified duration will typically be below two years. Credit asset selection is underpinned by minimising default risk and credit spread duration.


#### WHO SHOULD INVEST

**RISK INDICATOR**

#### **RISK INDICATOR DEFINITION**

This portfolio typically has longer dated and complex credit exposures, resulting in some capital volatility and liquidity constraints to investors over the shorter term. It is managed in such a manner that the probability of capital losses over one-year periods is unlikely, and in a manner that would cater for client redemptions appropriately.





#### FUND COMMENTARY

Local bond yields resume their trend higher, ending the first quarter of 2024 on a softer note, with the ALBI down 1.93% for the month. The South African Reserve Bank held the repo rate at 8.25%, with a unanimous vote, at the March Monetary Policy Committee (MPC) meeting. The MPC maintained a hawkish stance, projecting that the Consumer Price Index (CPI) would only retrace to the 4.5% midpoint by the fourth quarter of 2025.

Debt Capital Market activity continues to grow, with R18.5bn of term issuance in March, relative to the R10.1bn seen in February. Transnet tapped into its government guarantee facility, raising R7 billion through a mix of fixed and floating-rate notes spanning five to ten years. In the banking sector, both FirstRand Bank Ltd and Standard Bank Group issued R1.5 billion in Tier 2 capital issuance via auction. Further noteworthy issuances included Pepkor Ltd securing R2.2 billion, Toyota Financial Services with R1.1 billion, and Vukile Property Fund with R1 billion in senior paper. Total term issuance for the year is thus reported at R30.6bn.

Regarding our view on credit markets, our theme is determined by a combination of the output of our Credit Cycle Indicator (CCI), our consideration of individual counterparty default probabilities and finally the yields offered on these opportunities. Our CCI suggests continued heightened risk levels inherent in the South African Credit market, and the Fund positioning talks to holding assets with what we believe to have defensive characteristics, while opportunistically taking on additional risk as and when this is deemed appropriate.

The Fund reported a net return of 23bp for the month, while the benchmark performance was measured at 84bp. The Fund's gross yield is at 12.22%, modified duration is at 1.55, and its weighted term to maturity at 4.5 years.

#### GLOSSARY

Annualised performance: Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest performance: The highest and lowest performance for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Current Yield: Annual income (interest or dividends) divided by the current price of the security.

CPU: Cents Per Unit to the Glossary

Alpha: Denotes the outperformance of the fund over the benchmark.

Sharpe Ratio: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

Standard Deviation: The deviation of the return stream relative to its own average.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

% Positive Month: The percentage of months since inception where the Fund has delivered positive return.

Average Duration: The weighted average duration of all the underlying interest bearing instruments in the Fund.

Forward Yield: The Forward Yield is the expected combined income of the instruments in the portfolio over the next year expressed as a percentage of the current value of those instruments.

#### **Fund Specific Risks**
