

INVESTMENT AND RETURN OBJECTIVE

The objective of the fund is to outperform the JSE all-share index by more than 5% p.a. after fees over any 5–10 year rolling period.

INVESTMENT PHILOSOPHY

We invest in outstanding companies when, *and only when*, we can buy at a discount to a conservatively derived fair value. Our portfolio is concentrated in our 8–15 highest conviction ideas.

INVESTMENT PROCESS

The fund manager follows a fundamental and fact-based process that systematically sieves out companies that do not meet our strict quality and valuation criteria. The end result is that we invest in outstanding companies, run by competent managers, trading at attractive valuations.

Investors who: (i) understand and share our investment philosophy, (ii) have a long-term investment horizon, (iii) enjoys owning part interests in outstanding businesses (not trading in and out of stocks).

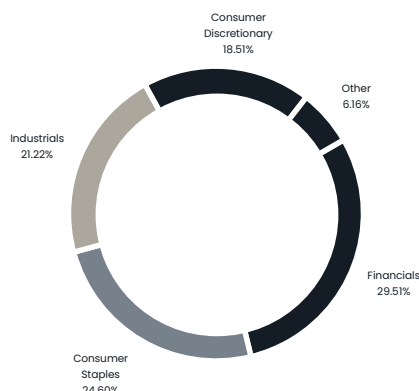

FUND COMMENTARY

The JSE all-share index (our benchmark) returned -2.5% over the five-month period since 2 August 2023, when the Steen Partners Fund (class A) was launched, and 31 December 2023. You would have seen from your account statements that our fund performed marginally better than this over this period. It is important to note the following:

1. Performance, absolute or relative, is meaningless over such a short period of time (we prefer the 3-year test).
2. The fund is materially different from its benchmark and investors should expect material differences in returns.
3. We expect, and so should you, that there will be periods of negative returns and underperformance.

The objective of the fund is long-term capital appreciation, above market averages. We would deem ourselves successful if we outperform the JSE all-share index by a sizeable margin after fees over any 5 year period.

GLOSSARY

Annualised Performance: Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest Performance: The highest and lowest performance for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Alpha: Denotes the outperformance of the fund over the benchmark.

Sharpe Ratio: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

Standard Deviation: The deviation of the return stream relative to its own average.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

Max Gain: Largest increase in any single month.

Transaction Costs (TC%): The Transaction Costs (TC) is the percentage of the net asset value of the Financial Product incurred as costs relating to the buying and selling of the assets underlying the Financial Product.

Qualified Hedge Funds only allow Qualified Investors to invest. A Qualified Investor, is a person who invests an initial minimum amount of R1 million and who has demonstrated knowledge and experience in financial and business matters which would enable the investor to assess the merits and risks of a hedge fund or has appointed a Financial Services Provider (FSP) who has demonstrable knowledge and experience to advise the investor regarding the merits and risks of a hedge fund investment.

FUND SPECIFIC RISK

Default Risk: The risk that the issuers of fixed income instruments may not be able to meet interest payments nor repay the money they have borrowed. The issuers credit quality is vital. The worse the credit quality, the greater the risk of default and therefore investment loss.

During the phase in period TER's do not include information gathered over a full year. Transaction Costs (TC) is the percentage of the value of the Fund incurred as costs relating to the buying and selling of the Fund's underlying assets. Transaction costs are a necessary cost in administering the Fund and impacts Fund returns. It should not be considered in isolation as returns may be impacted by many other factors over time including market returns, the type of Fund, investment decisions of the investment manager and the TER.
