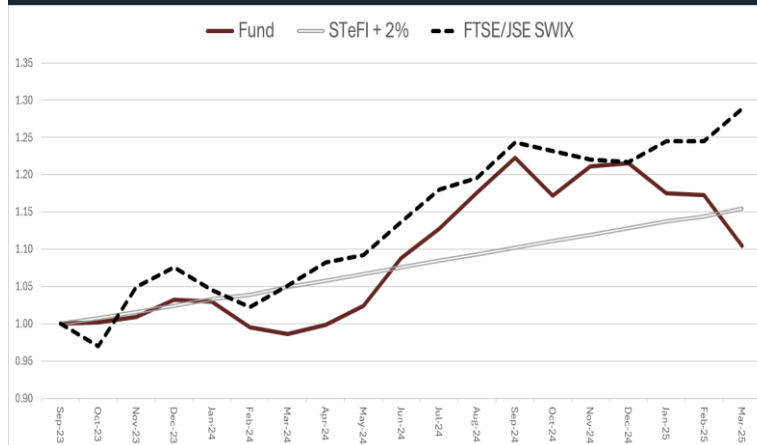

MANAGER COMMENTARY

The first quarter of 2025 presented exceptionally turbulent market conditions. The Global Policy Uncertainty Index, as measured by the Policy Uncertainty Project, continued its upward trend, reaching new record highs. This period was marked by a series of impactful exogenous events. Geopolitical tensions, significant shifts in global trade policies, unexpected announcements of economic stimulus packages, and, domestically, emerging complexities within the newly formed Government of National Unity (GNU) contributed to rapid and often unpredictable market swings, oscillating between periods of strong optimism and deep pessimism. These events triggered notable market movements, including substantial rallies in specific commodity prices, such as rhodium, driven by manufacturing pre-stocking amid supply chain disruption concerns. Simultaneously, demand for traditional haven assets like gold and platinum saw significant increases. Furthermore, a pronounced liquidity premium emerged, with large capitalisation companies significantly outperforming their smaller counterparts. Such swift and idiosyncratic shifts in market dynamics can pose considerable challenges for investment strategies designed to capitalize on more stable and predictable market patterns.

Amidst this global backdrop, the South African equity market demonstrated relative resilience, with both the ALSI and the SWIX delivering positive returns of 5.9% for the quarter. However, this overall index performance concealed significant divergences at a sector level. The Resources index (RESI10) posted an impressive return of 33.7% for the quarter, almost entirely attributable to the exceptional performance of the Precious Metals and Mining subsector, which rallied by 58.5%. In contrast, all other subsectors within the broader Materials sector experienced negative returns. Notably, the Top40 Index, comprising the largest market capitalisation companies, returned a robust 8.5% for the quarter, while the JSE Small Cap Index experienced a significant decline of 7.1%.

Our investment process is built upon machine-learning driven algorithms designed to identify high-probability investment opportunities and execute these systematically and without emotional bias. As a result, the aforementioned volatile and idiosyncratic market conditions that characterised the first quarter were not conducive to our investment process.

The overall fund experienced underperformance relative to the broader market and our benchmark during this period, with the month of March particularly impacting returns. The Alpha strategy, which aims to generate uncorrelated returns through relative value positions, experienced a volatile quarter, with weaker performance in January and March offset by a strong rebound in February. While some level of volatility is anticipated within this strategy, the degree observed during the quarter has been noted and is currently under review. The Vega strategy, designed to preserve capital during periods of heightened volatility, faced headwinds throughout the quarter. The rapid shifts between market exuberance and pessimism led to more frequent directional changes than is typically anticipated. As we enter April, the strategy remains positioned defensively, and we anticipate it will provide support should markets experience a significant downturn. The Beta strategy, which seeks to capture market rallies, also underperformed the overall market. The substantial outperformance of large-cap stocks and the Precious Metals and Mining sector, coupled with the corresponding underperformance of smaller capitalisation companies, created headwinds for the strategy's positioning.

The fund's performance during the first quarter of 2025 was disappointing. However, we believe the unusual market dynamics experienced during the quarter provide clear context for this underperformance.

Despite these challenges, our fundamental conviction in our data-driven, systematic investment approach remains strong. We are continuously evaluating opportunities to refine our current investment strategies and portfolio construction methodologies, and we are currently exploring techniques to potentially adjust our machine learning models to prioritize the identification of high return opportunities, with less emphasis on risk-adjusted metrics, which may have inadvertently reduced exposure to the strongly performing resource sector, when identifying high-probability investment opportunities. We believe that a measured and considered approach is crucial, and we will avoid any impulsive changes based on a single quarter's results.

We anticipate a gradual stabilization of market conditions as the impact and policy direction of the new US administration become clearer. This more predictable environment should create more favourable conditions for our machine learning algorithms to identify attractive investment opportunities. We remain confident in our data-driven, systematic approach and our ability to deliver superior risk-adjusted returns for our investors over the medium to long term.

GLOSSARY

Annualised performance	Annualised performance shows longer term performance rescaled to a 1-year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.
Highest and Lowest return	The highest and lowest returns for any 1 year over the period since inception have been shown.
Max Drawdown	The maximum loss from a peak to a trough before a new peak is attained. Maximum Drawdown (MDD) is an indicator of downside risk over a specified time period
Moderate-Aggressive/ Medium-High	Generally, these portfolios hold more equity exposure than lower risk profiled portfolios. These portfolios therefore tend to carry more volatility. Expected potential long-term returns could be higher than other risk profiles, in turn potential losses of capital could be higher.
NAV	The net asset value represents the assets of a Fund less its liabilities.
Performance fee	The fund charges a performance fee of 20% of the amount by which it outperforms the hurdle rate, STeFI. The performance fee is payable quarterly in arrears. A high-water mark principle is applied in the performance fee calculation.
Sharpe Ratio	A measure of risk-adjusted performance. Calculated by dividing the annualized excess returns over the risk-free rate by Std Dev.
Standard Deviation (Std Dev)	A measurement of dispersion of a dataset relative to its average. When a fund has a high standard deviation, the predicted range of performance is wide, implying greater volatility.
Total expense ratio (TER)	TER reflects the percentage of the average Net Asset Value (NAV) of the portfolio that was incurred as charges, levies and fees related to the management of the portfolio. A higher TER does not necessarily imply a poor return, nor does a low TER imply a good return. The current TER cannot be regarded as an indication of future TER's.
Total investment charge (TIC)	The sum of the TER and transaction costs is shown as the Total Investment Charge. Since Fund returns are quoted after the deduction of these expenses, the TER and Transaction costs should not be deducted again from published returns.
Transaction costs (TC)	TC is the percentage of the value of the portfolio that was incurred as costs relating to the buying and selling of the assets underlying the portfolio. Transaction costs are a necessary cost in administering the Fund and impacts returns. It should not be considered in isolation as returns may be impacted by many other factors over time, including market returns, the type of financial product, the investment decisions of the investment manager and the TER.

FUND SPECIFIC RISK

Derivatives risk	The use of derivatives could increase overall risk by magnifying the effect of both gains and losses in a Fund. As such, large changes in value and potentially large financial losses could result.
