INVESTMENT AND RETURN OBJECTIVE

The Fund aims to return CPI + 3% per annum through a full interest rate cycle while providing stability by aiming never to lose capital over any rolling 3 month period.

INVESTMENT PROCESS

This Fund invests in local money market, bonds, inflation-linked bonds, preference shares and derivatives to meet the investment objectives. Fund performance can be generated from taking interest rate views or duration, yield enhancement via credit instruments, asset allocation between income producing asset classes and also via the use of derivatives.

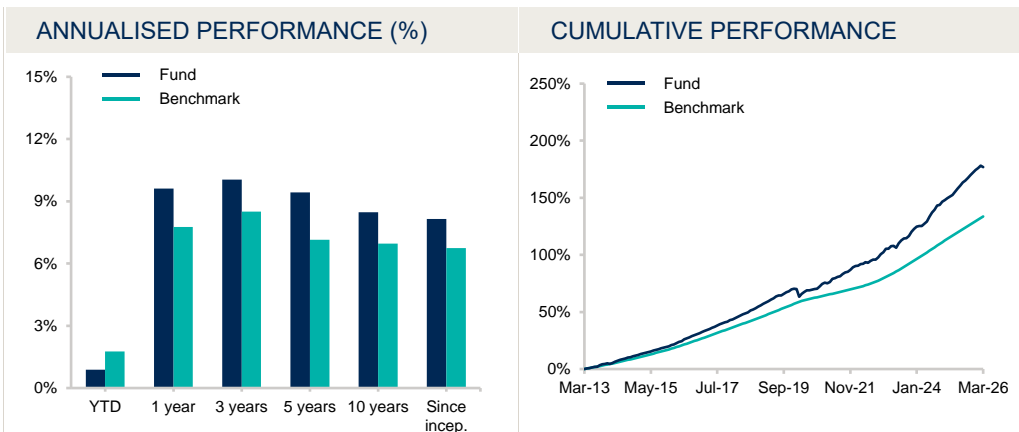
WHO SHOULD INVEST

Investors seeking stable real returns and aiming to maximise income via exposure to primarily the South African Money and Bond markets. This Fund is suitable to investors with a short- to medium-term investment horizon and is Regulation 28 compliant.

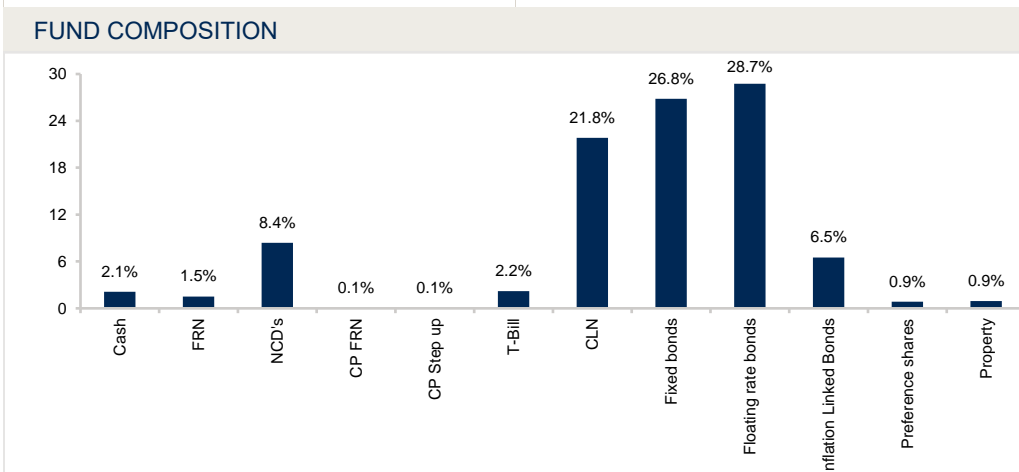
RISK INDICATOR DEFINITION

FUND COMMENTARY

South African fixed-income markets weakened in March, reflecting a broad-based global sell-off in bond markets. Rising oil prices and renewed geopolitical tensions drove a reassessment of inflation risks, prompting investors to push back expectations for monetary policy easing. As a result, bond yields moved higher both globally and locally, with South African government bonds coming under pressure amid foreign outflows and a softer rand. While shorter-dated yields moved higher, the longer end of the curve experienced more pronounced weakness as term premia adjusted higher.

The South African Reserve Bank kept the repo rate unchanged at 6.75% during the month, but struck a more cautious tone, highlighting upside risks to the inflation outlook stemming from higher fuel prices and currency weakness. Although inflation remains broadly contained, the shift in global dynamics has reduced the likelihood of near-term rate cuts, contributing to the repricing of duration assets.

Globally, March was defined by one of the sharpest fixed-income drawdowns in years. Government bond markets in the US, Europe and other major regions sold off as surging energy prices raised stagflation concerns and forced markets to scale back expectations for interest-rate cuts. With the US 10-year Treasury yield rising by nearly 40 basis points over the month. Against that backdrop, South African bonds were not immune: despite still offering attractive real yields, they traded weaker as higher global term premia, inflation uncertainty and capital outflows outweighed the local carry appeal.

Within this environment, the Fund maintained its conservative positioning, with a continued emphasis on capital preservation, liquidity and high-quality income generation. Limited duration exposure and a bias toward shorter-dated and floating-rate instruments helped to mitigate the impact of the sell-off. Importantly, the repricing in fixed-income markets has improved prospective yields, enhancing the opportunity set for reinvestment at more attractive levels while remaining aligned with the Fund's objective of delivering stable returns without compromising its risk target. To this end we increased the Fund's duration by adding Fixed Rate Bonds to the portfolio, taking advantage of the sell-off. This environment again highlighting the benefit of our keen risk focus.

The Fund's forward yield remains attractive at 9.06%. The Fund has an interest rate duration of 1.57 years and a total duration (including ILBs) of 1.66 years. The current risk profile aligns with the Fund's risk objective, and we believe the Fund is well positioned to achieve its return objectives.

The Fund delivered a negative performance in March but held up well relative to market movements. Key contributors were the higher yielding assets in the portfolio. Key detractor was the duration assets held and bought at the end of the Month.

GLOSSARY

Annualised performance: Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest performance: The highest and lowest performance for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Current Yield: Annual income (interest or dividends) divided by the current price of the security.

CPU: Cents Per Unit to the Glossary

Alpha: Denotes the outperformance of the fund over the benchmark.

Sharpe Ratio: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

Standard Deviation: The deviation of the return stream relative to its own average.

% Positive Month: The percentage of months since inception where the Fund has delivered positive return.

Average Duration: The weighted average duration of all the underlying interest bearing instruments in the Fund.

Forward Yield: The Forward Yield is the expected combined income of the instruments in the portfolio over the next year expressed as a percentage of the current value of those instruments.

Fund Specific Risks

Default Risk: The risk that the issuers of fixed income instruments may not be able to meet interest payments nor repay the money they have borrowed. The issuers credit quality is vital. The worse the credit quality, the greater the risk of default and therefore investment loss.

Derivatives risk: The use of derivatives could increase overall risk by magnifying the effect of both gains and losses in a Fund. As such, large changes in value and potentially large financial losses could result.
