INVESTMENT AND RETURN OBJECTIVE

The Fund aims to generate real returns in US Dollars and is benchmarked to the US inflation rate.

The investment universe includes fixed, floating, real and nominal money market and bond market investments, derivatives and global currencies. Fund performance can be generated from taking interest rate views or duration, yield enhancement via credit instruments, asset allocation between income producing asset classes, the use of derivatives and currency management.

WHO SHOULD INVEST

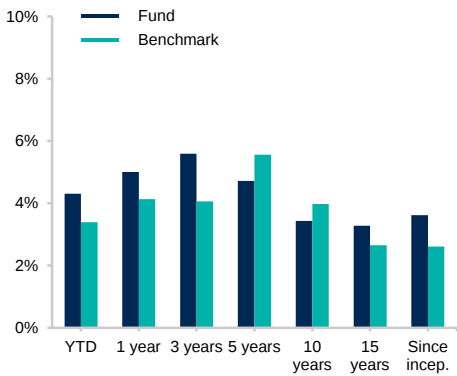
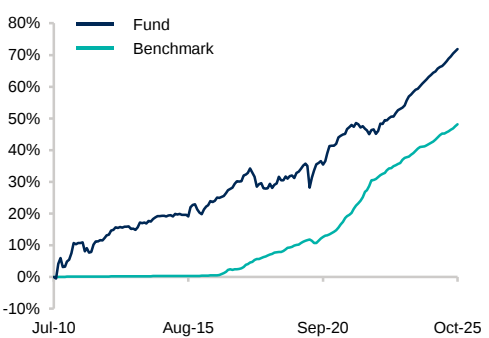
Investors seeking a hedge against any rand depreciation while gaining exposure to high yielding offshore assets that are not available locally in South Africa. Although this is a roll-up fund and does not distribute income, it is suitable to investors with a medium to long-term investment horizon who wishes to fund income withdrawals by redeeming units, due to the exposure to yield generating assets held in the Fund and therefore a lower probability of selling underlying units at inappropriate times such as in a market downturn.

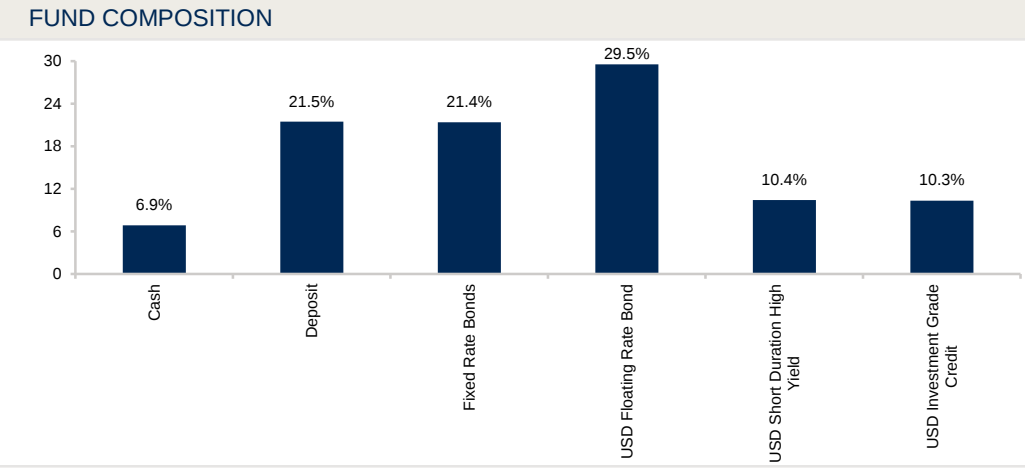
RISK INDICATOR DEFINITION

This portfolio typically has no equity exposure, resulting in higher interest yields and stable capital values with the probability of capital losses in USD terms over the shorter term unlikely. This portfolio typically targets a return in the region of 1% – 3% above US inflation over the long term.

FUND COMMENTARY

Global fixed-income markets extended their positive momentum into October, supported by easing inflation pressures and growing confidence that major central banks have entered a gradual cutting cycle. U.S. Treasuries posted another month of gains, with the 10-year yield declining a further 10 bps to settle near 4.25%, while front-end yields held broadly stable. Market pricing now implies an additional 50 bps of Fed cuts by mid-2026 as labour-market data continues to soften and inflation trends remain benign. Credit spreads were steady to marginally tighter across most segments, buoyed by healthy corporate balance sheets and renewed demand from global income-seeking investors.

In Europe, sovereign yields drifted lower alongside a weaker growth backdrop, though political uncertainty in parts of the region limited the extent of the rally. Japanese government bonds experienced a modest pullback as the Bank of Japan signalled continued caution on further tightening, even as domestic inflation indicators remained elevated. Emerging-market debt sustained its constructive tone, aided by U.S. dollar softness and improved risk sentiment, particularly across Latin America and select Asian markets where local central banks remain ahead in the easing cycle.

Against this backdrop, the Fund continued to prioritise high-quality, short-duration opportunities while tactically extending duration through selective sovereign holdings. The team trimmed some of its front-end USD exposure following strong gains in September and added moderately to intermediate-maturity Treasuries, specifically the 5y point, and investment-grade corporates, seeking to capture carry at attractive levels. Credit exposure remains concentrated in defensive sectors such as supranationals, high-grade financials, and short-dated corporate paper, maintaining liquidity and flexibility should volatility re-emerge. Overall duration remains modestly below benchmark, balancing carry generation with prudent interest-rate risk management.

The Fund's forward yield remains attractive at 5.00%, with an interest rate duration of 1.39 years. The portfolio's current risk portfolio aligns with the Fund's risk objective, and we believe the Fund is well positioned to achieve its return objectives.

The Fund had positive performance in October albeit behind its benchmark slightly. Key drivers of performance included the good yielding assets in the portfolio, and the front end focussed yields. The added duration also contributed as global yields continued their shift lower. The Fund remains well positioned to achieve its risk and return targets.

GLOSSARY

Annualised performance: Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest performance: The highest and lowest performance for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Current Yield: Annual income (interest or dividends) divided by the current price of the security.

CPU: Cents Per Unit to the Glossary

Alpha: Denotes the outperformance of the fund over the benchmark.

Sharpe Ratio: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

Standard Deviation: The deviation of the return stream relative to its own average.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

Average Duration: The weighted average duration of all the underlying interest bearing instruments in the Fund.

Forward Yield: The Forward Yield is the expected combined income of the instruments in the portfolio over the next year expressed as a percentage of the current value of those instruments.

Fund Specific Risks

Default Risk: The risk that the issuers of fixed income instruments may not be able to meet interest payments nor repay the money they have borrowed. The issuers credit quality is vital. The worse the credit quality, the greater the risk of default and therefore investment loss.
