/ Portfolio description

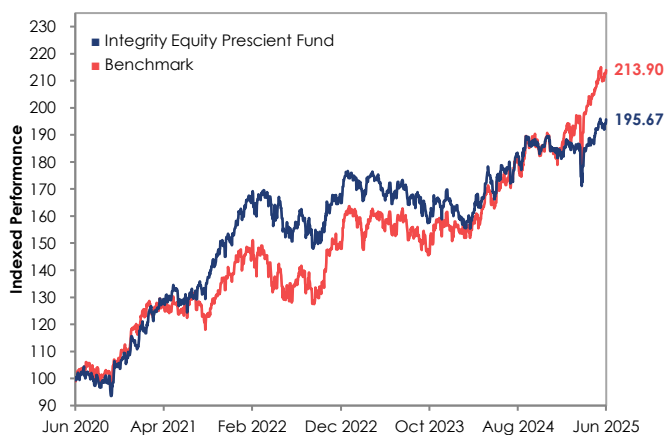
The primary objective of the portfolio is to achieve long term capital appreciation by investing in a diversified portfolio of **South African listed equities**. The portfolio manager acquires local equities at levels below the assessment of the companies' fair values. The portfolio manager also takes cognisance of worldwide economic, sector and investment trends to tilt the portfolio towards attractive sectors and companies.

The Integrity Equity Prescient Fund is required to invest a minimum of 80% of the portfolio in equities and is therefore suitable for investors with an investment horizon of five years or longer.

Integrity diligently follows a **value investment philosophy and process**. This is the same investment philosophy and process applied in managing the Integrity Local Equity Strategy, with track record since 5 August 2011.

The portfolio has adhered to its policy objective since its inception.

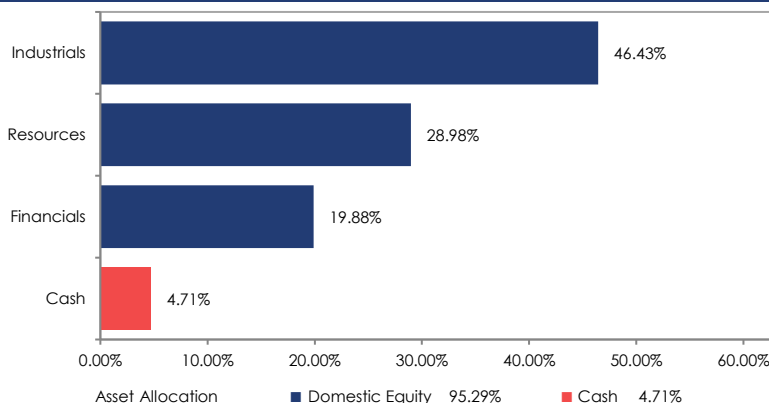

/ Sector allocation



/ Relative performance

Over the quarter, the Fund generated a return of 6.30% compared to the FTSE/JSE All Share Index's total return of 10.15%. The Fund benefitted from its top performing shares over the period, namely; Sibanye Stillwater, Telkom SA, Tharisa, Impala Platinum, AB InBev and the Satrux Fini ETF. However, due to the Fund's option overlays, the upside on Impala Platinum and Sibanye Stillwater was reduced. Conversely, the largest contributor to the negative return for the Fund was having no exposure to Naspers which detracted 2.46% of alpha over the period. Furthermore, the lack of exposure to Capitec, MTN Group and FirstRand added to the underperformance. Lastly, the Fund's exposure to KAP and The Spar Group detracted from the Fund's performance. Over the quarter, a continued tilt from value to growth was experienced, as the FTSE/JSE Growth Total Return Index increased by 10.82% compared to an increase of 9.41% in the FTSE/JSE Value Total Return Index. Considering the current macro backdrop, the Investment Manager expects value outperformance to reassert itself in the future once fundamentals regain focus.

/ Fund composition

Over the quarter, the Investment Manager decreased exposure to shares that performed well, namely; British American Tobacco, Remgro, Anglo American, AB InBev, Sibanye Stillwater, Telkom SA and Impala Platinum. Additionally, the Fund exited exposure to Ninety One since the share price increased above its estimated fair value. During the period, Valterra Platinum was unbundled from Anglo American and was subsequently sold when opportune. The Investment Manager increased exposure to certain counters in the materials, financials, healthcare, consumer staples and consumer discretionary sectors. Lastly, the Investment Manager initiated exposure to Aspen Pharmacare and Reunert over the quarter. The above portfolio changes resulted in a decrease in cash exposure from 7.31% to 4.71%. The Fund's Resources allocation marginally increased from 28.69% to 28.98%, Industrials allocation increased from 43.09% to 46.43%, and the Financials allocation decreased from 20.91% to 19.88%.

/ Glossary

Annualised performance: Annualised performance shows longer-term performance rescaled to a 1-year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest return: The highest and lowest returns for any 1 year over the period since inception have been shown.

NAV: The Net Asset Value represents the assets of a Fund less its liabilities.

Risk profile: A measure of the volatility of the fund and volatility is a statistical measure of the dispersion of returns for a given security. Low risk portfolios indicates less volatility with potentially lower returns and high risk portfolios indicates more volatility with potentially higher returns. High risk portfolios generally hold more equity exposure than any other risk portfolios and therefore tend to carry higher volatility.
