



**Investment Objective**

The Fairtree Global Emerging Markets Prescient Fund is an actively managed global equity fund. The objective of the fund is to offer long term capital growth by investing in emerging equity markets or in companies that derive a significant portion of their revenue in emerging economies. The portfolio is constructed in a diversified manner and aims to provide returns above the index.

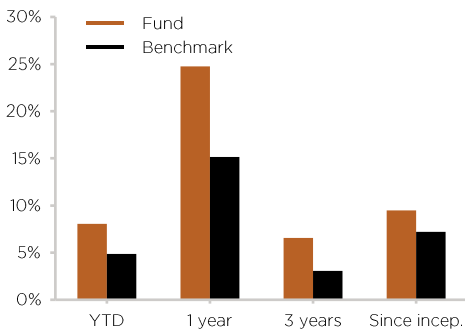
**Investment Policy**

The objective of the Fairtree Global Emerging Markets Prescient Fund is to provide investors with long term capital growth by investing primarily in large and mid-cap stocks within emerging equity markets, or in companies that derive a significant portion of their revenue, profits or asset base from emerging economies. Our investment philosophy is to buy quality companies, that are growing earnings, at attractive valuations below intrinsic value. In order to achieve this objective, the portfolio uses a quantitative screening process, based on various factors, to identify the most attractive opportunities. Fundamental research is then performed to determine the inclusion and sizing of positions.

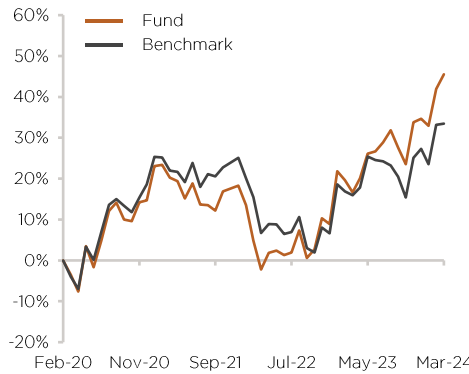
**RISK INDICATOR**

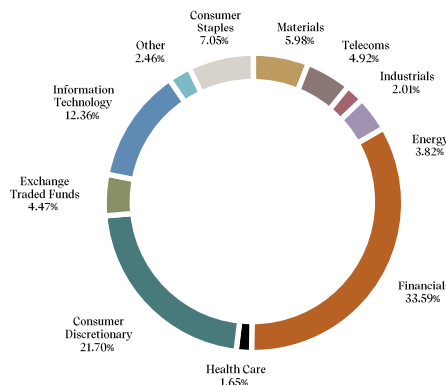

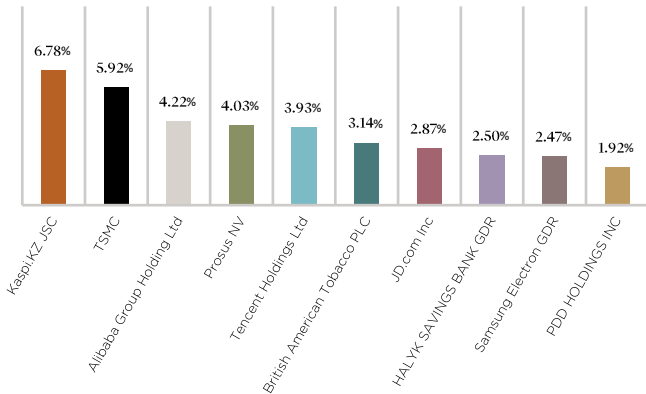

**Income Distribution:**

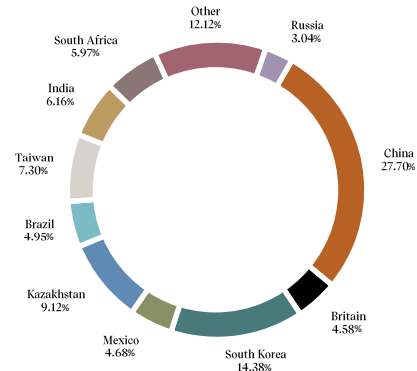

MARKET COMMENTARY

The Fund returned 2.55% for the month, outperforming the benchmark by 2.36%. Global markets enjoyed strong performances in March, with the S&P Global 1200 Index increasing 3.5%, the MSCI ACWI climbing 3.2%, and the MSCI Emerging Markets Index rising 2.2% (all in USD).

The US market continues to be supported by resilient economic data and strong corporate earnings. The S&P 500 Index rose 3.1% over the month, despite February inflation coming in higher than expected, which likely delays monetary easing further than the market originally expected at the start of the year. Within Emerging markets, Taiwan was the best-performing market over the month, rising 7.7%, where the Fund, unfortunately, has an underweight position as continued investor appetite for AI-related technology businesses drove the share price higher. Mexico was the second-best performing market, increasing 5.4% over the month, where the Fund has an overweight position. The Chinese market was marginally higher over the month as investors remained cautious about the economic outlook despite select stimulus by the government. On a sector level, returns were driven by Information Technology (+7.7%), where the Fund is underweight and Communication services (+4%), where the Fund is largely neutrally positioned. Real estate, Health care and Utilities were the three worst-performing sectors, and they added to our relative performance through underweight exposure.

Noteworthy portfolio actions include partially switching the position in Tencent into a larger position in Prosus while topping up the existing holdings in JD.com and Petrobras. JD.com released results that beat expectations across most metrics, as well as increasing the capital return to shareholders. Other noteworthy actions include partially switching the holding in Samsung Electronics preference shares into Samsung Electronics ordinary shares at attractive levels, while the holding in Coca-Cola Icecek was exited during the month. Coca-Cola Icecek has performed well, despite consistent downgrades in dollar earnings for the business. Notable contributors to Fund performance were holdings in Kaspi (+97 bps absolute and relative), Taiwan Semiconductor Manufacturing (+57 bps absolute, -22 bps relative), JD.com (+53 bps absolute, +46 bps relative) and Tencent (+53 bps absolute, +25 bps relative). Notable detractors from performance over the month came from China Medical Systems (-20 bps absolute, -19 bps relative), Alibaba (-17 bps absolute, -6 bps relative) and Pinduoduo (-16 bps absolute, -7 bps relative).

The Fund's style and country positioning remain largely unchanged, with Kazakhstan the largest overweight through positions in Kaspi and Halyk. The Fund remains underweight Taiwan and India, where both markets continue to trade on elevated valuations compared to their history and emerging market peers.



## Glossary

**Annualised Performance:** Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

**Highest & Lowest Performance:** The highest and lowest performance for any 1 year over the period since inception have been shown.

**NAV:** The net asset value represents the assets of a Fund less its liabilities.

**Current Yield:** Annual income (interest or dividends) divided by the current price of the security.

**Alpha:** Denotes the outperformance of the fund over the benchmark.

**Sharpe Ratio:** The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

**Sortino Ratio:** A measure of the risk-adjusted return of a portfolio. It is a modification of the Sharpe ratio but only penalises the returns falling below a user specified target, or required rate of return, while the Sharpe ratio penalises both upside and downside volatility equally.

**Max Drawdown:** The maximum peak to trough loss suffered by the Fund since inception.

**Max Gain:** Largest increase in any single month.

**% Positive Month:** The percentage of months since inception where the Fund has delivered positive return.

## Specific Risk

**Default Risk:** The risk that the issuers of fixed income instruments may not be able to meet interest payments nor repay the money they have borrowed. The issuers credit quality is vital. The worse the credit quality, the greater the risk of default and therefore investment loss.
