The Fund aims to produce returns in excess of inflation over the medium to longer-term, whilst placing a high premium on protecting capital. The manager in selecting securities for the fund will seek to follow an investment policy which will secure long-term capital growth in real terms. Subject to such restrictions as may apply under the Act, the Fund may invest in all financial instruments, including but not limited to equities, bonds, money market instruments, property shares, derivatives and debentures, whether listed or unlisted and in line with the conditions as determined by legislation from time to time. The manager shall use the commitment method to calculate the Fund's total exposure.. Hurdle rate: CPI inflation + 4%.

Risk Guidance:

Moderate:

These portfolios generally hold more equity exposure than low risk portfolios but less than high risk portfolios In turn, the expected volatility is higher than low risk portfolios but less than high risk portfolios.
