INVESTMENT AND RETURN OBJECTIVE

The Fund offers efficient and cost effective exposure to listed property as represented by the FTSE/JSE SA Listed Property Index. Tracking error to the index is minimised in the process.

INVESTMENT PROCESS

The Fund is a property index fund where returns are enhanced by taking advantage of low risk arbitrage opportunities in the market. Additional benefits are gained from efficient implementation of cash flows, dividend reinvestments, management of corporate actions and index rebalancing. The Fund aims to remain fully invested in property shares at all times.

WHO SHOULD INVEST

Investors who require exposure to SA listed property shares and who are comfortable with the volatility and potential short term capital losses that can result from exposure to property shares.

RISK INDICATOR DEFINITION

These portfolios typically hold meaningful equity and/or offshore exposure which may result in significant capital volatility over all periods. Due to their nature expected long term returns are higher than for the other risk categories.

FUND COMMENTARY

Global equity markets delivered strong gains in May, with robust corporate earnings offset ongoing concerns around elevated oil prices and sticky inflation. The MSCI World Index advanced 4.55% as risk appetite broadened and emerging markets led the way.

In the United States, equities posted a robust month, with the S&P 500 advancing 5.26%. The move reflected resilient corporate earnings and a constructive macro backdrop, with leadership broadening beyond the largest growth names. European equities also delivered solid returns, with the Euro Stoxx Index rising 3.42%. Performance was supported by improving sentiment and constructive economic data across the region. Japan was the standout developed market, with the Nikkei 225 surging 10.04% on the back of strong earnings momentum and continued investor interest in the Japanese deflation story.

Emerging markets were the strongest performing asset class in May, with the MSCI EM index returning 9.69%, driven by exceptional strength in North Asian technology names. Korea's KOSPI surged 28% and Taiwan's TAIEX approximately 14%. Both markets propelled by AI-driven semiconductor demand, as US hyperscalers (Microsoft, Alphabet, Amazon, Meta) committed to sizeable capital expenditure for the year, directly benefitting the region's dominant chip and technology supply chains. Chinese equities were more modest, with the CSI 300 adding 2.71%.

Locally, a challenging consumer and retail environment weighed on local stocks. South African equities were broadly flat, with the FTSE/JSE All Share Index easing 0.27%. Sector performance was uneven: Financials added 0.93%, Basic Materials gave back 1.05% and Technology was the principal drag, declining 5.02%. The sector weakness was concentrated in the index heavyweights, with Naspers and Prosus falling 5.08% and 8.25% respectively, more than offsetting double-digit gains from smaller counters such as Altron and Bytes Technology.

The rand strengthened 2.67% against the US dollar over the month, supported by improved global risk appetite and a softer US dollar, which weighed on offshore returns translated back to rand.

South African listed property delivered a modest positive return, with the FTSE/JSE SA Listed Property Index up 0.62%, supported by a constructive yield environment and resilient distribution growth.

Overall, May was characterised by strong, broad-based gains across global markets, with Japan and emerging markets leading the way and developed market leadership widening beyond US mega-caps. Locally, the picture was more nuanced - headline index returns were held back by weakness in the technology heavyweights. The month nonetheless extended the constructive tone seen through the second quarter, with risk assets continuing to find support from resilient earnings and a steadier macro backdrop.

The top contributors to the Fund's performance for the month were Growthpoint Prop Ltd (2.20%), Equites Property Fund (6.57%) and Fairvest Limited B (5.51%). Detractors included Redefine Properties (-5.21%), Vukile Property Fund (-2.43%) and Fortress Real Est (-1.65%).

GLOSSARY

Annualised performance: Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest performance: The highest and lowest performance for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Current Yield: Annual income (interest or dividends) divided by the current price of the security.

CPU: Cents Per Unit to the Glossary

Alpha: Denotes the outperformance of the fund over the benchmark.

Sharpe Ratio: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

Standard Deviation: The deviation of the return stream relative to its own average.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

Dividend Yield: The weighted average dividend yield of all the underlying equity in the Fund. The dividend yield of each company is the dividends per share divided by the price.

PE Ratio: The weighted average price earnings ratio of all the underlying equity in the Fund. The price earnings ratio of each company is the price divided by the earnings per share.

Fund Specific Risks

% Property risk: Investments in real estate securities can carry the same risks as investing directly in real estate itself. Real estate prices move in response to a variety of factors, including local, regional and national economic and political conditions, interest rates and tax considerations.

Transaction cost is a necessary cost in administering the Fund and impacts Fund returns. It should not be considered in isolation as returns may be impacted by many other factors over time including market returns, the type of Fund, investment decisions of the investment manager and the TER.
