INVESTMENT AND RETURN OBJECTIVE

The Fund aims to deliver long term capital growth over time by offering a well-diversified portfolio investing in a broad range of domestic only asset classes in a balanced manner. The Fund will typically have high exposure to equities although some tactical asset allocation will be performed.

INVESTMENT PROCESS

The Fund invests in South African markets only across a diverse range of domestic only equities, property and interest-bearing instruments. Asset allocation is managed actively, anchored at the long-term strategic asset allocation but can be varied tactically to target outperformance of the benchmark by capitalising on signals of significant market mispricing. Where possible, a process of enhanced indexation is utilised within asset classes to deliver stable incremental alpha.

WHO SHOULD INVEST

South African investors seeking long term capital growth by investing in a typical, market related domestic balanced portfolio. The Fund is suitable for investors with a medium to long-term investment horizon and is Regulation 28 compliant.

RISK INDICATOR DEFINITION

These portfolios typically exhibit more volatility and potential for capital losses due to higher exposure to equities and exposure to offshore markets where currency fluctuations may result in capital losses. These portfolios typically target returns in the region of 5% - 6% above inflation over the long term.

FUND COMMENTARY

The big global news came right at the start of the month, when the Federal Reserve Bank of New York sold euros to buy yen on behalf of the US Treasury - the first joint US-Japan intervention in the currency market in nearly three decades. The yen had drifted to a 40-year low near ¥164 in late July, and the coordinated action pulled USD/JPY back below ¥158 by the end of the trading day. Alongside this, the BoJ held its policy rate at 1%, but Governor Kazuo Ueda flagged upside risks to inflation and said the bank would not fall behind on raising rates.

The dollar continued to weaken three weeks later. On 19 August the US Treasury unexpectedly announced increased buybacks of long-dated bonds, signalling concern about a selloff that had pushed the US 30-year yield to its highest level since 2007. The move pulled 30-year yields down about 8bp on the day, while the dollar index fell 0.7% to its weakest level since mid-May - its largest single-day drop in three weeks. Markets are now pricing a Fed hike as unlikely before December, adding to the pressure on the dollar. The yen also gained on the announcement, up 0.9% to ¥158.17, but was still down 0.7% for the month - a sign that the earlier joint-intervention gains were being tested rather than locked in. The Swiss franc and Swedish krona were among the biggest gainers against the dollar on the day, and emerging-market currencies broadly strengthened.

For South Africa the month of August opened with a tough data print. Q2 unemployment rose to 33.6% from 32.7% in Q1 - a further 345,000 people out of work, taking the total to 8.5 million. The broader measure, which counts discouraged jobseekers, edged up to 43.8% from 43.7%. The most striking feature of the print was the widening gap between provinces. Western Cape unemployment ticked down to 19.5% - the only province below 20% - while Eastern Cape climbed to 47.5%, up 8.0 percentage points year-on-year. That gap sets the political backdrop for the November 2026 local government elections, where the Eastern Cape figure will be a specific flashpoint. The month therefor left a mixed picture: a weaker SA labour market alongside a clear coordinated push to weaken the dollar.

The offshore US Treasury buyback announcement flowed straight through to South Africa. The rand moved to R16.10 against the dollar - its strongest level this year since early March - and the JSE ALSI rallied 4.65% to close above 116,000, a three-month high that took the index back to where it started the year.

Over the course August, Developed Market equity gained 2.58%, while emerging market equity gained 3.37% and Developed Market bonds gained 0.31%. Locally the ALBI gained 0.69%, the Cili was up +0.99%, while the JSE Top40 Index gained +5.73%.

The fund was strongly positive for the month as local equity and bonds contributed positively.

The Fund currently holds a neutral view on both South African equities and South African bonds.

GLOSSARY

Annualised performance: Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest performance: The highest and lowest performance for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Current Yield: Annual income (interest or dividends) divided by the current price of the security.

CPU: Cents Per Unit to the Glossary

Sharpe Ratio: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

% Positive Month: The percentage of months since inception where the Fund has delivered positive return.

Fund Specific Risks

Default Risk: The risk that the issuers of fixed income instruments may not be able to meet interest payments nor repay the money they have borrowed. The issuers credit quality is vital. The worse the credit quality, the greater the risk of default and therefore investment loss.
