

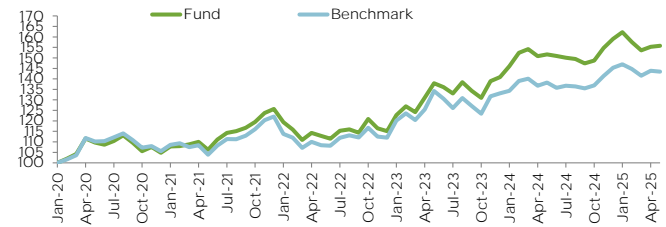
FUND OBJECTIVE & STRATEGY

The Fund will employ asset and geographical allocations to reflect changing economic and market conditions to maximise returns over the long term.

MONTHLY COMMENTARY

Global markets performed well during May with the MSCI All Country World Index adding +5.8%, following signs of progress in trade negotiations between the US and Europe and a 90-day pause in reciprocal tariffs between the US and China was announced. Reduced fears of a global recession, combined with strong corporate earnings out of big US tech resulted in growth (+8.7%) outperforming value (+3.2%). Concerns around the US fiscal sustainability, especially after the approval of the Reconciliation Bill by the House of Representatives which is expected to worsen the US debt position and the downgrade of the US sovereign credit rating by ratings agency Moody's pushed yields higher and weighed on bond markets. The FTSE World Government Bond Index lost -0.7% during May. Gold declined -0.8% during May as a more risk-on environment reduced the demand for defensive assets.

US markets were strong during May as the S&P 500 (+6.3%), Nasdaq (+9.6%) and the Dow Jones Industrial Average (+3.9%) all moved higher on the back of positive news flow which included strong corporate earnings, approval of the Reconciliation Bill by the House of Representatives, which is set to extend tax cuts passed in 2017, and optimism around possible trade negotiations between the US and China. Labour market data also remained resilient, as the US added another 177 000 during April. Markets across Europe also advanced amid the general optimism around risk assets. Eurozone consumer price inflation eased to 1.9% year-on-year in May, down from 2.2% in April and below market expectations of 2.0%. This marks the first time inflation has fallen below the European Central Bank's (ECB) 2.0% target since September 2024 and adds to expectations that the ECB will continue its path of rate cuts. The Bank of England (BoE) cut interest rates by 25 basis points, making it the fourth cut since August 2024 and taking the rate to 4.25%. The BoE now expects inflation to peak at 3.5% this year and decline to its 2.0% target by early 2027. The Eurostoxx 50 (+5.1%), German DAX (+6.7%) and FTSE 100 (+3.8%) all moved higher during the month. The Japanese equity market rallied strongly, with the Nikkei 225 adding +5.3%, driven by strong performance from large caps amid ongoing corporate governance reforms resulting in increased shareholders returns. Despite the easing of tariff concerns between the US and China, the Shanghai Shenzhen (+2.1%) lagged on ongoing fears of weak macro data out of China.

Our top performing shares during the month were Nvidia, Meta Platforms and Intuit with the biggest detractors being UnitedHealth, Elevance and Berkshire Hathaway.

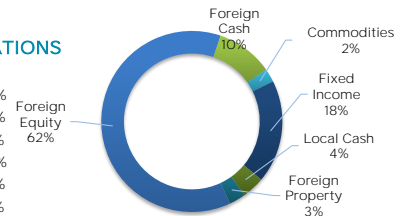

During the phase in period TER's do not include information gathered over a full year.

Transaction Costs(TC) is the percentage of the value of the Fund incurred as costs relating to the buying and selling of the Fund's underlying assets. Transaction costs are a necessary cost in administering the Fund and impacts Fund returns. It should not be considered in isolation as returns may be impacted by many other factors over time including market returns, the type of Fund, investment decisions of the investment manager and the TER.

Where a current yield has been included for Funds that derive its income primarily from interest bearing income, the yield is a weighted average yield of all underlying interest bearing instruments as at the last day of the month. This yield is subject to change as market rates and underlying investments change.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

% Positive Months: The percentage of months since inception where the Fund has delivered positive returns.
