INVESTMENT AND RETURN OBJECTIVE

The Fund aims to achieve healthy real returns over the long term and to outperform the ASISA category average of the South African - Multi-Asset - Low Equity funds over a full market cycle by maintaining moderate exposure to growth assets like equities.

INVESTMENT PROCESS

This Fund invests in local and offshore money market, bonds and inflation-linked bonds, property, preference and ordinary shares, derivatives and unlisted instruments to meet the investment objectives. Fund performance can be generated from taking interest rate views or duration, yield enhancement via credit instruments, asset allocation and exposure equities.

WHO SHOULD INVEST

Investors seeking real returns coupled with a stable and attractive income yield via significant exposure to the South African interest bearing markets. Although the Fund's mandate allows investment up to 40% in equities, it is expected to have lower actual exposure on average. This Fund is suitable to investors with a medium to long-term investment horizon and is Regulation 28 compliant.

RISK INDICATOR DEFINITION

These portfolios typically have moderate equity exposure or in the case of bond funds, longer duration bond exposure, resulting in some capital volatility over the shorter term. They are managed in such a manner that the probability of capital losses over one year periods is unlikely. These portfolios typically target returns in the region of 3% - 4% above inflation over the long term.

FUND COMMENTARY

In 2023, the global economy encountered unprecedented challenges, including soaring inflation, an exceptionally aggressive monetary tightening campaign, and geopolitical conflicts in Europe, the Middle East, as well as a lingering real estate crisis in China. Despite these formidable obstacles, the post-pandemic global recovery persevered.

In December, the Federal Reserve affirmed its commitment to maintaining a stringent monetary policy in the near term, recognising that interest rates were likely at their peak in the ongoing tightening cycle. The minutes from the Federal Open Market Committee meeting reflected officials' optimism about progress in managing inflation. Although there was discussion among participants about potential rate cuts in 2024 if the positive inflation trend continued, the minutes did not hint at an immediate easing in March, contrary to market expectations, while six cuts are expected over the course of the year.

However, the committee underscored a cautious approach, emphasising the necessity for a sustained reduction in inflation before considering a shift to a more accommodative stance. This cautious stance suggests that the Federal Reserve is prioritising a careful and measured response to economic conditions, aiming for stability in inflation rates before contemplating any significant policy adjustments.

Looking ahead, the International Monetary Fund predicts a global growth rate of 2.9% in 2024, slightly lower than the previous year. This year is expected to be significantly influenced by political events, including ongoing conflicts in two war zones and approximately 40 scheduled national elections. The political landscape is poised to play a pivotal role, particularly as Donald Trump embarks on an endeavour to reclaim the presidency, adding an additional layer of complexity to the global economic environment.

As 2023 came to a close on a positive note, global equities continued the momentum from November's robust rally with optimism that interest rates would decrease, signalling the conclusion of the tightening cycle. In December, both the MSCI World and Emerging Markets Total Return indices recorded gains of 4.9% (accumulating 23.8% for the year) and 3.9% (with a yearly increase of 9.8%) respectively. In the US, major indices such as the S&P500 and Dow Jones saw increases of 4.5% (26.3%) and 4.9% (16.2%), while the Nasdaq experienced a notable surge of 5.6% (culminating in a 44.6% yearly rise), indicating a strong performance for the year in the tech sector. On the local front, the JSE All Share Total Return Index slightly lagged its global counterparts but still managed a 2% gain (totalling 9.3% for the year). Global Bonds maintained their positive momentum, gaining 4.2% (5.7%). However, the US dollar depreciated by 2.1% against a basket of major currencies.

GLOSSARY

Annualised performance: Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest performance: The highest and lowest performance for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Current Yield: Annual income (interest or dividends) divided by the current price of the security.

CPU: Cents Per Unit to the Glossary

Alpha: Denotes the outperformance of the fund over the benchmark.

Sharpe Ratio: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

Standard Deviation: The deviation of the return stream relative to its own average.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

% Positive Month: The percentage of months since inception where the Fund has delivered positive return.

Fund Specific Risks

Default Risk: The risk that the issuers of fixed income instruments may not be able to meet interest payments nor repay the money they have borrowed. The issuers credit quality is vital. The worse the credit quality, the greater the risk of default and therefore investment loss.

Derivatives risk: The use of derivatives could increase overall risk by magnifying the effect of both gains and losses in a Fund. As such, large changes in value and potentially large financial losses could result.

Developing Market (excluding SA) risk: Some of the countries invested in may have less developed legal, political, economic and/or other systems. These markets carry a higher risk of financial loss than those in countries generally regarded as being more developed.

Foreign Investment risk: Foreign securities investments may be subject to risks pertaining to overseas jurisdictions and markets, including (but not limited to) local liquidity, macroeconomic, political, tax, settlement risks and currency fluctuations.

Transaction cost is a necessary cost in administering the Fund and impacts Fund returns. It should not be considered in isolation as returns may be impacted by many other factors over time including market returns, the type of Fund, investment decisions of the investment manager and the TER.

This yield is subject to change as market rates and underlying investments change.
