## **Investment Objective**

The Fairtree Global Real Estate Prescient Feeder Fund aims to provide access to high quality, international real estate assets that should benefit from capital appreciation while also delivering solid foreign dividends. The fund aims to outperform its benchmark by analyzing the central economic and political drivers in the various geographies, identifying global property sector trends and studying the specific physical property market and equity fundamentals.


#### **Investment Policy**

The portfolio has a long term focus, and is well diversified across geographic regions, currencies, real estate sectors and stocks. We will combine our top-down fundamental property market research with rigorous statistical valuation analysis using our proprietary models. We aim to lower portfolio volatility by adjusting the stocks and cash levels actively, while still outperforming our benchmark. We practice active risk management on a portfolio, sector and stock basis including the dynamic use of targets and stops. The fund will invest primarily in real estate equities in the United States, Japan, Hong Kong, Singapore, Australia, Europe and the UK.





## MARKET COMMENTARY

In March, the underlying fund underperformed the benchmark by 149 bps as it increased by 1.89%, while the benchmark increased by 3.38%. The underperformance was driven by the first and second bites of the apple (region and sector allocation), which contributed 167 bps, while the third bite of the apple (stock selection) had a marginal 6 bps effect. Currency had a positive effect on performance by 24 bps, and we maintained a stable cash position of 4% for the month. Our country calls went against us, with Japan, our biggest geographical underweight, recording the strongest performance, while Hong Kong (HK), our biggest geographical overweight, recording the weakest performance. Our US sector calls went better, although our overweight in data centres went against us as guestions were asked about Equinix's accounting practices.

Japan developers were up 21% for the month. The second-best performing region was Australia, up 11%, which we are neutral on, given strong demand in the industrial and residential sectors and a weaker outlook elsewhere. The third best region was Europe, up 8%, where we remain overweight after updating our views following the attendance of a UK/Europe conference in London. EU saw inflation decrease to 2.4% in March, signalling that the region Is likely to see interest rate cuts later this year. The weakest regional sectors were the HK REITs, down 13%, and the HK developers, down 5%. HK fundamentals remain challenging, given weak GDP growth thanks to China and high interest rates thanks to the US. However, valuations are at record lows, China's growth is likely to stabilise, and US/HK interest rates are likely to fall in the second half of 2024. The third weakest performer was neutral-weighted Singapore, down 2%. Singapore had been quite resilient YTD, but the developers weakened after sales slowed post increasing stamp duties. We are overweight the UK, which was up 7% as inflation fell and interest rate cuts looked increasingly likely going forward. US valuations are relatively less favourable, and the region underperformed. We remain underweight the US as we continue to monitor macro indicators, fundamentals and valuations.

The best-performing US sector was malls, up 5%, with restricted supply and earnings estimates being revised higher. We are neutral as the good fundamentals have led to good performance, which has led to stretched valuations. Our biggest overweight was net lease, which was the second-best performing sector, up 4%, with falling interest rates in the second half of 2024 hopefully unlocking attractive valuations. The third-best sector was office, where we remain underweight given weak fundamentals, but stocks remain volatile on the back of sentiment swings and deep value. The weakest performing sector was data centres, down 7%, linked to Equinix entering an accounting investigation after being accused of inflating figures. We remain overweight the sector on strong structural demand combined with capped supply on the back of infrastructure bottlenecks. The second worst performing sector was industrial, down 1%, where we are overweight as the fundamentals remain solid. We are also overweight healthcare, which performed positively in March, preferring senior housing, but also exposed to life science through high-quality assets. We were also underweight self-storage and residential due to demand and affordability challenges respectively, but both sectors were up 3%.

The best performers for the month were German residential stock, LEG Immobilien, up 17%, followed by British Land, the UK office stock, up 14%, which we acquired during the month after meeting with management in London and learned that prime London office demand and rentals were stronger than our previous expectation. The third-best performer was Healthpeak Properties, the US healthcare stock, up 12%. At the opposite end of the spectrum, the weakest-performing stock was HK retail stock Link REIT, down 14%, which weakened after HK retail sales came in weaker than expected. The second-weakest stock was Equinix, as mentioned above, and the third-worst performer was Sun Hung Kai Properties, the HK developer, which was down 4%.

We are currently reviewing the APAC and UK regions and assessing where further alpha can be generated, as we are most overweight in these regions. Global Real Estate is expected to perform well in 2024 as physical property prices start to move higher on the back of falling interest rates and decent rental growth.
