

## COMMENTARY

The CAEP Controlled Fund posted moderate gains this quarter, benefiting from a balanced exposure across growth and income assets. The fund remains on track with its long-term CPI +5% target, driven by positive contributions from domestic equity and inflation-linked bonds.

Equity volatility increased during the quarter, particularly in offshore markets, but our diversified allocation helped mitigate downside. Tactical positioning in floating-rate instruments and quality equities added resilience. We maintain a disciplined risk-budgeted approach to navigate ongoing macro uncertainty while targeting steady real returns.

## GLOSSARY

**Sharpe Ratio:** The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

Max Gain: Largest increase in any single month

% Positive Month: The percentage of months since inception where the Fund has delivered positive return.
