The portfolio is permitted to invest in listed and unlisted financial instruments in line with the conditions as determined by legislation from time to time.



COMMENTARY

The CAEP Controlled Fund posted moderate gains this quarter, benefiting from a balanced exposure across growth and income assets. The fund remains on track with its long-term CPI +5% target, driven by positive contributions from domestic equity and inflation-linked bonds.

Equity volatility increased during the quarter, particularly in offshore markets, but our diversified allocation helped mitigate downside. Tactical positioning in floating-rate instruments and quality equities added resilience. We maintain a disciplined risk-budgeted approach to navigate ongoing macro uncertainty while targeting steady real returns.
