The ClucasGrav Future Titans Prescient Fund has a flexible mandate to invest in a range of asset classes but will typically have high exposure to companies outside of the Top 40 Index. The fund is permitted to invest 2% offshore plus an additional 5% in Africa. The primary objective of the fund is to achieve real long-term capital growth ahead of CPI + 6%. The fund looks to acquire fast growing, mispriced, mid-and small-cap shares, "Future Titans", on the back of high conviction fundamental investment calls. The fund has a deep value / activist bias.

MONTHLY COMMENTARY

The Clucasgray Future Titans Prescient Fund had a better month as small- and mid-caps caught up with the global rally. The fund delivered +4.8% versus the peer group of 2.5%.

Nampak, the fund's second largest holding, delivered a very strong 31% increase in core earnings driven by the operational turnaround and lowering of debt. Demand for cans continues to grow at between 3% and 4% per annum in South Africa as consumer goods companies move away from glass and plastic, with energy drink demand growing in the mid-teens. Demand is so strong for 500ml beer and energy drink cans that Nampak has had customers on allocation limits. Nampak started the process of moving a spare can line from Angola back to South Africa. Although a complex move requiring 180 containers, the cost is less than a third of installing a new machine and will deliver growth capacity for the next 5 years. Despite the fantastic share price performance, the company remains very cheap and we will continue to hold our position.

Southern Sun also delivered a very strong 30% increase in earnings driven by increased occupancy and a higher room rate, with Cape Town hotels the star performers. We expect a better performance from the Gauteng hotels with the hosting of the G20 summit over 2025 and a better performance from Mozambique as stability returns and the huge Total Energies gas project kicks off. Southern Sun is the largest listed asset in HCI, which reported some interesting developments. Firstly, HCI increased their holding in Impact Oil & Gas, implying a value of R28bn against our valuation for the unlisted company of R14bn. Secondly, HCI (through their Canadian listed Africa Energy Corp) have taken control of the Mossel Bay gas deposits. The Mossel Bay gas deposit will require international partners to fund the capex but the full utilisation of the existing gas pipeline would imply R12bn in annual gas revenues supplying Mossgas and/or 1800mw of gas turbines.


