Investment Objective

To create long-term wealth for investors by taking long positions in South African stocks that appear relatively undervalued and short portions in South African stocks that look relatively overvalued.

Investment Policy

Positions are quantitatively managed to capture short-term price volatility while growing investors capital, in real terms, over the long-term. The portfolio manager makes use of technical analysis, fundamental valuations, and quantitative analysis when making investment decisions.

Overall portfolio exposure is managed within limits, and our view of Index valuations as a whole, through the use of Top40 futures.

Who Should Invest

Unum targets retail investors, typically affluent and HNW clients with an above average risk tolerance and reasonably high level of financial literacy.

FUND COMMENTARY

A great month for the fund up 11.9% before fees, significantly out performing the market. Positive contributions were broad based as the "buy everything" rally gained momentum in December. Stand outs were longs in ACL (1,28%), platinum shares (1,76%), MUR (3,7%), REN (0,91%) and property shares (0,87%) as well as short positions in AGL and the NPN/PRX stable. Following the strong 2 month rally in markets and the fund, we significantly reduce our market exposure and gearing into January as we take a wait and see approach into the new year, as we are concerned that the markets are now overestimating the speed and quantum of interest rate cuts, we believe the market view of cuts will only materialise in the event of a recession. In addition we want to see whether earnings in the US increase sufficiently to justify last years 25% rally or if earnings disappointments are now on the cards. Position wise we reduce our long platinum shares vs short gold shares on the back of market performance and the increasingly negative news (for Platinum stocks) on Electric Vehicles. We take this opportunity to reduce our short on AGL and close our short on NPN/PRX where we prefer PRX over NPN on the relative performance this year.

Glossary

Annualised Performance: Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest Performance: The highest and lowest performance for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Alpha: Denotes the outperformance of the fund over the benchmark.

Sharpe Ratio: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

Standard Deviation: The deviation of the return stream relative to its own average.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

Max Gain: Largest increase in any single month.

% Positive Month: The percentage of months since inception where the Fund has delivered positive return.

Total Expense Ratio (TER%): The Total Expense Ratio (TER) is the percentage of the net asset value of the class of the Financial Product incurred as expenses relating to the administration of the Financial Product.

Performance fee incl. in TER (%) PF (%): The Performance Fee is a payment made to the Fund Manager for generating positive returns and is generally calculated as percentage of investment profits, often both realized and unrealized.

Transaction Costs (TC%): The Transaction Costs (TC) is the percentage of the net asset value of the Financial Product incurred as costs relating to the buying and selling of the assets underlying the Financial Product.

Total Investment Charges TIC (%) = TER (%) + TC (%): The Total Investment Charges (TIC), the TER + the TC, is the percentage of the net asset value of the class of the Financial Product incurred as costs relating to the investment of the Financial Product. It should be noted that a TIC is the sum of two calculated ratios (TER+TC).

Fund Specific Risk

Default Risk: The risk that the issuers of fixed income instruments may not be able to meet interest payments nor repay the money they have borrowed. The issuers credit quality is vital. The worse the credit quality, the greater the risk of default and therefore investment loss.
